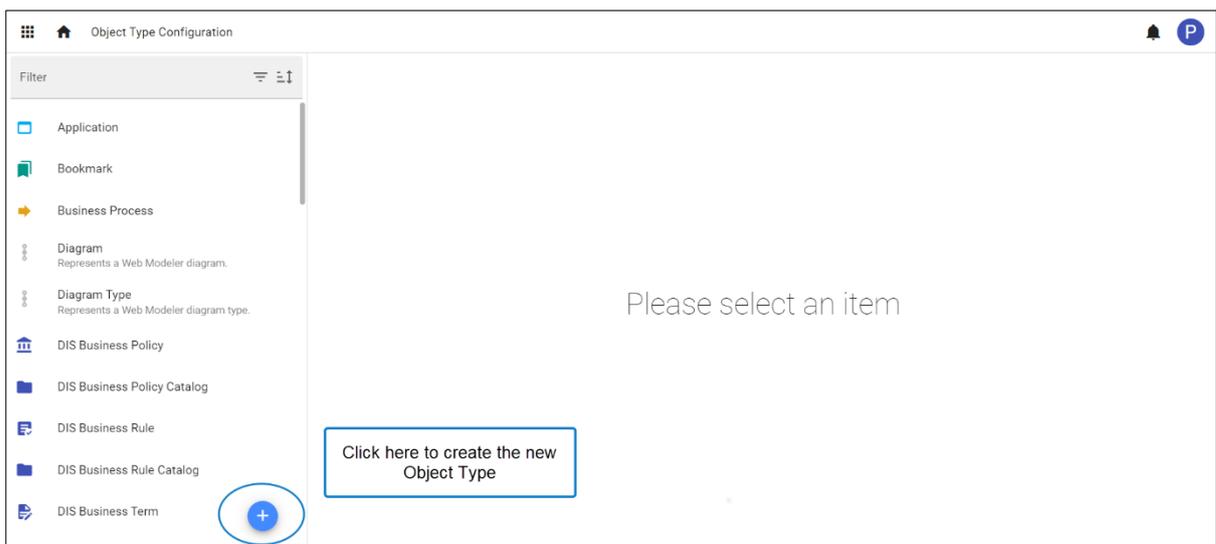
## Object Types

### How Do I Add A New Object Type?

1. Click on the profile, go to **Object Types**

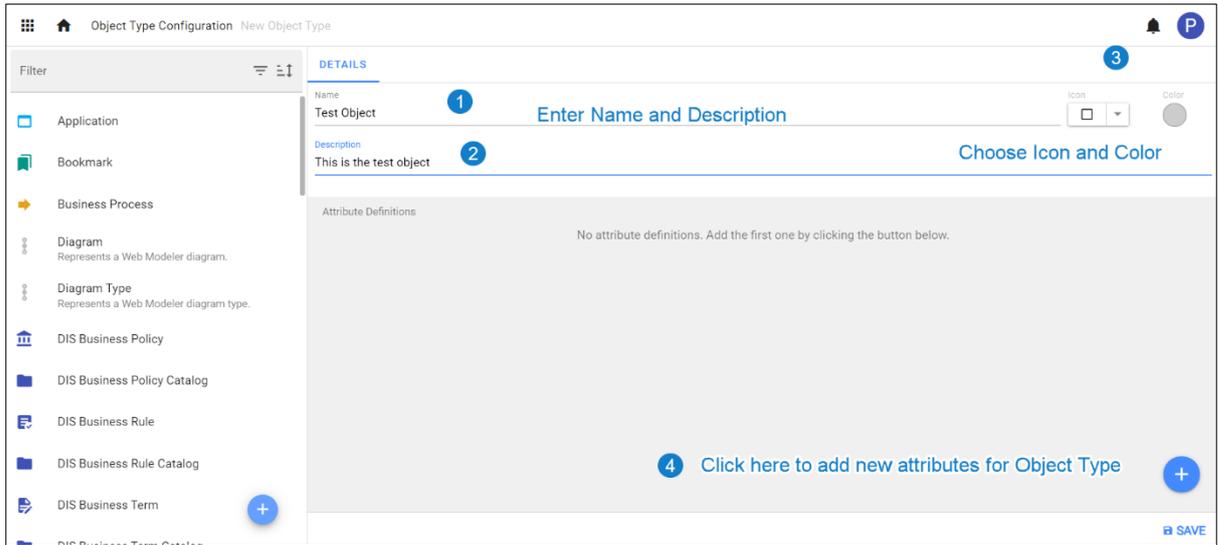


2. Click the + icon in the list view on the left-hand side of the screen, this will create a blank new **Object Type**.



3. Enter **Name** and **Description**. Add an Icon and Color you wish to assign to the new object type.

To add **Attributes** and their definition, click on + icon on the right below corner of the screen.

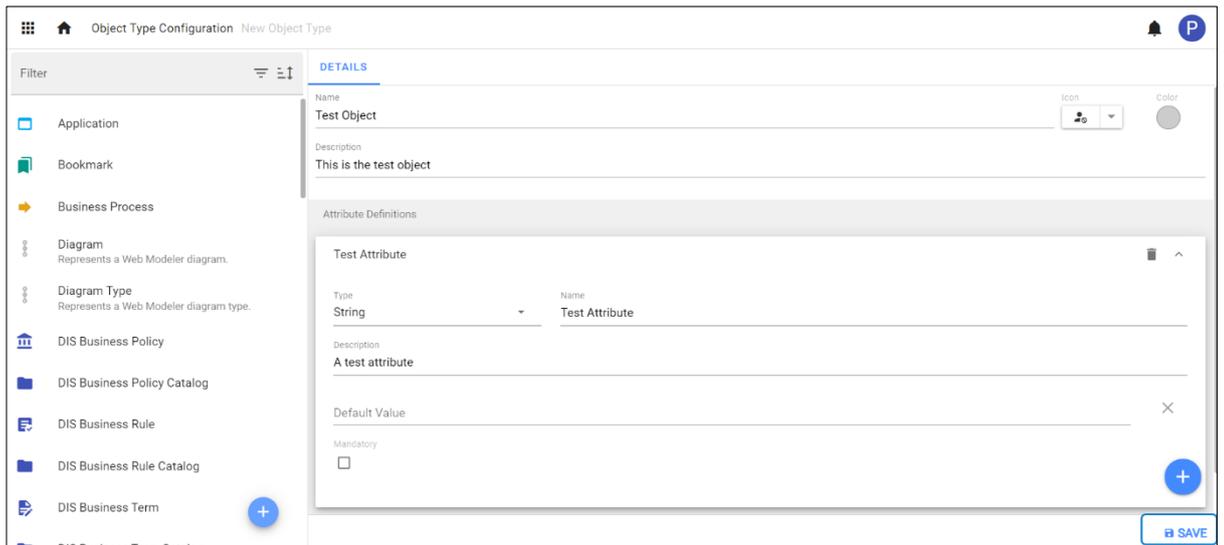


4. To add new **Attributes**:

- a. Select type of **Attribute** from the list.
- b. For each new Attribute you can provide a **Name, Description, Default Value** and choose if they are **Mandatory**.

Some Attributes such as **List** or **Array** require additional information which are unique to that Attribute type e.g., Key

- c. Click on **Save**.

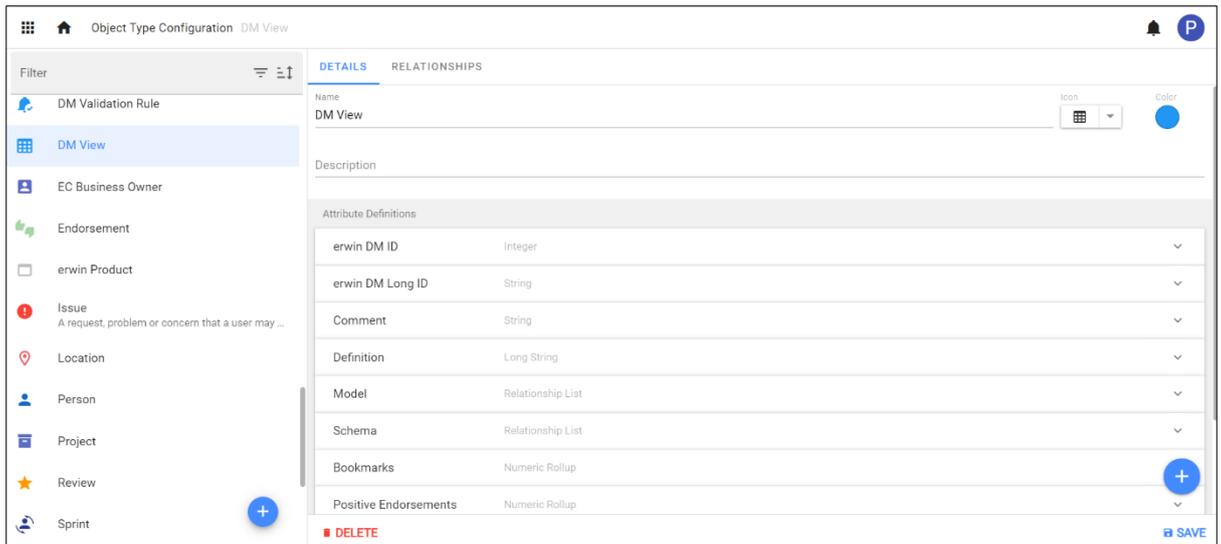
## How Do I Add an Attribute to an Existing Object Type?

### Available Attribute Types

1. Boolean - Simple true/false attribute
2. Integer - A whole number not a fraction
3. Real - Whole number/fraction/positive or negative
4. String - Text with a limit of 255 characters
5. URL - Set a URL for use as a clickable hyperlink or an Item Action
6. Date Time - Set a single point in time
7. Date Time Range - Define a range of time with a start and end date
8. List (Single) - Create a single choice list
9. List (Multiple) - Create a multiple-choice list
10. Array (Single) - Set a single choice key & value array
11. Array (Multiple) - Set a multiple-choice key & value array
12. Scorecard - Allows users to use a predefined 'scorecard' to perform equations on numeric attributes
13. Relationship List - Create a pick-list from a defined relationship and object type
14. Numeric Rollup – Roll up numeric values through relationships
15. Date Time Rollup – Roll up date-times through relationships
16. Date Time Range Rollup – Roll up date-time range through relationships
17. Long String - Text with a limit of 16,383 characters
18. Image - Allow users to attach an image to an object instance

### Configuring an Attribute

1. Click on the profile, go to **Object Types**.
2. Search for a specific Object Type to add an Attribute or you can manually scroll through the list.
3. Click on the Object Type in the list to bring up its details.
4. Click on the blue + button in the bottom right of the details view.



5. This will bring up a blank Attribute. Select your **Attribute Type**

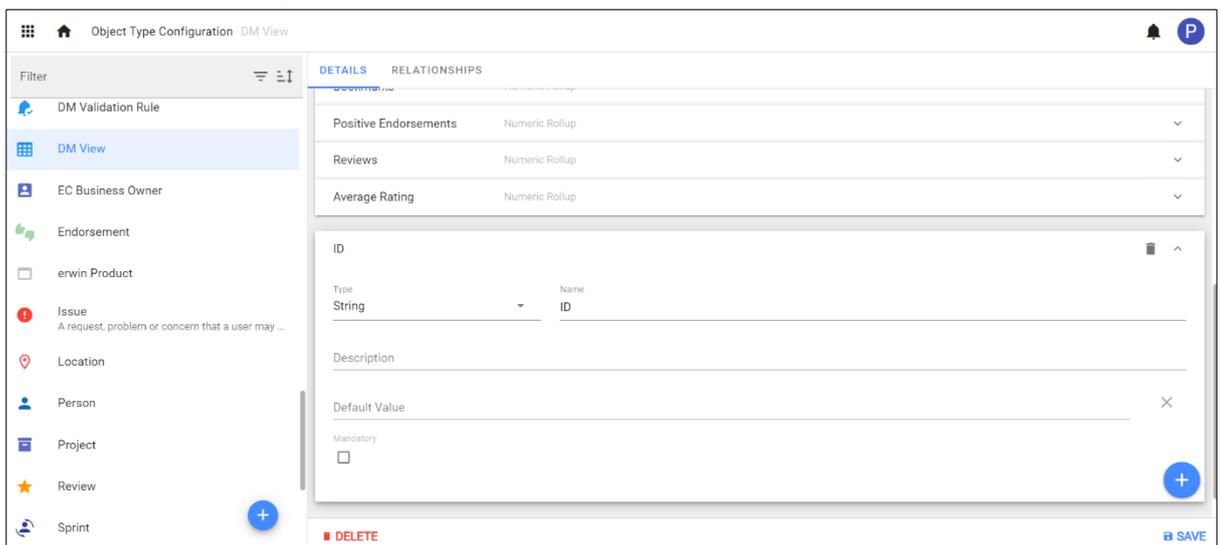
6. Enter new **Attribute a Name & Description.**

You can also set a **Default Value** for new Instances of the **Object Type**

And finally, choose if your new Attribute is **Mandatory** by checking the box

- a. Some Attributes such as **List** or **Array** require additional information which are unique to that Attributes Type e.g. Key

7. Click **Save** in the bottom right of the screen to finish adding the new attribute.



**i** | A default view is required to see Object Types. To create the default view, (see topic link)

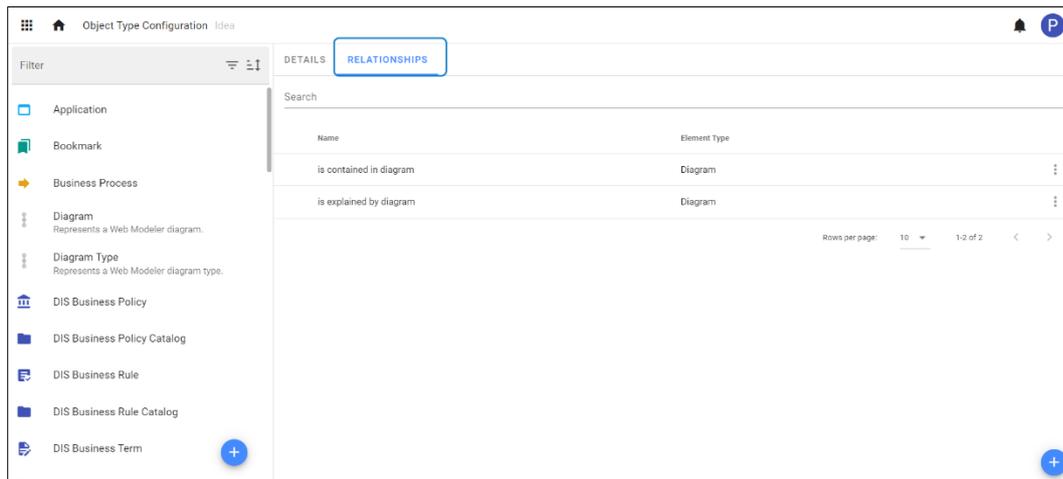

# Relationships

## How Do I Create A New Relationship?

To add the **Relationships**, go to **Object Types** and select from the list you wish to add.

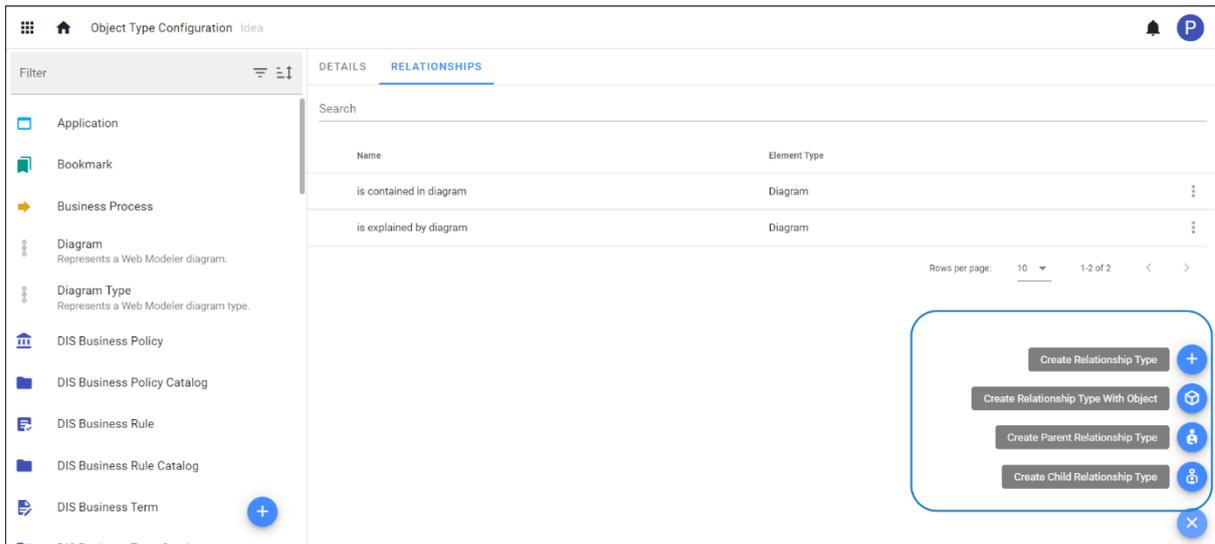
Click on the tab **Relationships**.



**i** By default, every Object Type will have its wildcard Relationships that exists in the model and populated automatically.

To add a new **Relationship**, click on + icon at the right bottom of the screen. This will show the four types of **Relationships** available.

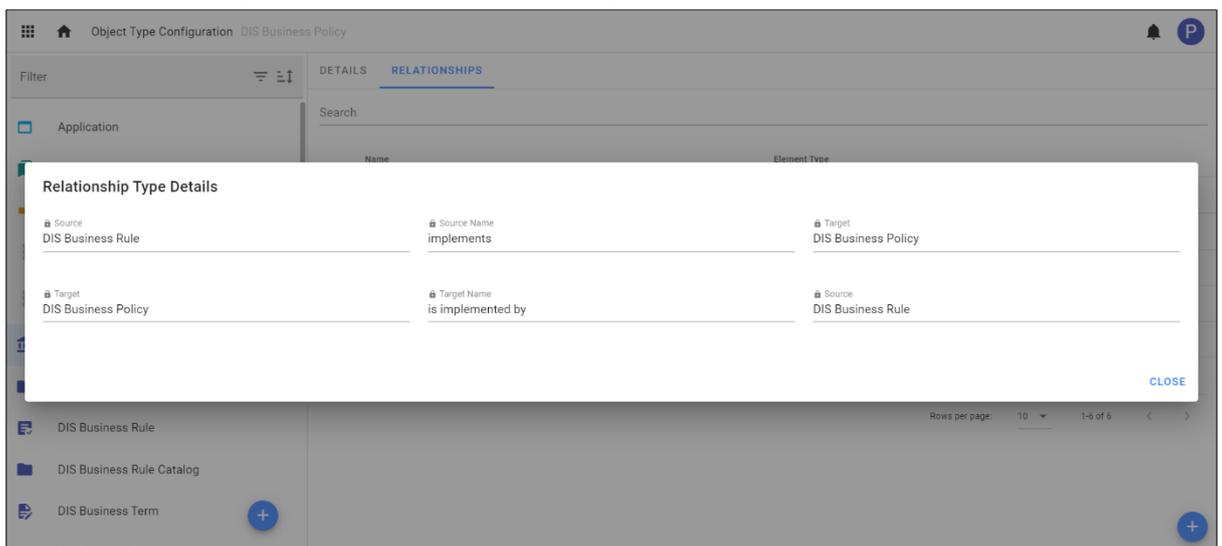

## Create Relationship Type

To create a simple Relationship between the objects,

1. Go to **Create Relationship Type**.
2. Select **Source** and **Target**, enter **Source Name** and **Target Name**.



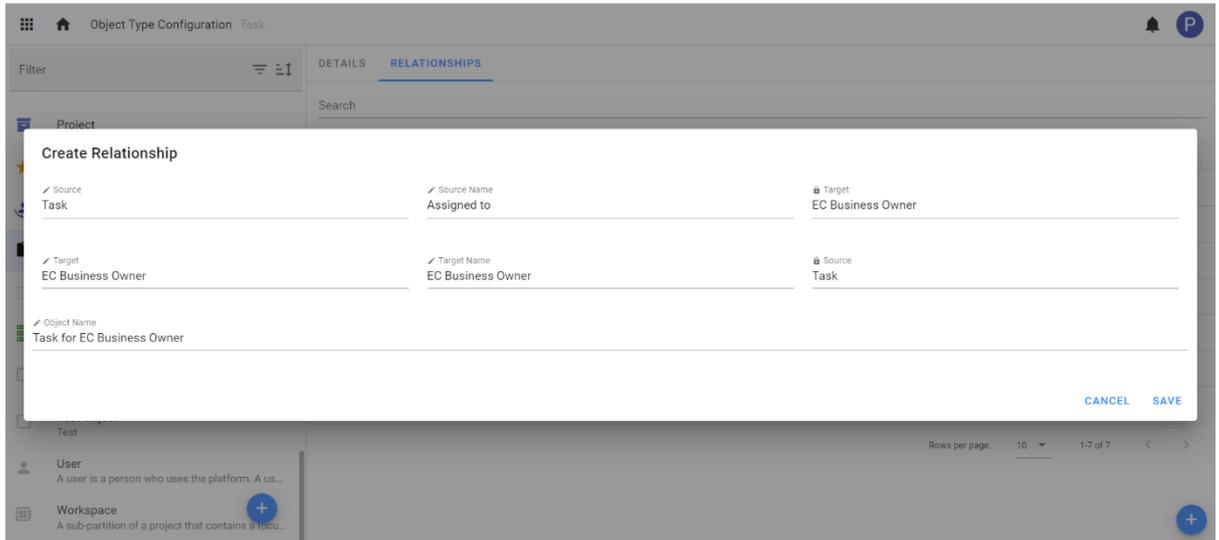

## Create Relationship Type with Object

Create Relationship Type with Object works similarly as the first relationship type, but if you want an object to represent the relationship, then select **Create Relationship Type with Object**.

This will create an Object Type with the Relationship.

1. Go to **Create Relationship Type with Object**.
2. Select **Source** and **Target**, enter **Source Name** and **Target Name**.  
Enter **Object Name** to display.



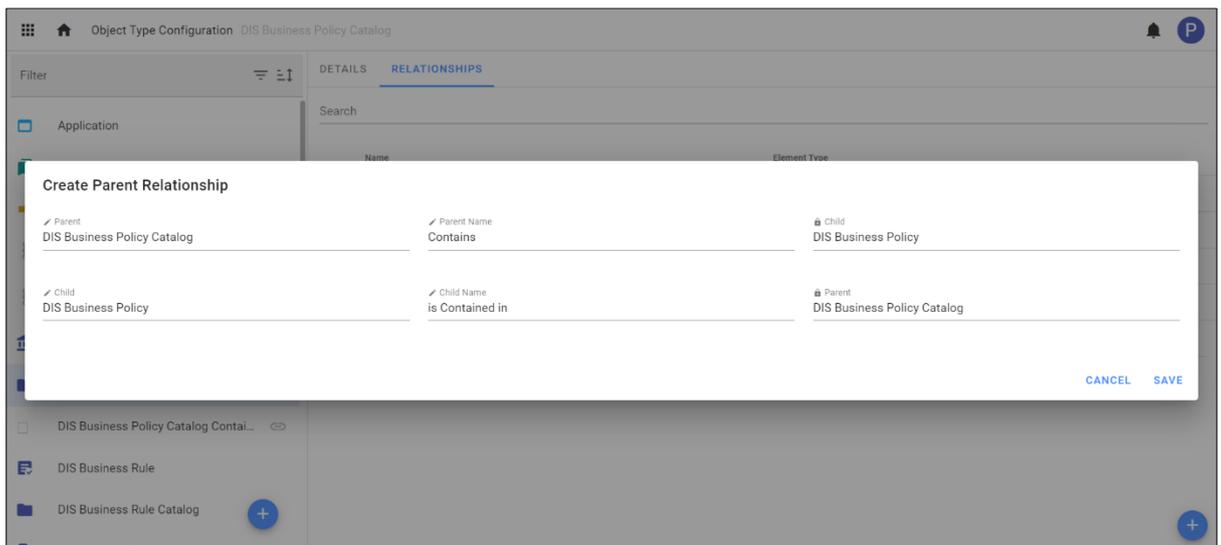
3. Click on **Save**.

## Create Parent Relationship Type

**Create Parent Relationship Type** is used to relate the parent to the Child Object Instances.

To create parent-child relationship,

1. Go to **Create Parent Relationship Type**
2. Select **Parent** and **Child**, enter **Parent Name** and **Child Name**.



3. Click on **Save**.

**i** Enter Parent and Child names that explains its relationship.

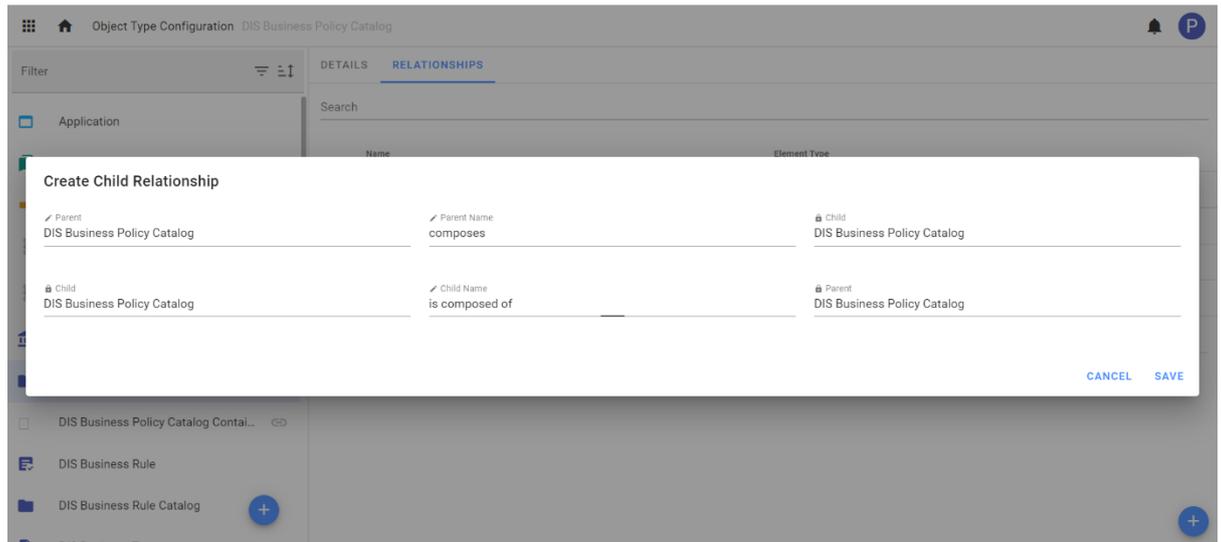

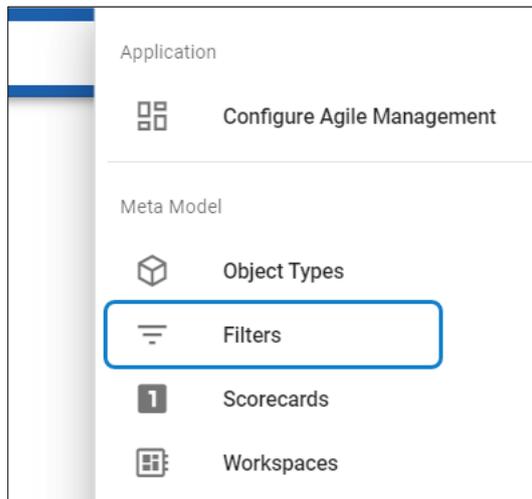

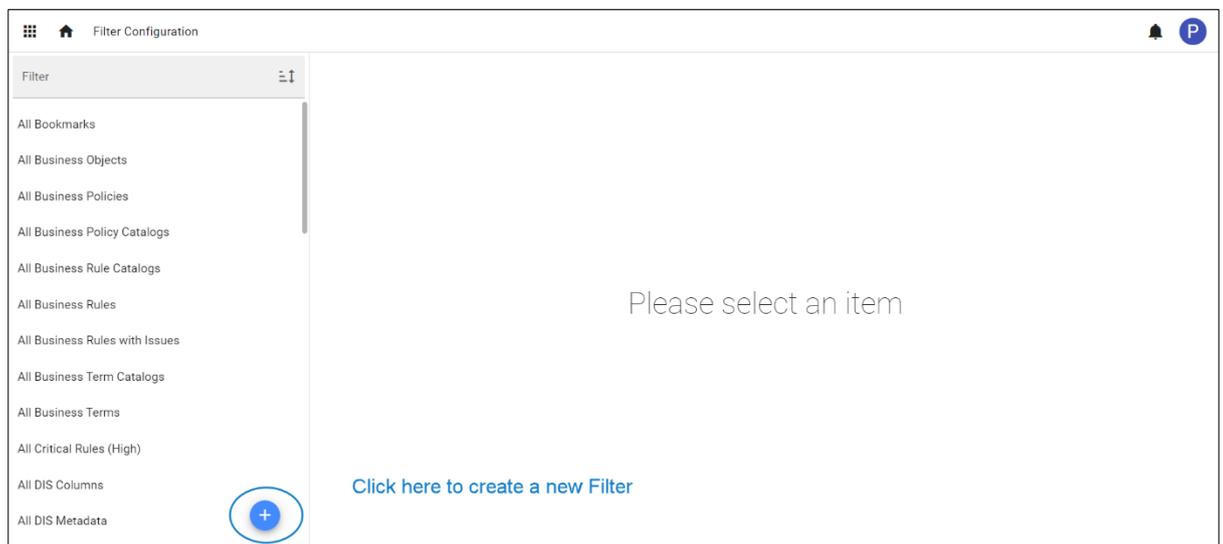
# Filters

## How Do I Create A New Filter ?

1. Click on the profile, go to **Filters**



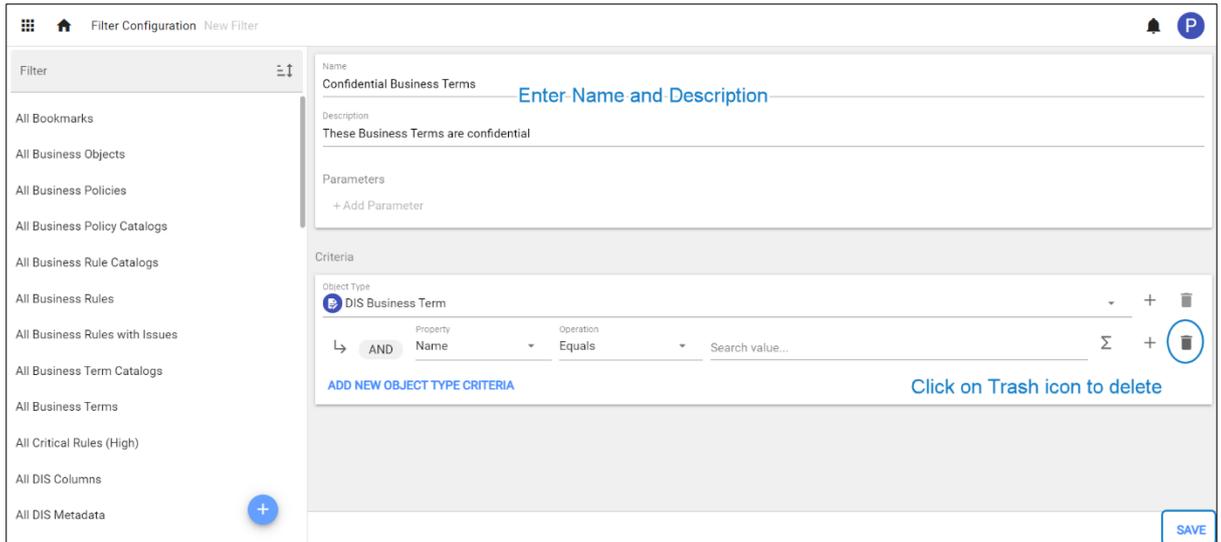
1. Click the + icon in the list view on the left-hand side of the screen, this will create a blank New **Filter**.



2. Enter **Name** and **Description**. Add **Parameters** if you wish to.
3. Select the Object Type you wish to filter by.

If you wish to filter only by **Object Type** with no further criteria, press the **Trash icon** on the additional criteria and click **save**.

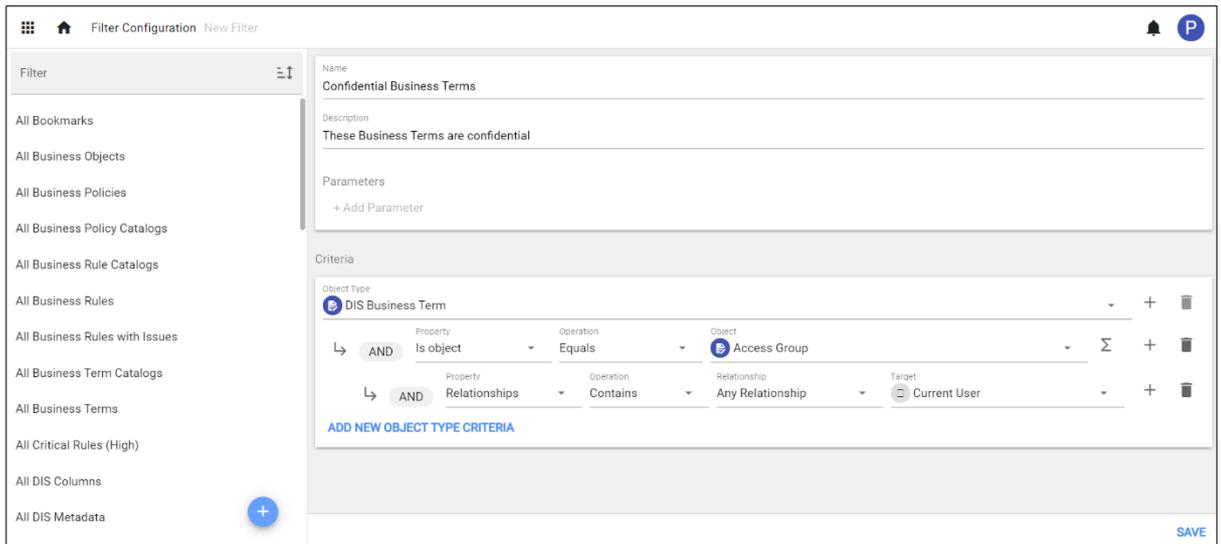
This will create a filter which display all Business Terms as shown in the below figure.



4. To add the further criteria, press the Object Type Criteria '+' icon next to the Object Type.
  - i. First additional operator will be **AND**, every additional operator afterwards will be an **OR**.
  - ii. Select the object type criteria you wish to filter by.

There are 4 main criteria categories

- 'Is Object' – You can select individual Objects of that Object Type
  - 'Use Filter' – Will only show Objects of your selected Object Type that appear as results of the selected filter
  - 'Generic Properties' – Properties that are of all Object Types
  - 'Attribute Properties' – Attributes of that specific Object Type
- iii. Select the **Property**. Depending on the **Property** you select, it presents with different operators.
    - 'Is Object' – Equals, Does not equal
    - 'Use Filter' – Is in filter, Is not in filter
    - 'Generic Properties' – Equals, Does not equal, Starts with, Does not start with, Contains, Does not contain, Ends with, Does not end with
    - 'Attribute Properties' – Equals, Does not equal, Has value, Does not have value
  - iv. Enter the Value. Depending on the criteria you selected, you need to either enter a Value or select related from the pickup list.
  - v. If you wish to add another step, click on '+' icon next to your first operator.
  - vi. Follow the steps i to iv to add details for an additional criteria branch.



5. If you wish to enter further Object Type Criteria to filter, click on **Add New Object Type Criteria** shown in blue color below the operations.

Repeat Steps from 4 to add new filter.

6. Once Object Type **Filters** are added, click on **Save**.

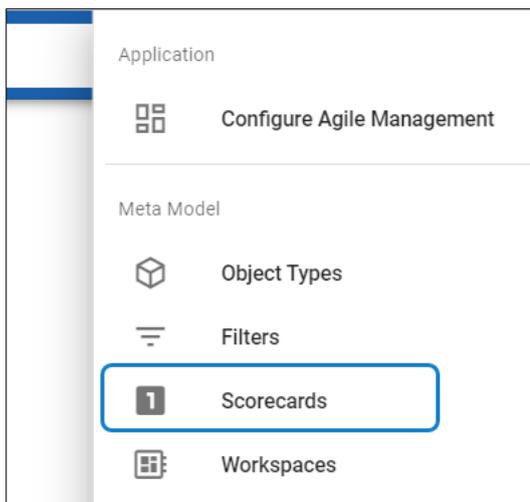

# Scorecards

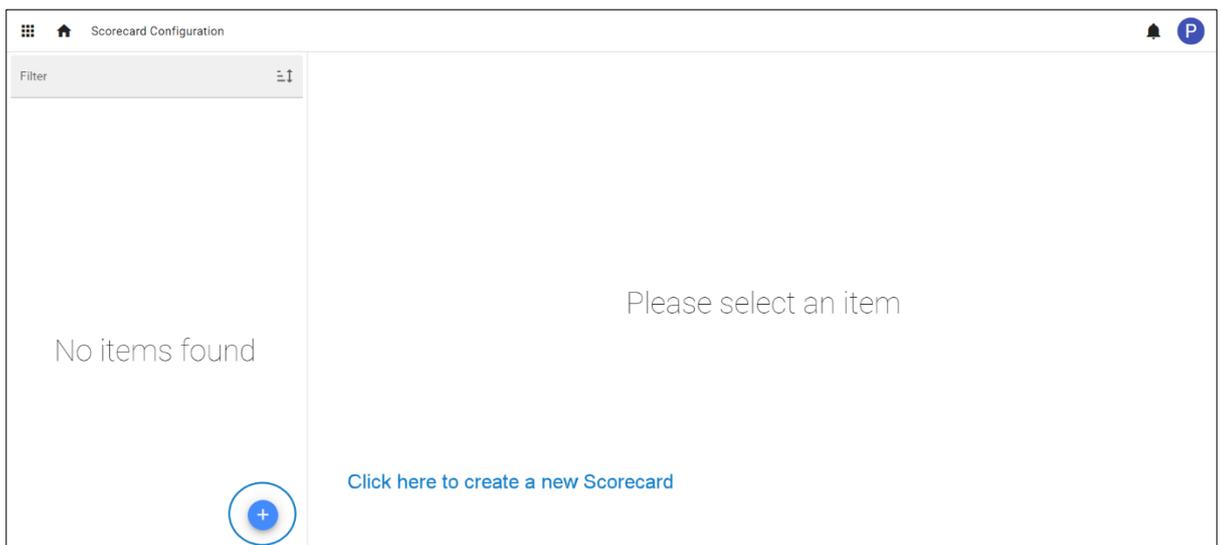
**Scorecards** are templated formula, which can be applied to the **Object Types**. It helps you manage and evaluate metrics that can be applied to objects. With many objects, creating an automated score is the best way to calculate value.

## How Do I Create a New Scorecard?

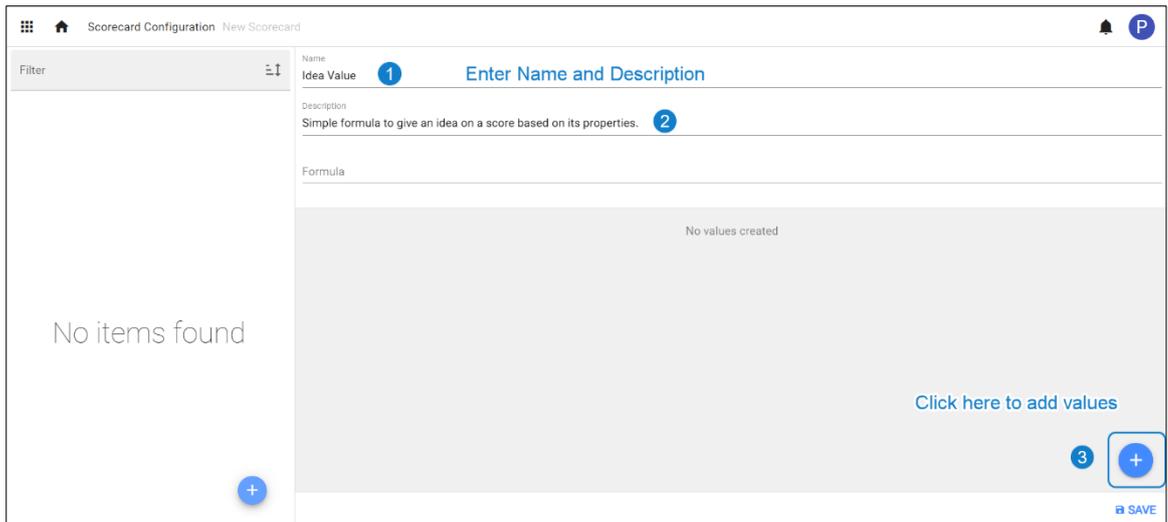
1. Click on the profile, go to Scorecards.



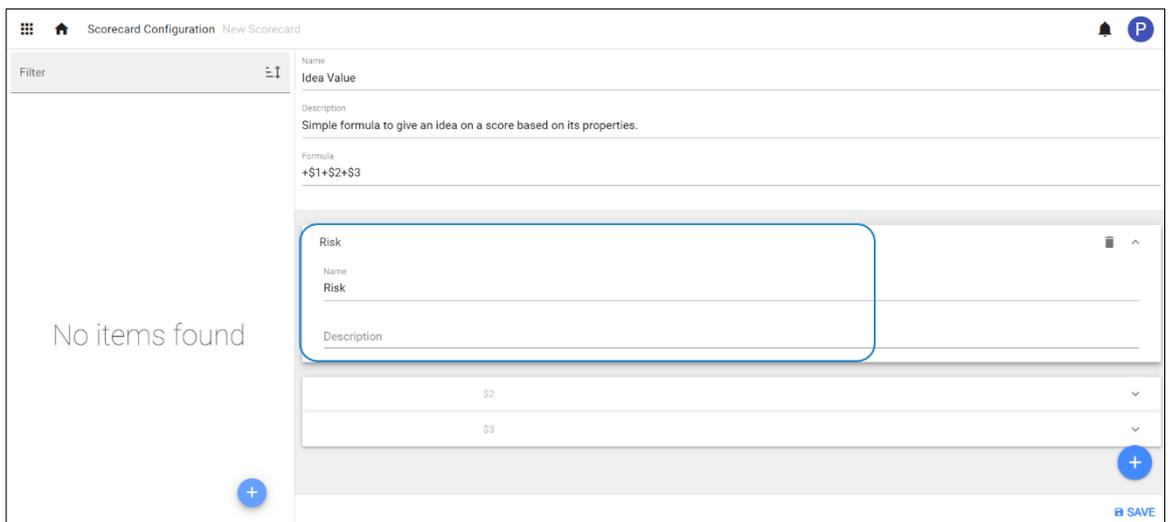
2. Click the + icon in the list view on the left-hand side of the screen, this will create a blank new **Scorecard**.



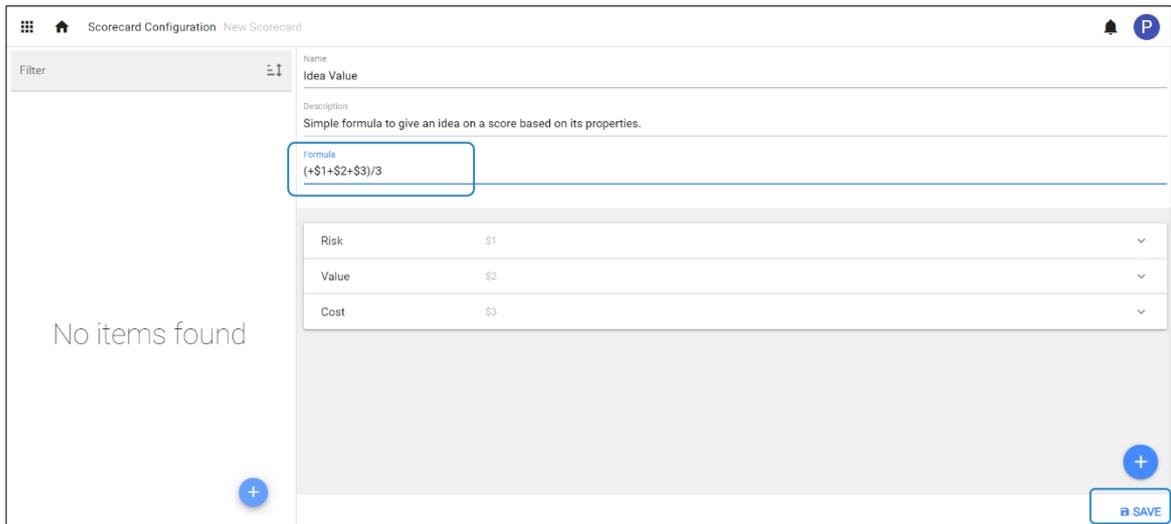
3. Enter **Name** and **Description**. Click on + icon at the bottom of the screen to **Add Values** to the formula.



4. You need to click multiple times to add required values. Click on the expansion button against each value and then enter **Name** and **Description** for every value added.



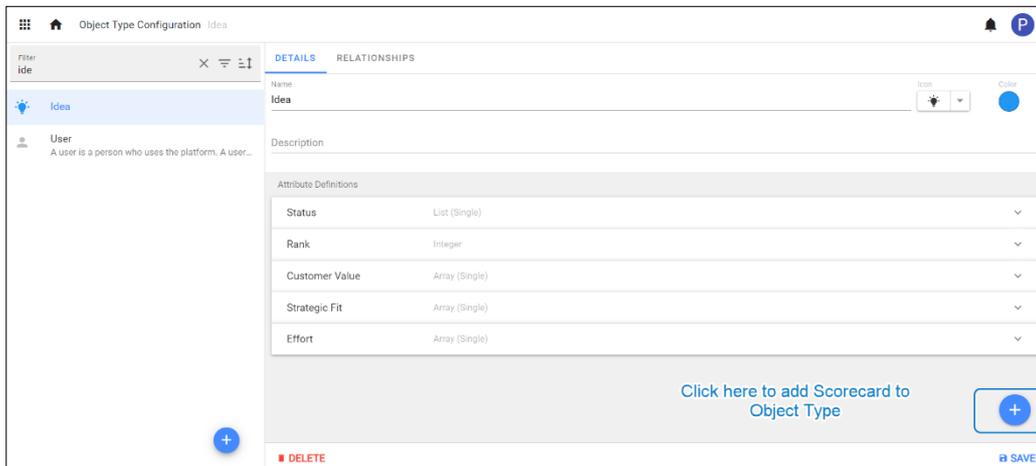
5. Edit the **Formula**, if needed. To finish creating a **Scorecard**, click on **Save** from the right bottom of the screen.



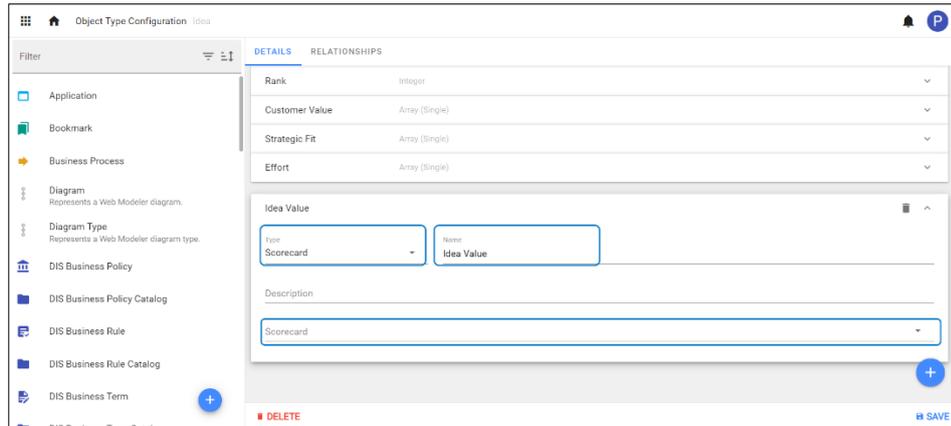

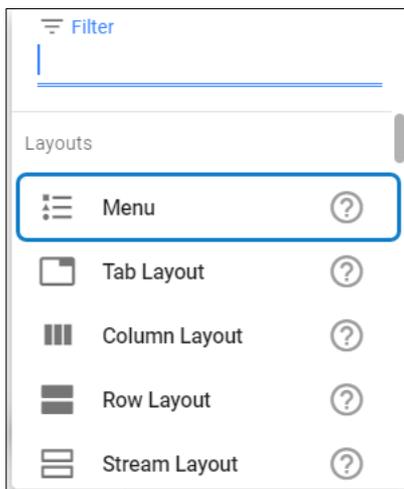
# Menu View

**Menu view** in the Layout is used to create a structure with a separate set of information on the same page.

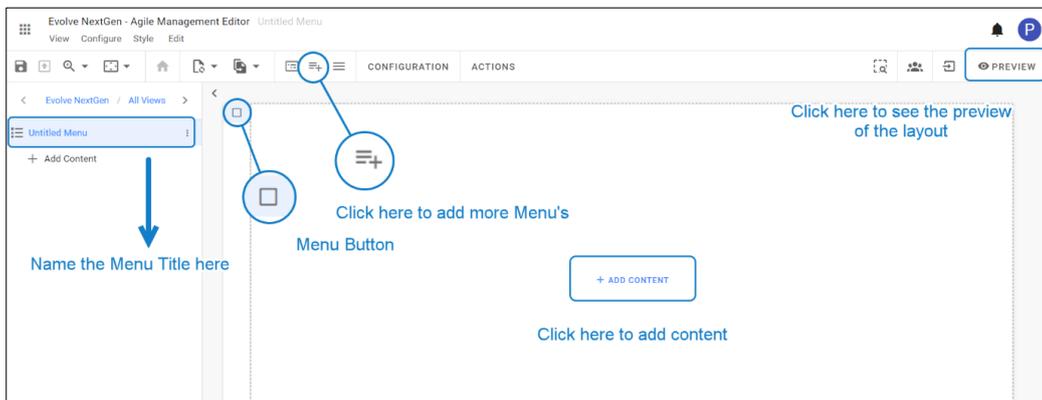
To create a **Menu View**,



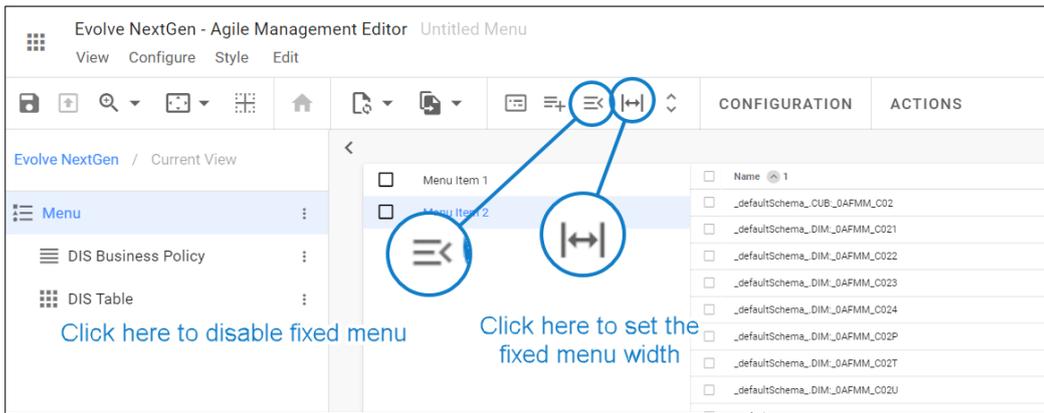
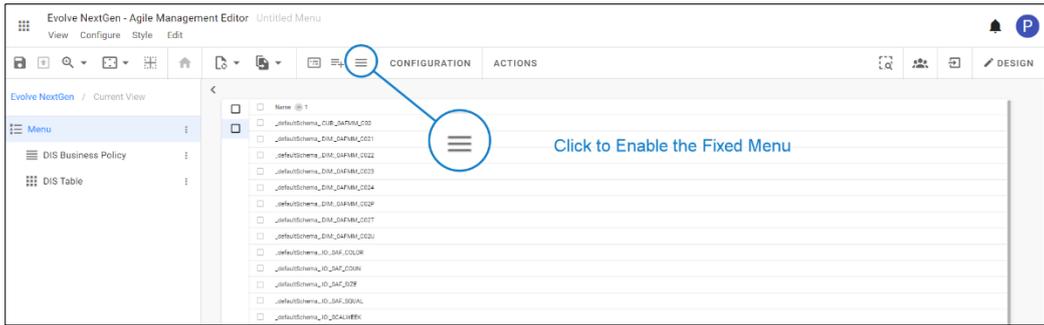
1. Click on **All Views** in the application editor and then click on  icon placed at the bottom of the list of views, then select **Menu**.



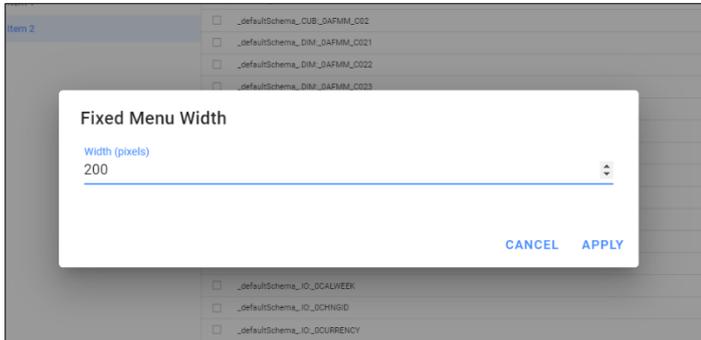
2. Click on **Add Menu Item** icon from the toolbar or click on **Configuration** to add the menu items.



3. To **Enable Fixed Menu**, click on the icon shown in the picture below.



To customize the **Menu Width**, click on **Configure Fixed Menu Width** shown above. Enter the value and then click on **Apply**.

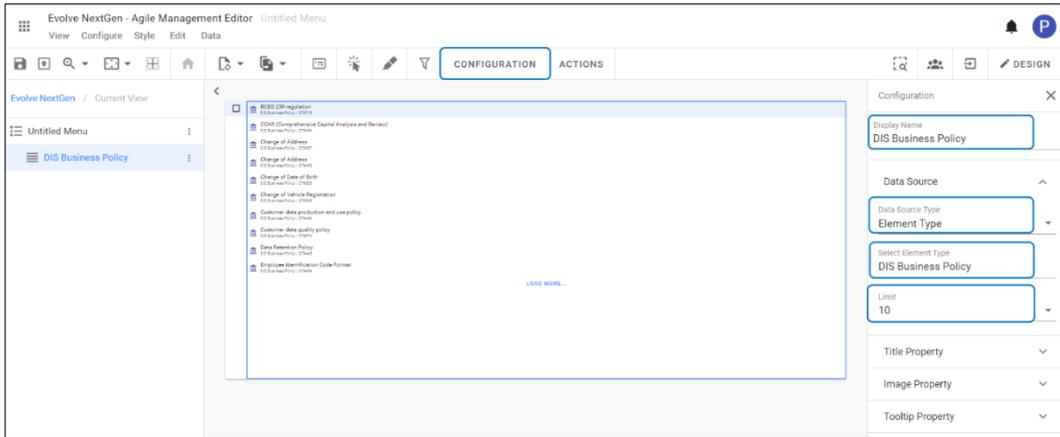


**i** The menu width should be greater than or equal to 200px.

4. Click on **Add Content** and select the view type you wish to configure.

You can add any other **Layout, Collection, Charts, or Item Views** under each menu as per your use case.

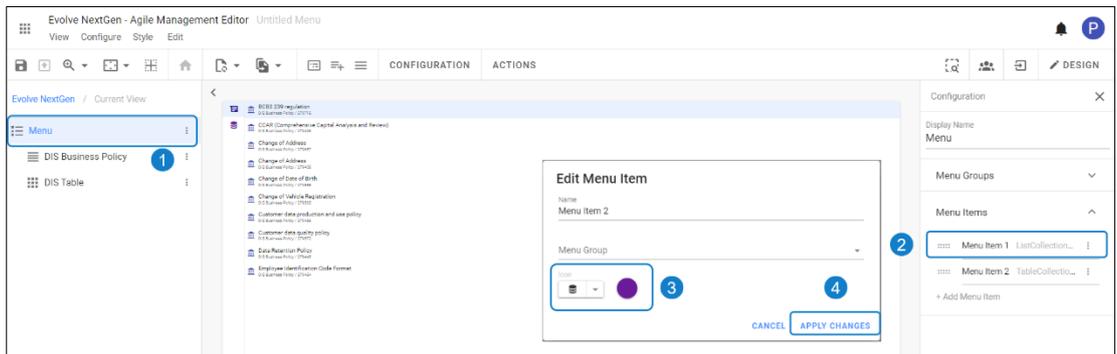

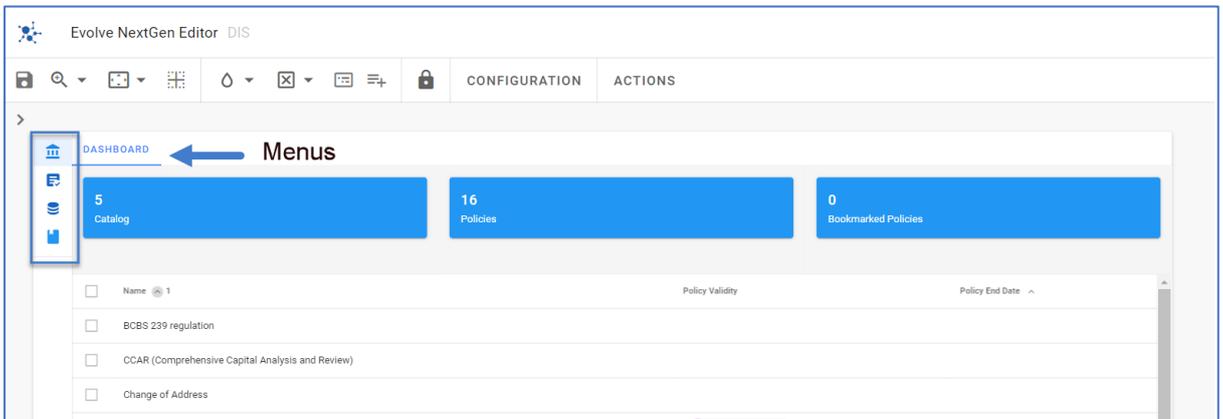
5. To configure the displaying title property, click on Title Property under Configuration

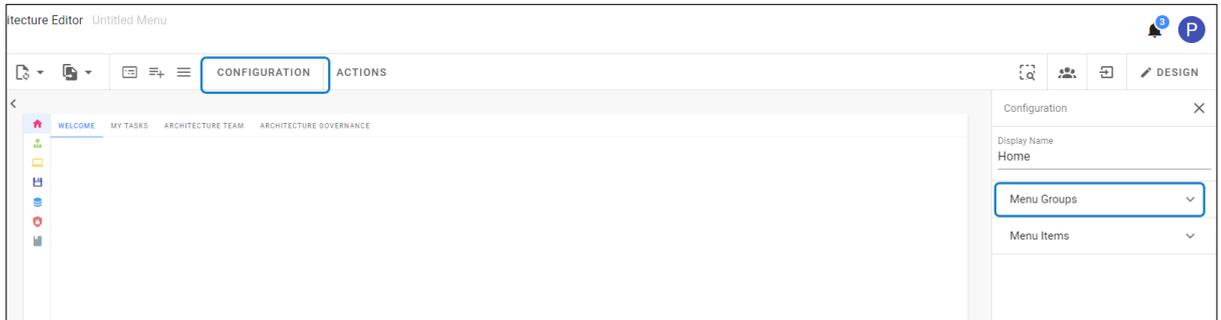

## How to work with Menu Groups?

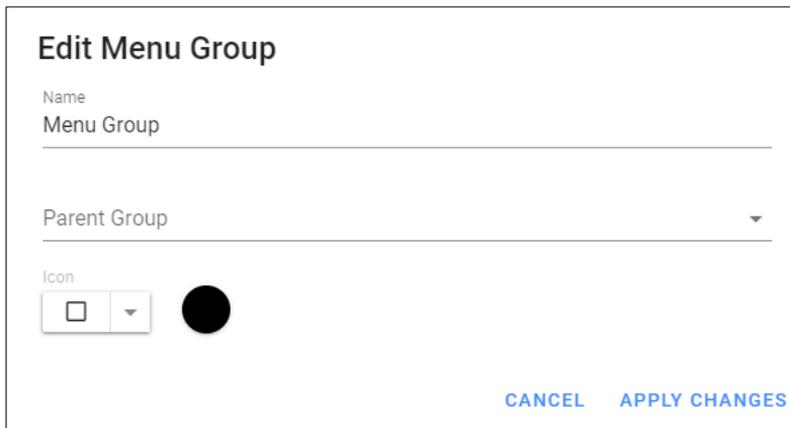

Enter **Name** > Select **Parent Group** (Optional) > Select **Icon and Color** > **Apply Changes**.

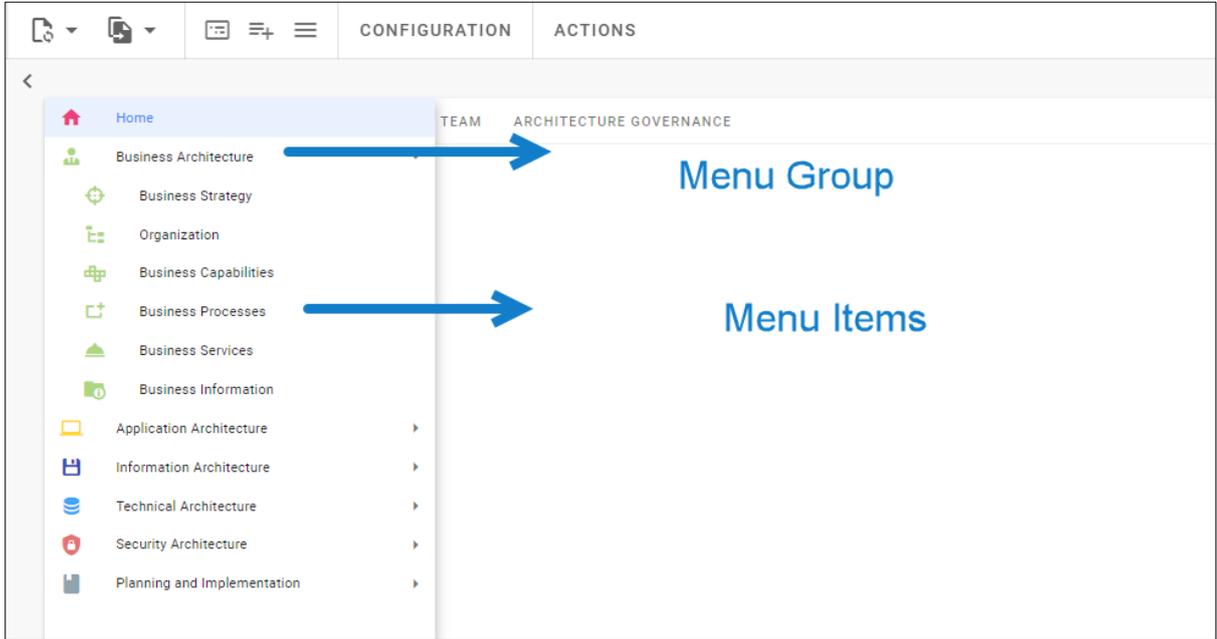

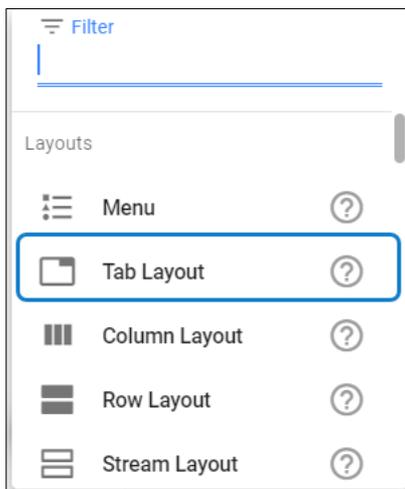

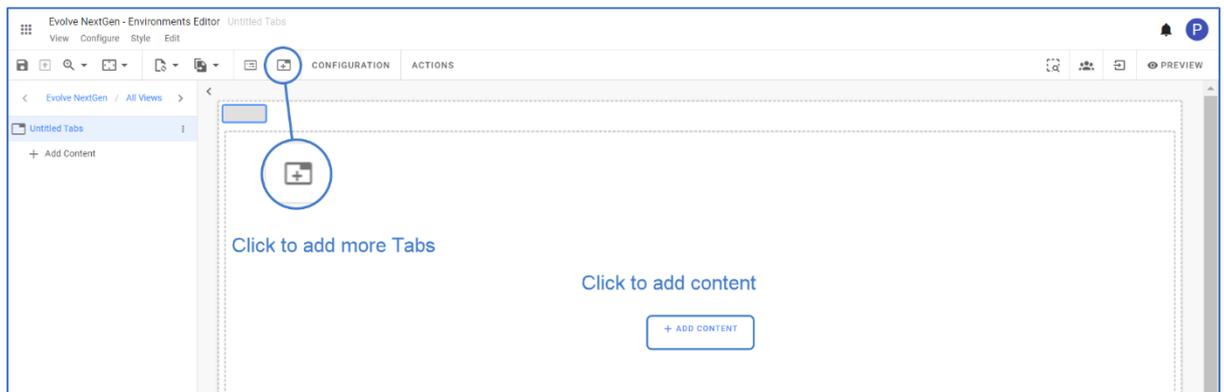
**Tabs View** helps to organize the content in a separate section on a page.

To create **Tabs**,

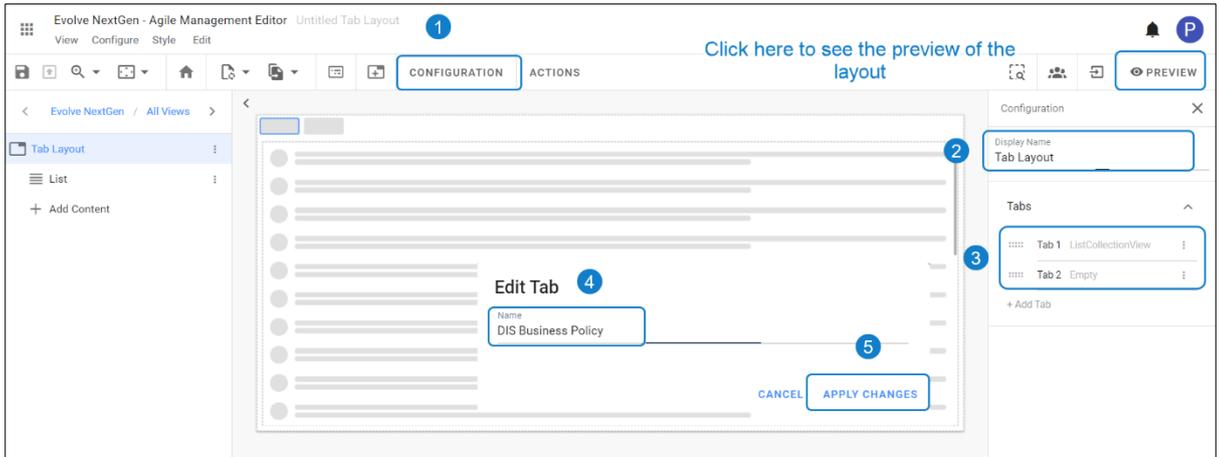

You can add any **Collection**, **Charts**, **Item** views as per your use case. For instance, a **Table View** and a **List View** added in the columns. You must configure each column individually.

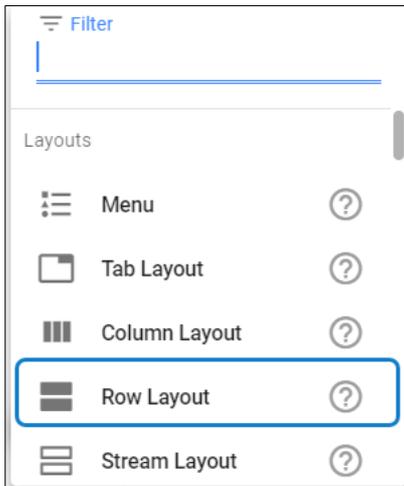
# Row Layout

**Row Layout** helps create a modern dashboard with customizable rows size and position in the editor.

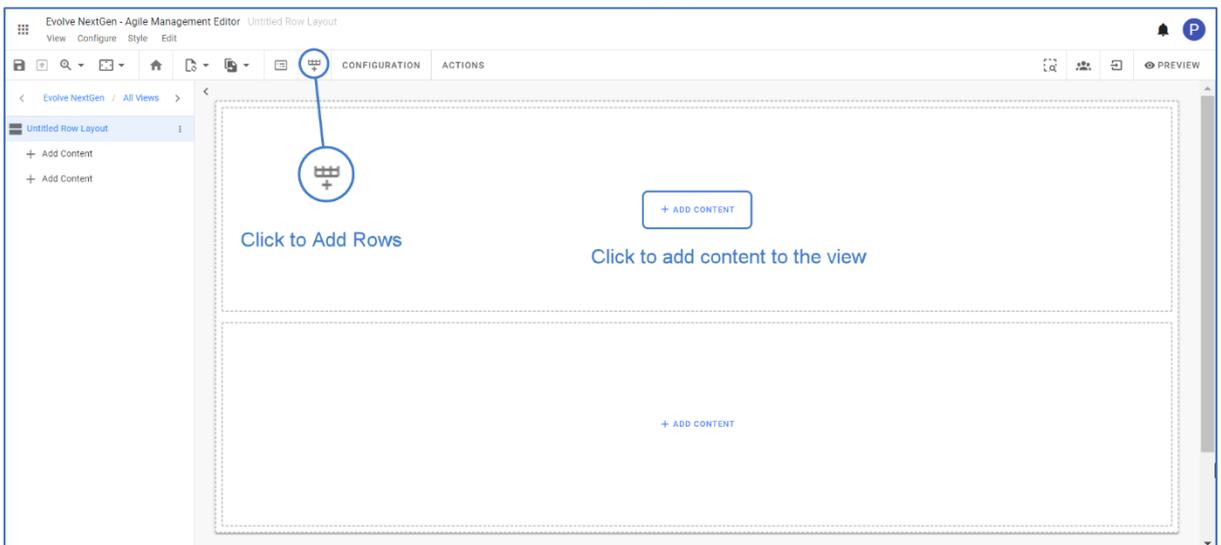
To create a **Row Layout**,



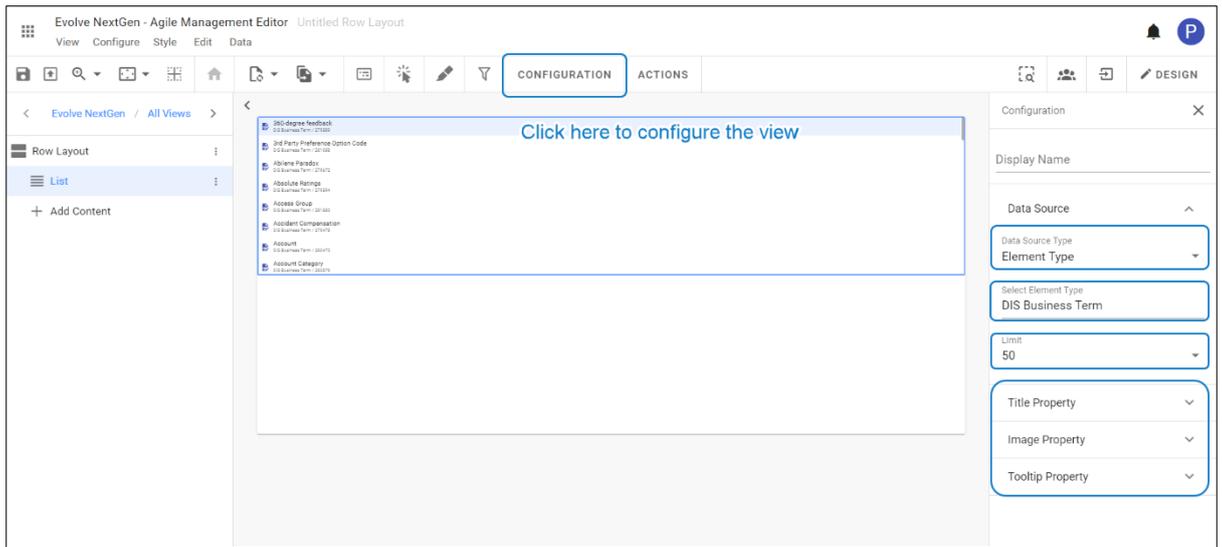
1. Click **All Views** in the editor, then click on the icon placed at the bottom of the list of views.
2. Select **Row Layout** from the list.



3. Click on **Add Content > Add New View > Select the view type** you wish to add.



4. After adding content in the Rows, select the **Row** and click **Configuration** on the toolbar or right-click on the view. You can add any **Collection, Charts, Item** views as per your use case. For instance, a **List View** is added in the first row as shown in the picture below. You must configure each row individually.



**i** The size of each **Row** can be adjusted by dragging the lines between the **Rows**. Each **Row** must be configured similarly explained above.

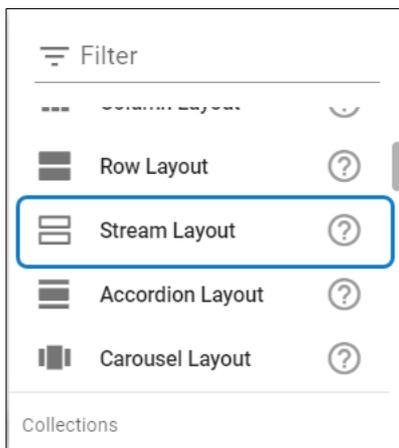

# Stream Layout

**Stream Layout** is used to create the mixed content in the rows which can be scrolled.

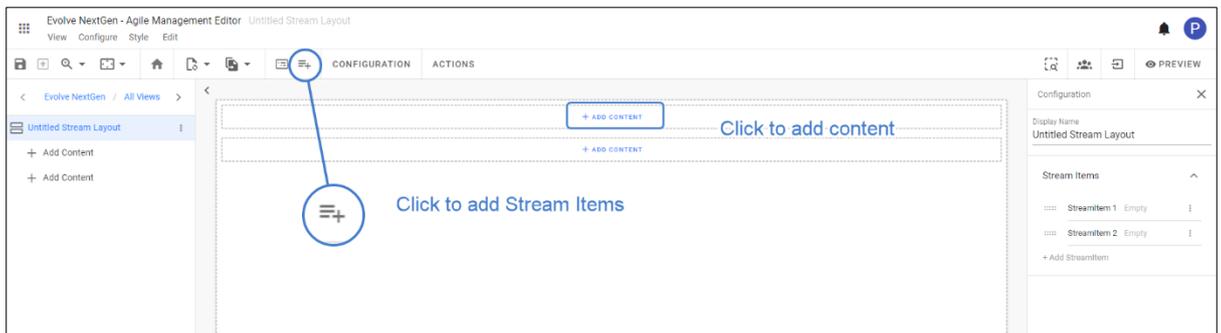
To create a **Stream Layout**,

1. Click on **All Views** in the editor and then click on  icon placed at the bottom of the list of views.
2. Select **Stream Layout** from the list.

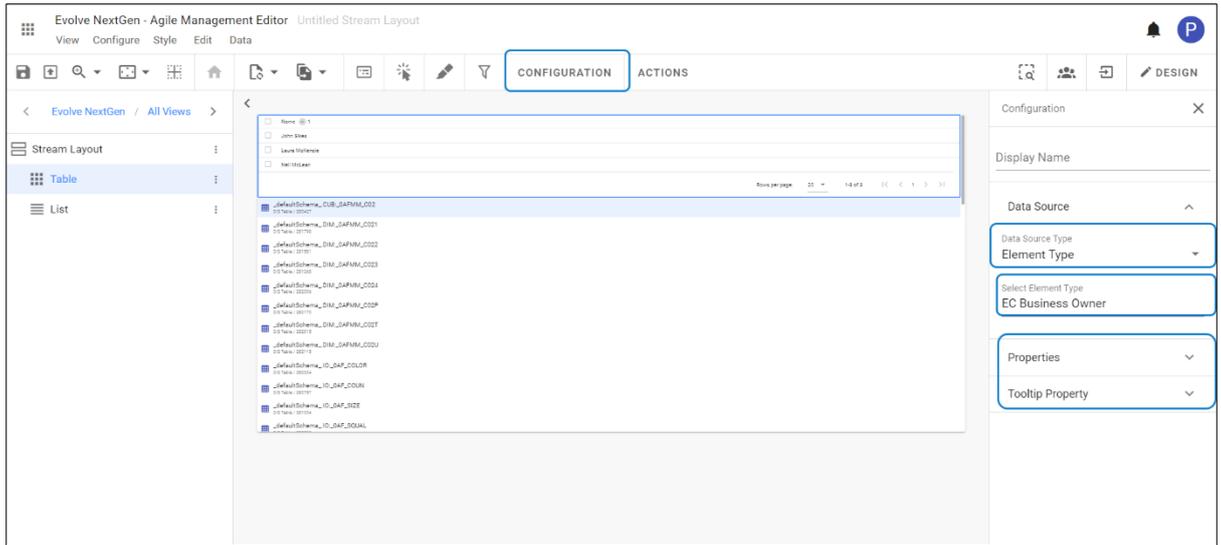


3. A layout with two rows by default will be opened in the editor as shown in the picture below.

Click the icon  to add **Stream Items**.



4. Click on **Add Content > Add New View > Select the view type** you wish to add. Repeat the same step for other items too.
5. After adding content in the layout, select the **Stream** and click **Configuration** on the toolbar or right-click on the view. You can add any **Collection, Charts, Item** views as per your use case. For instance, a **Table** and **List View** is configured as shown in the picture below. You must configure each stream individually.

# Accordion Layout

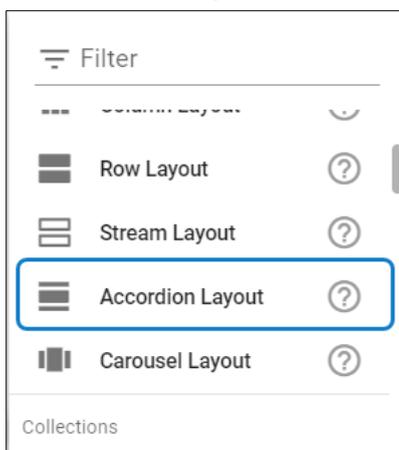
**Accordion Layout** helps to categorize a form or to create a flow to the information.

Each accordion is used to toggle between hiding and showing the content.

To create **Accordion Layout**,



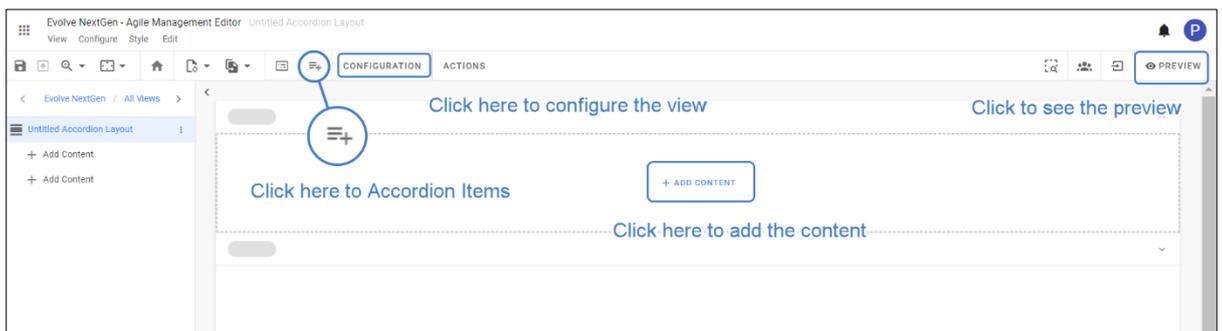
1. Click on **All Views** in the editor and then click on  icon placed at the bottom of the list of views.
2. Select **Accordion Layout** from the list.



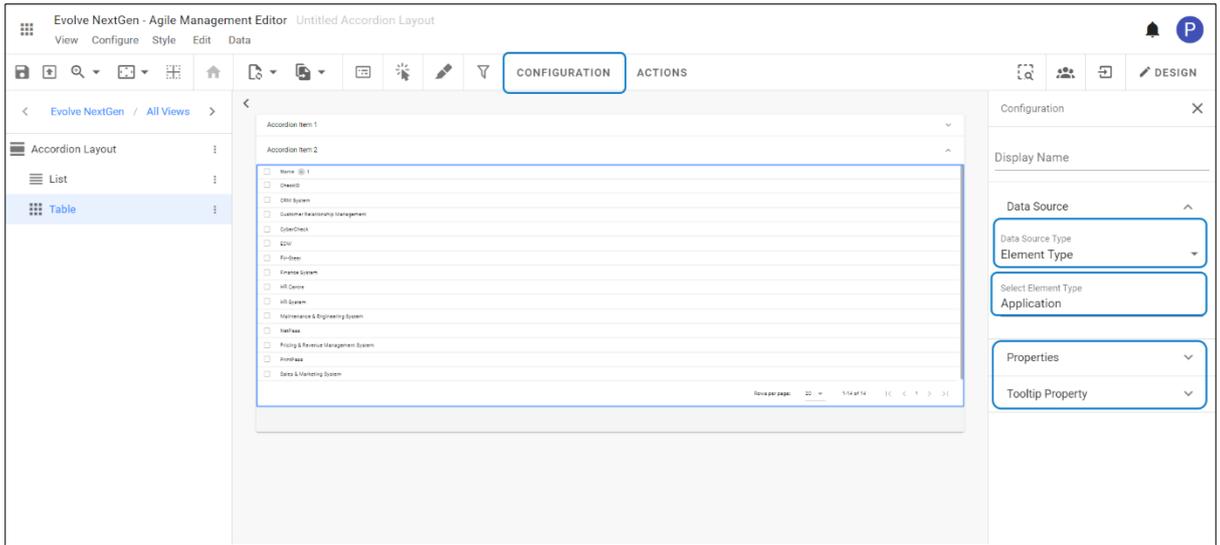
3. A default layout will be opened in the editor as shown in the picture below.



Click the icon  to add **Accordion Items**.

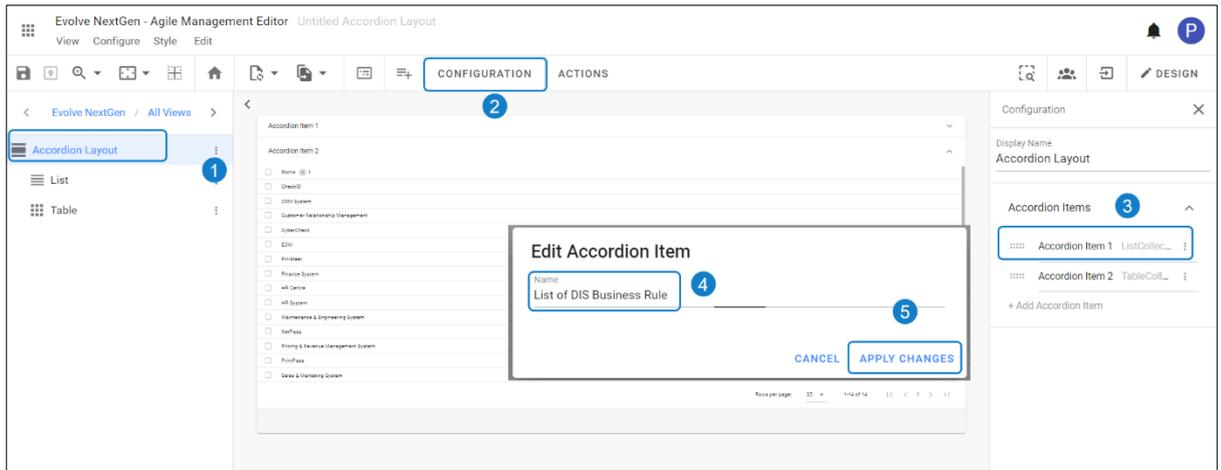


4. Click on **Add Content > Add New View > Select the view type** you wish to add. Repeat the same step for other items too.
5. After adding content in the layout, select the **Accordion** and click **Configuration** on the toolbar or right-click on the view. You can add any **Collection, Charts, Item** views as per your use case. For instance, a **Table** and **List View** is configured as shown in the picture below. You must configure each accordion individually.



6. To edit the **Accordion** titles,

- Select the **Layout** title, and then click on **Configuration**.
- Click on **Accordion** you wish to edit.
- Enter **Name** and click on **Apply Changes**.



**i** Repeat Step -6 to edit all the accordions you add in the layout.

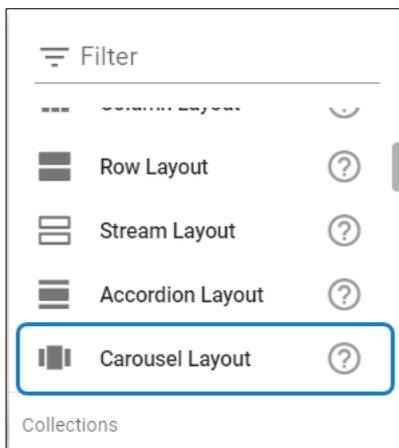
# Carousel Layout

Carousel can be used to cycle through multiple pieces of content in single space.

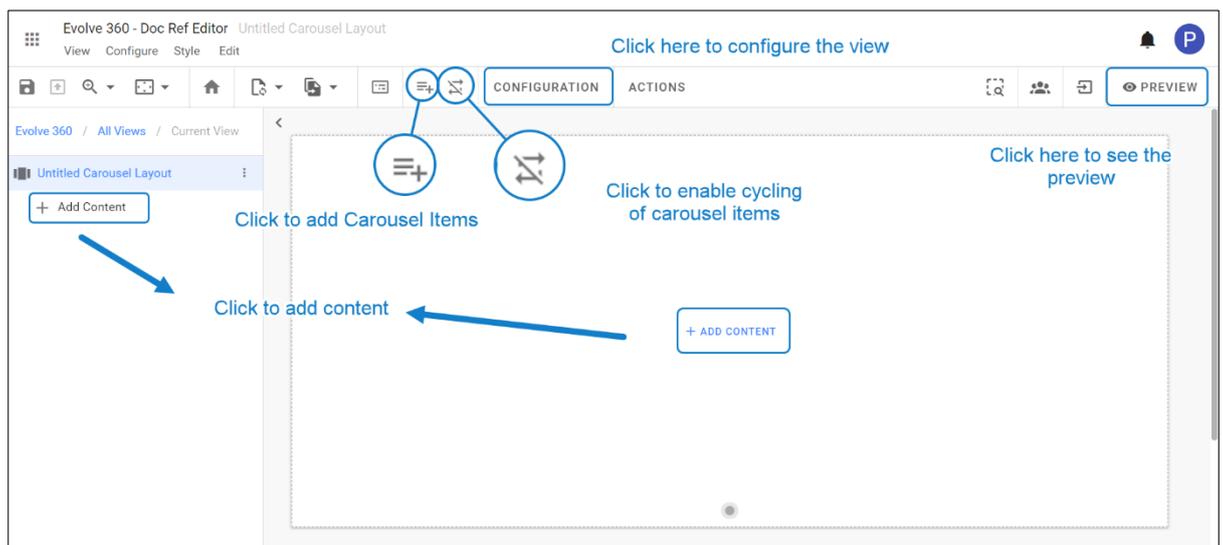
To create **Carousel Layout**,

1. Click on **All Views** in the editor and then click on  icon placed at the bottom of the list of views.
2. Select **Carousel Layout** from the list.



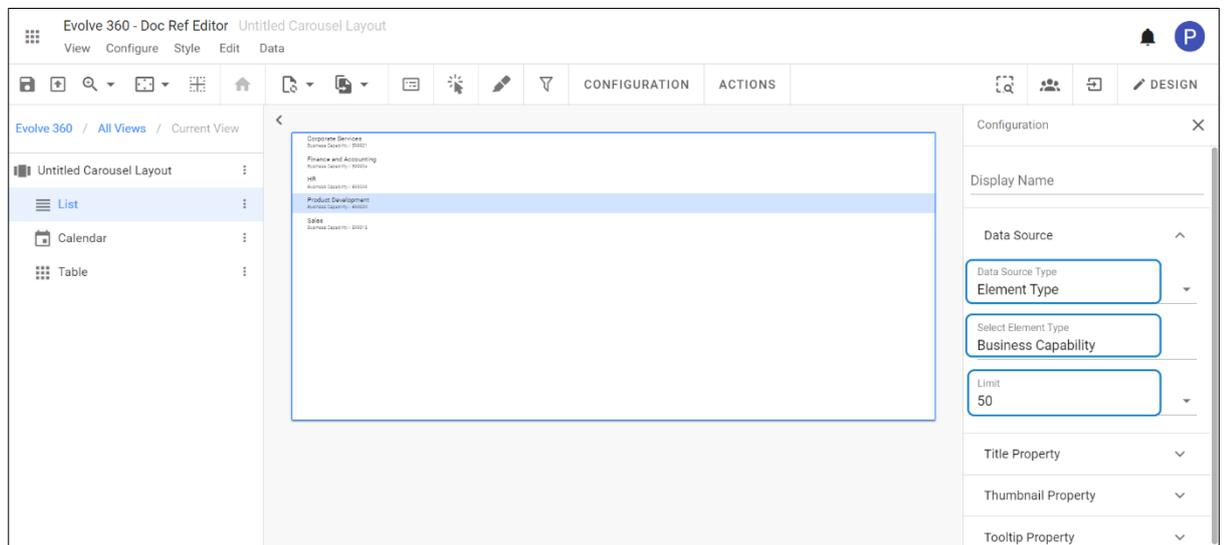
3. An unconfigured Carousel Layout will be opened in the editor as shown in the picture below.

Click the icon  to add **Carousel Items**.

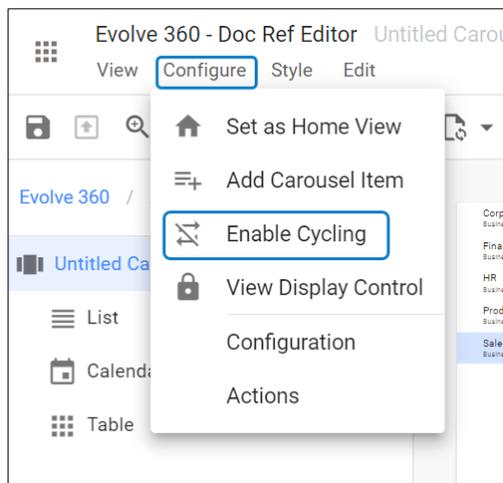


4. Click on **Add Content** > **Add New View** > **Select the view type** you wish to add. Repeat the same step for other items too.

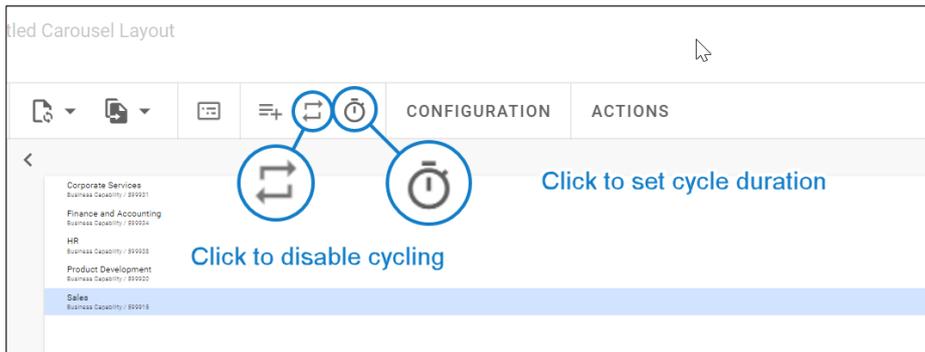
5. After adding content in the layout, select the **Carousel** and click **Configuration** on the toolbar or right-click on the view. You can add any **Collection, Charts, Item** views as per your use case. You must configure each carousel item individually.



6. To enable cycling interval for carousel items, click on  the toolbar or go to **Configure** and then select **Enable Cycling**.



To set the **Cycle Duration**, click on the  clock symbol on the toolbar.



- Enter **Duration** in seconds
- Click on **Apply**.

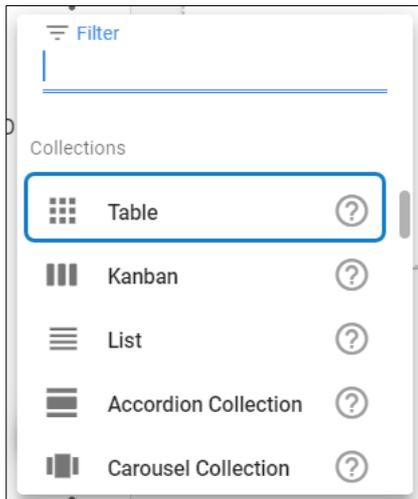

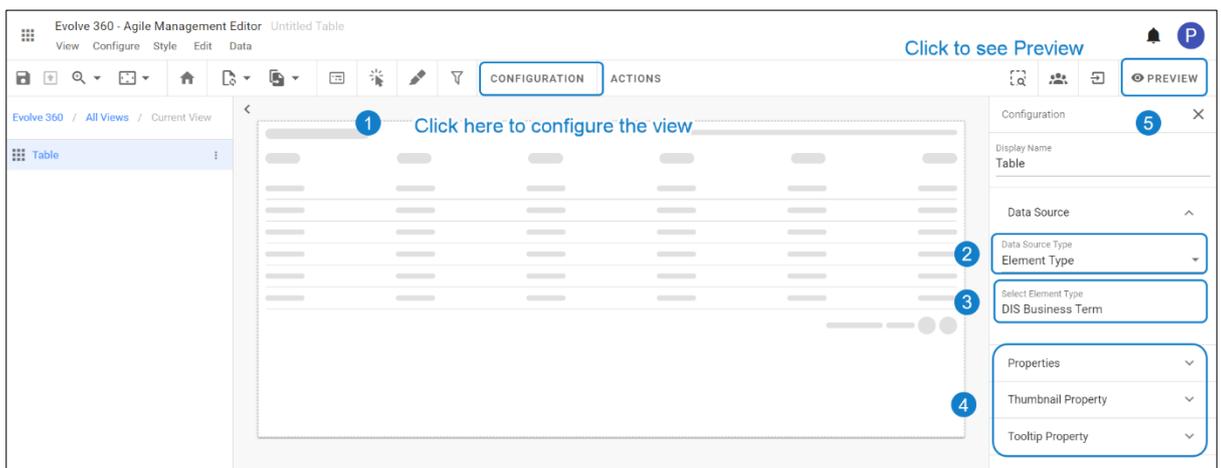
**Table** is used to show the data at once in the large cross-section with vertical scrolling.

To create **Table View**,

1. Click on **All Views** in the editor and then click on  icon placed at the bottom of the list of views.
2. Select **Table** from the list.



3. To configure the view,
  - Click on **Configuration** on the toolbar or right-click on the view.
  - Select **Data Source**, either **Element Type** for a new one or **Filter**.
  - Apply the **Properties, Thumbnail Property and Tooltip Property** according to the view.
  - Click **Preview** to see the result.

Pie charts help to visualize proportions between attributes.

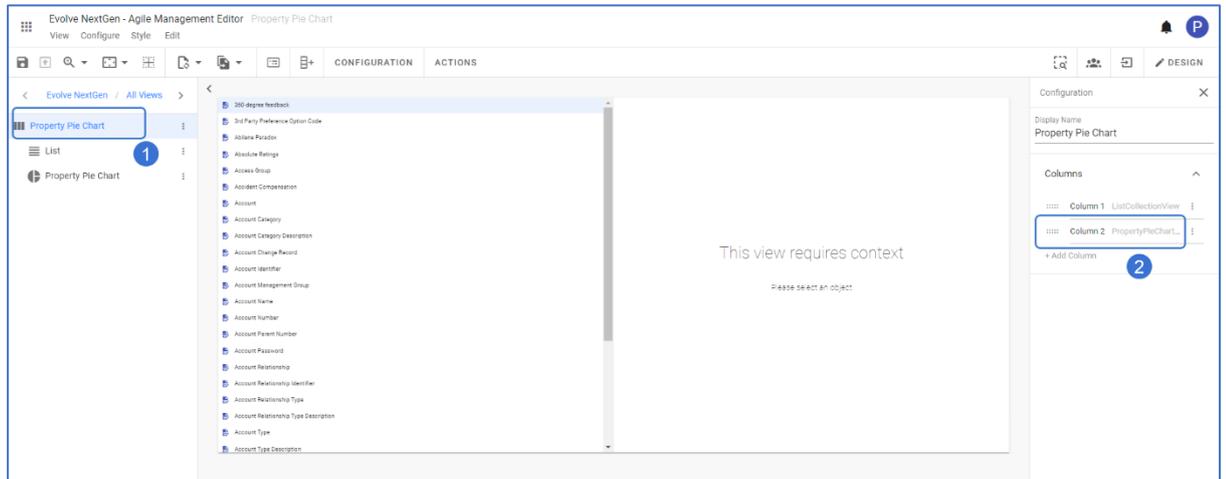

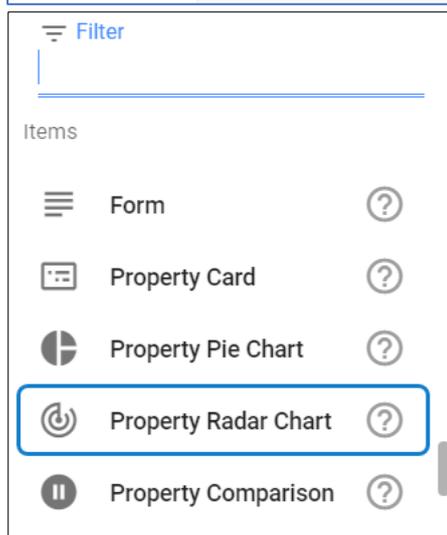
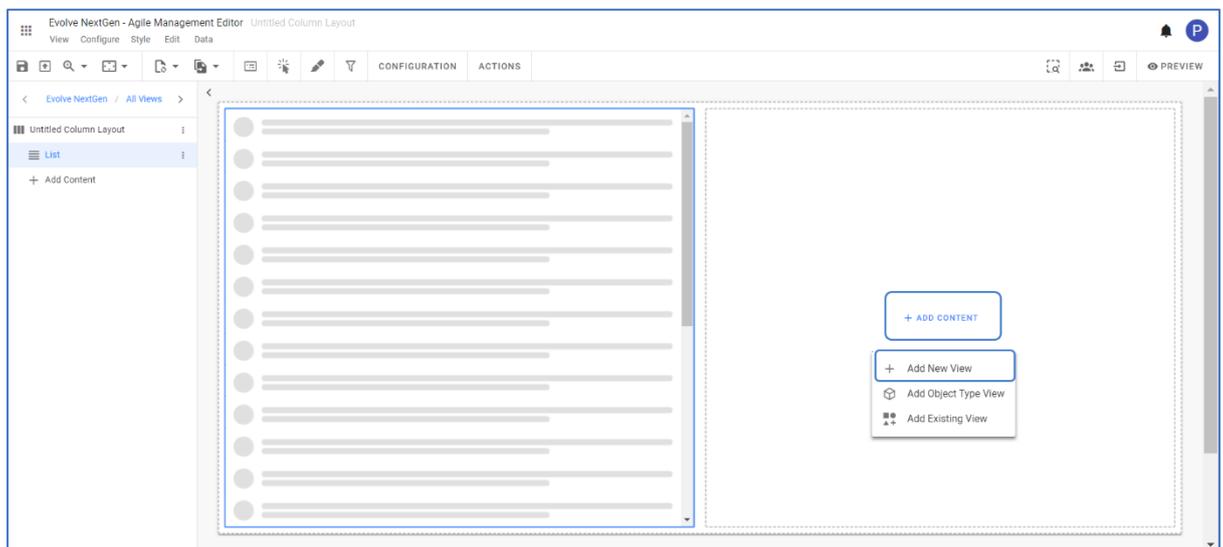


# Property Radar Chart

**Property Radar Chart** is useful for comparing multiple numeric attributes.

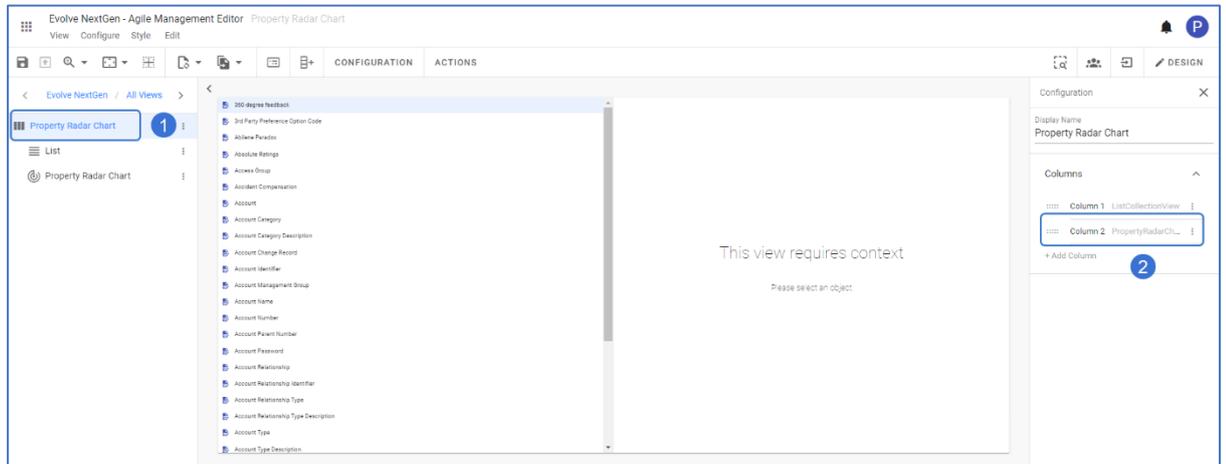

Click **Add Content > Add New View > Select Property Radar Chart**.

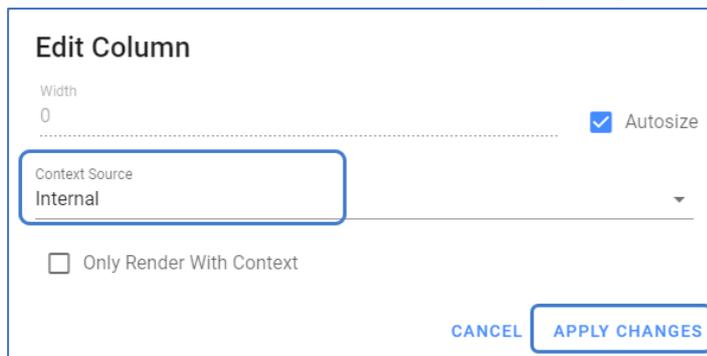


4. To pass the context from the source,

- Click on the title of the layout and then **Configuration** from the toolbar.

- Click **Context Source > Select Internal > Apply Changes**.

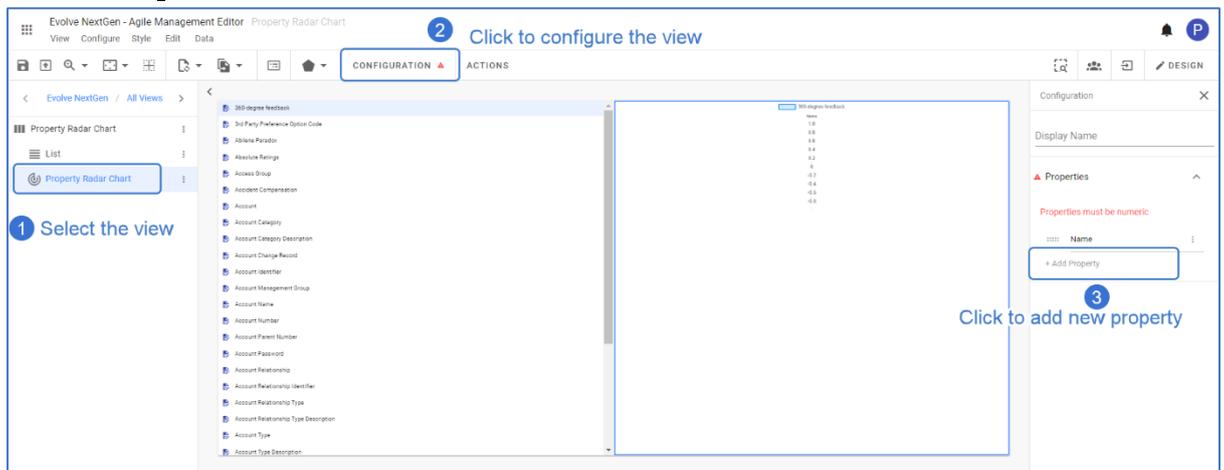

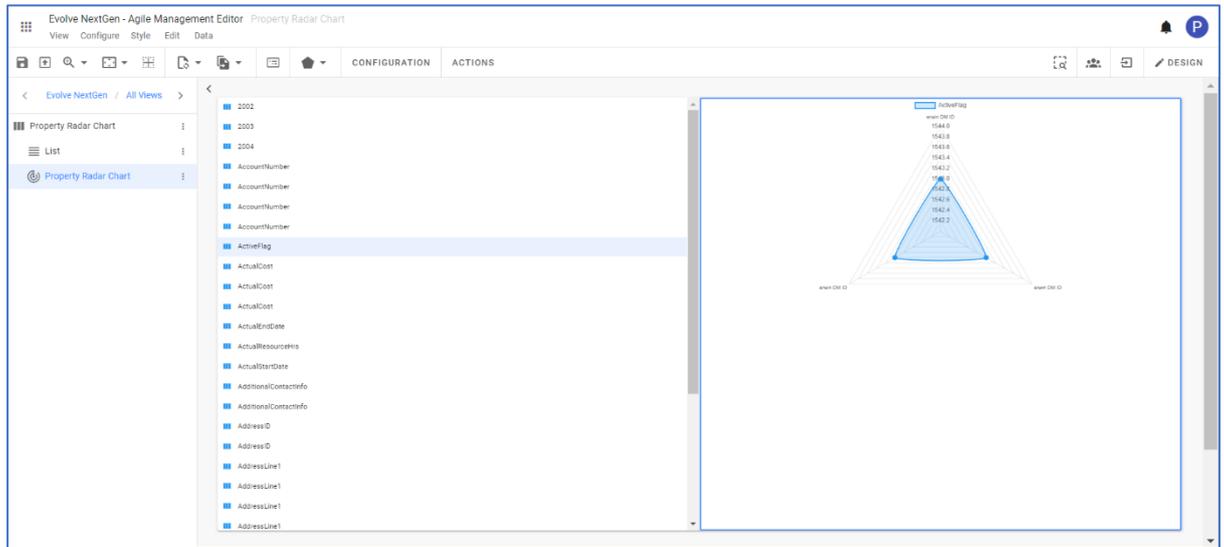

# Property Comparison

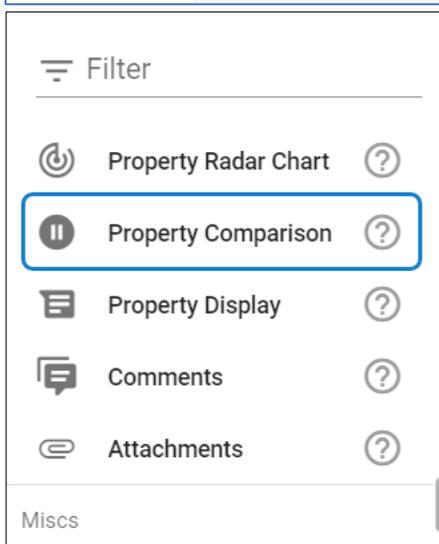
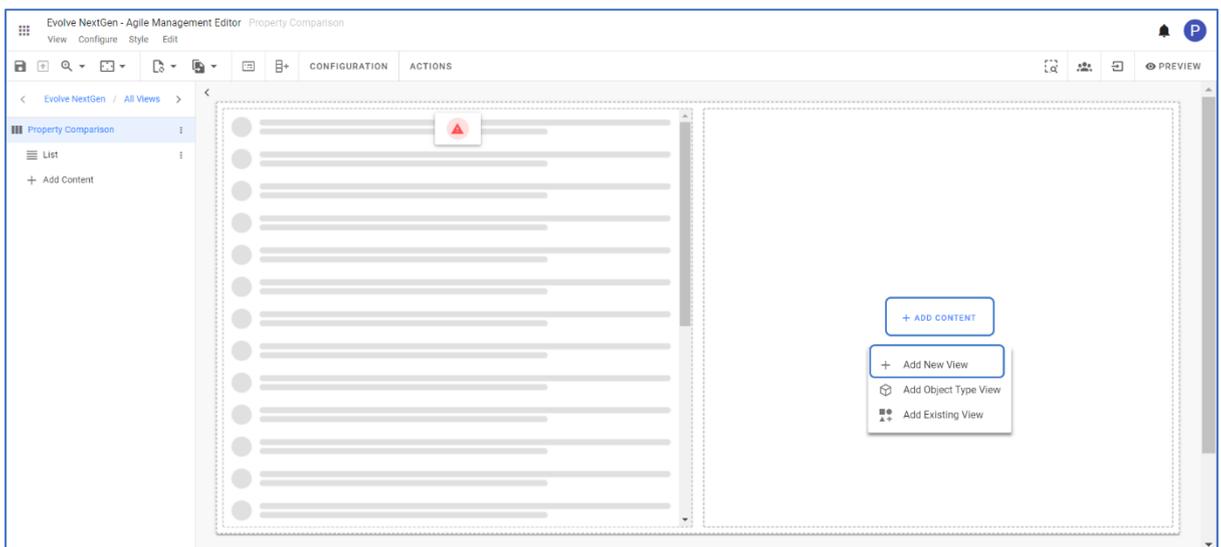

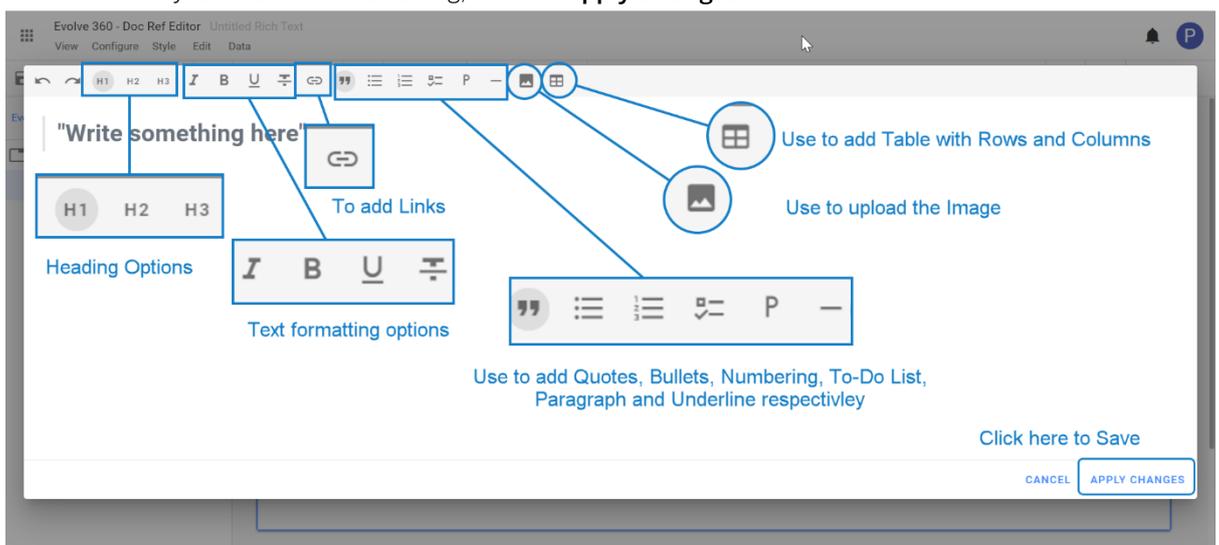
## Rich Text

  - Write the text in the space and can customize the text as you do in the word editor.
  - You can add **Links, Images** and can construct the **Table** by defining rows and columns.
  - When you finish with the editing, click on **Apply Changes**.

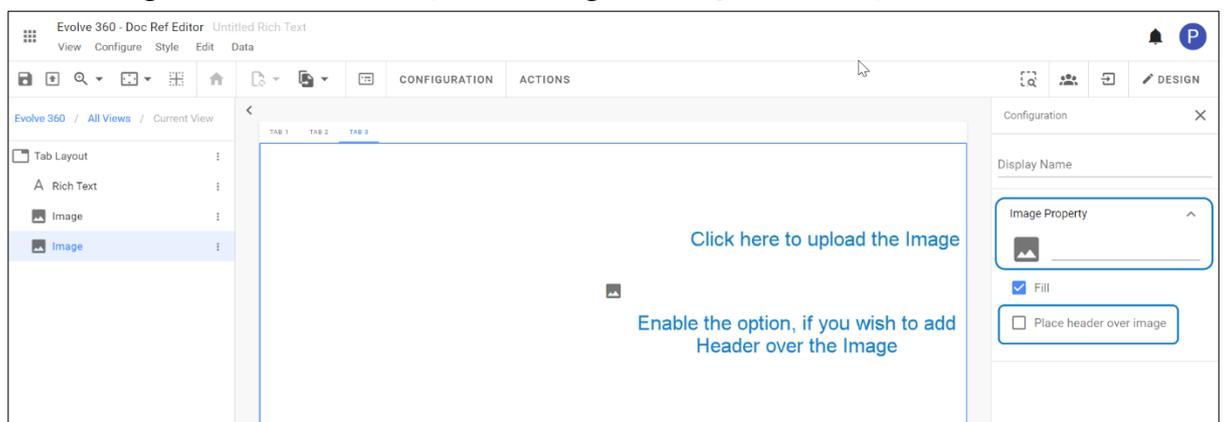
# Image

**Image View** allows to upload the images for use in an application.

Image works along with any layout and the properties of the image can be configured with the individual view type too.

To configure the Image,

1. Choose **Image** view type in any layout you wish.

# Customization of View

Customization of a view can be performed by applying **Filters, Events, Heatmaps, Overlay Filters, Actions, Headings**.

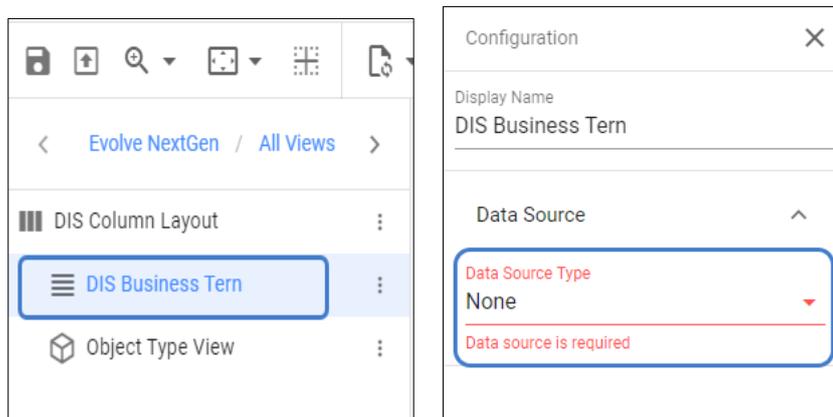
## Filters

**Filters** are applied while configuring the view to display the data, which can be applied in two ways. The first is defining the new set of filters using **Filter Criteria**, and the other is applying the already defined filter using the **Existing Filter**.

### Steps to apply Filter Criteria:

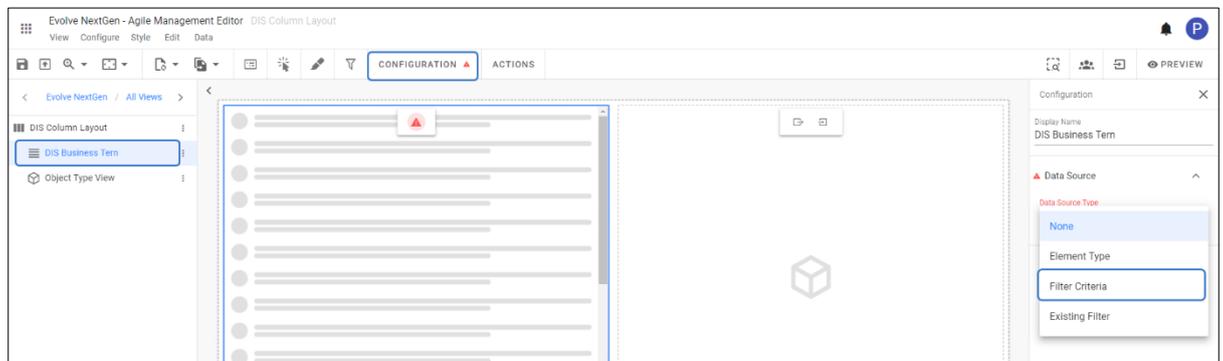
For instance, in a list view, **Filter Criteria** is applied to **Data Source Type** to extract the necessary list of items based on the **Object Type's Properties**.

1. Click on **view** under the **Layout**, go to **Configuration**, which appears on the pane's right side.



By default, **Data Source Type** will be **None**.

2. Select the **Filter Criteria** under the **Data Source Type**.

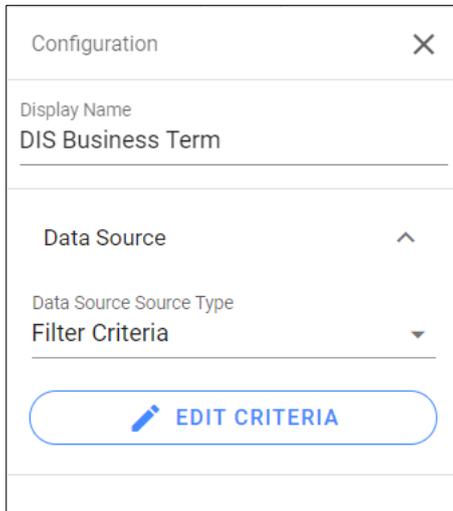


An option to edit will show up right after the selection.

Click on **Edit Criteria**.

Click on **Apply Changes** to save.

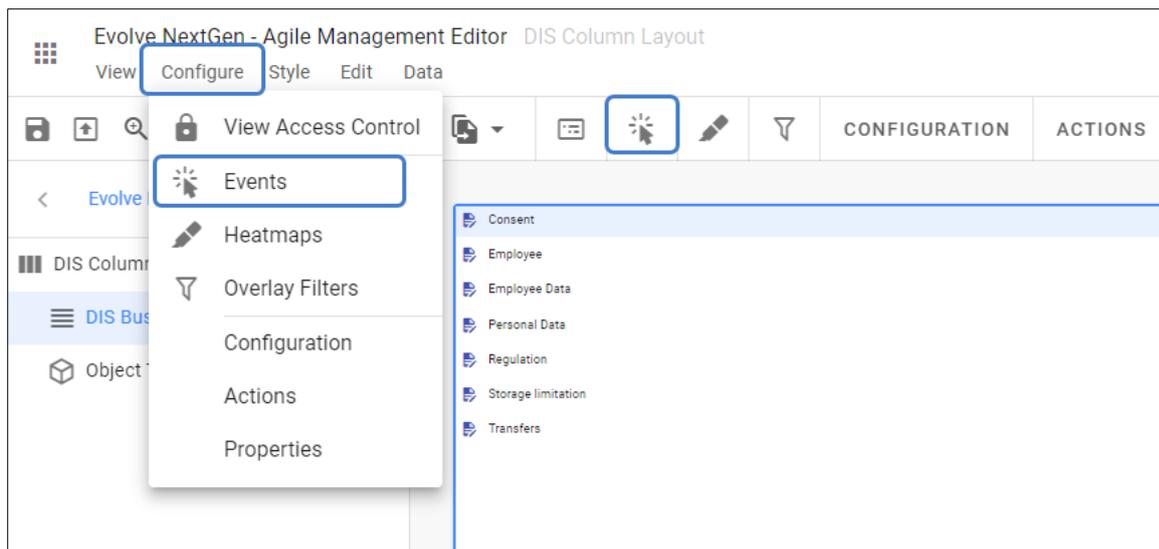


# Events

**Events** help the users define what happens and what view appears when the interact with an element in the view.

For example: Open a panel displaying the object type view if they click on a row in a table

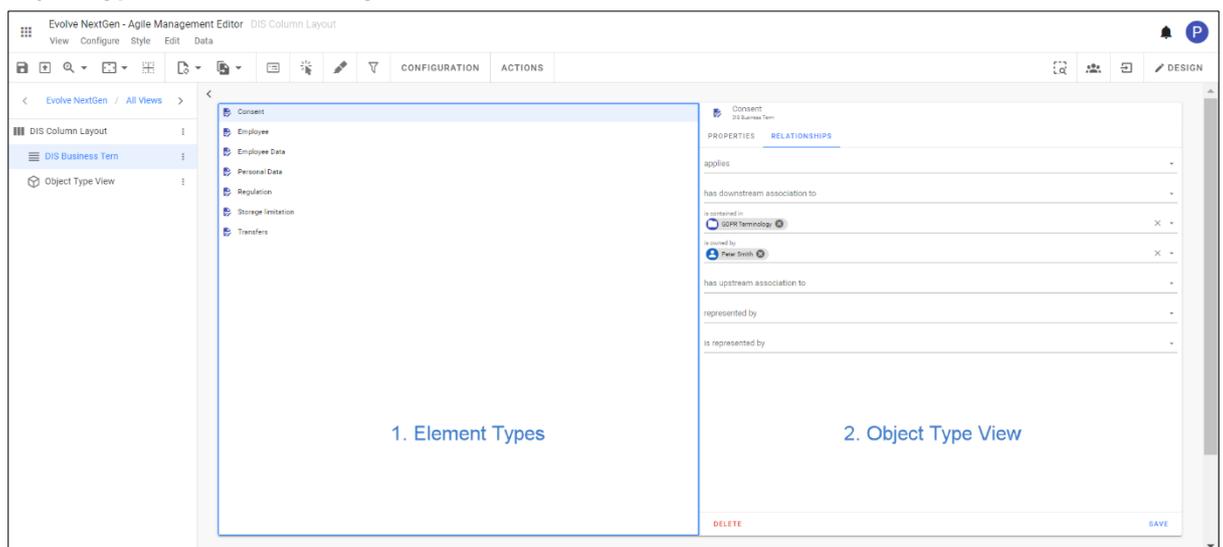
**Events** can be found under **Configure** tab or on the toolbar.



There are two types of behaviors for an Object Type.

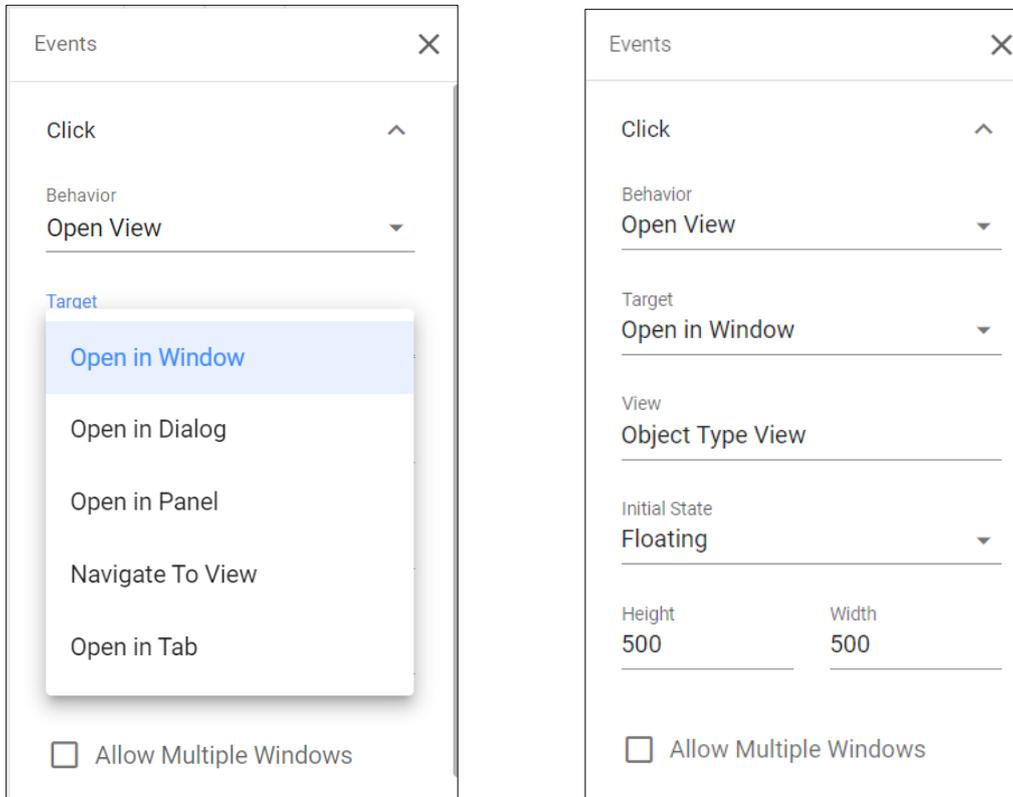
**1. Trigger Context** – is used to pass the **Object Type** selected to the other **view**.

E.g., In the below example, the **Element Type** defined passes the object and displays it in the **Object Type View** within the **Layout**.

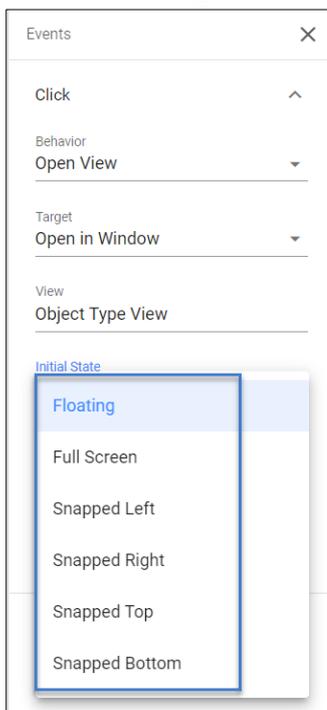


## 2. Open View – It opens the **Object Type View** in **Window, Dialog, Panel** and **Tab**.

Dimensions of the View can also be customized by giving the **Height** and **Width**.



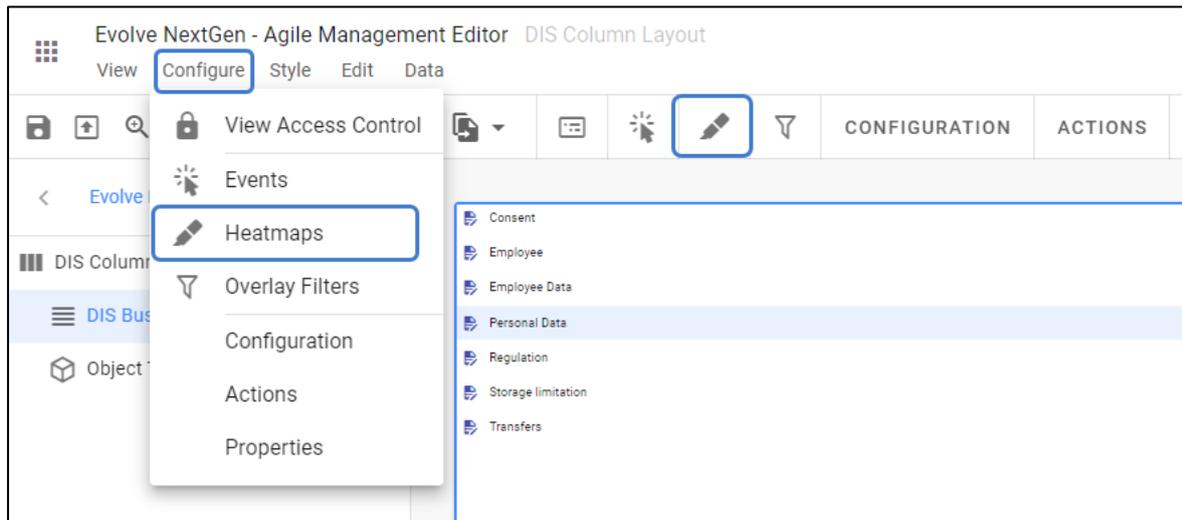
The **Initial State** of the View can be set in different ways, i.e., **Floating over the screen, in Full Screen, Snapping to the left, right, top and bottom**.



# Heatmaps

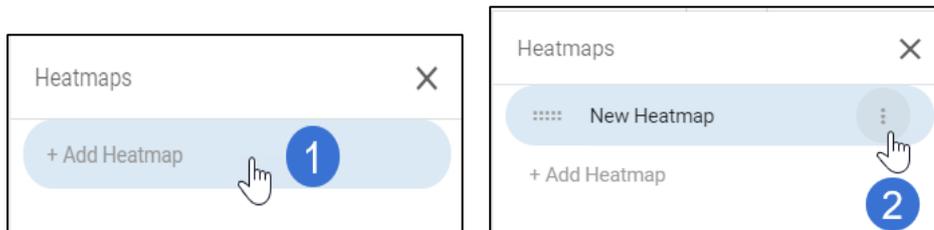
**Heatmaps** help to highlight the required information of the **Element Type**.

To add the **Heatmaps**, click on the  icon in the toolbar or find under the tab **Configure**.



A popup appears on the right side of the pane.

1. Click on **Add Heatmap**.
2. Click on three dots against the **New Heatmap**.



3. Click on **Edit**, a dialog box appears.  
Input the Label and choose **Filter Criteria**, then click on **Edit Criteria**.

Choose the Object Type and enter the properties of the object to display.

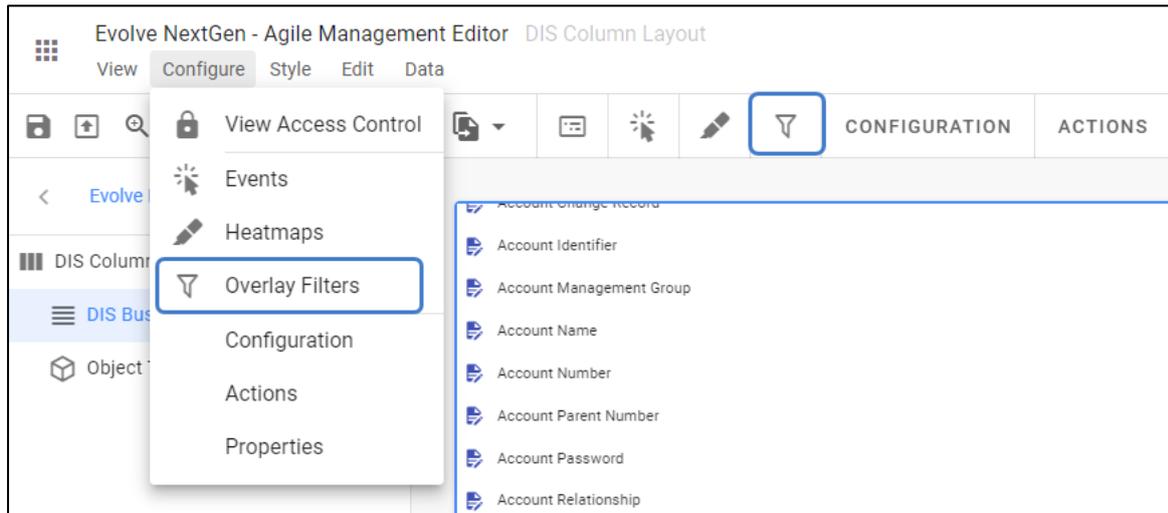

4. Applied **Heatmap** appears as a breadcrumb over the top of the view by highlighting the information.

# Overlay Filters

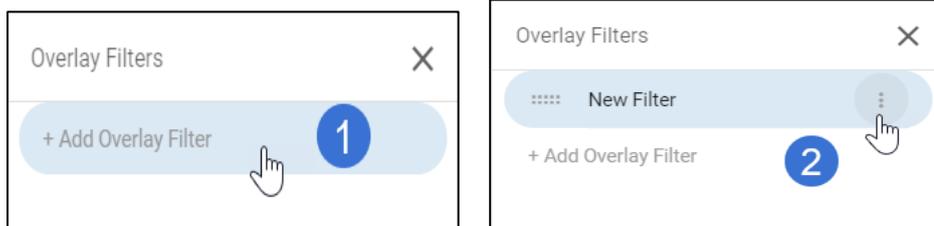

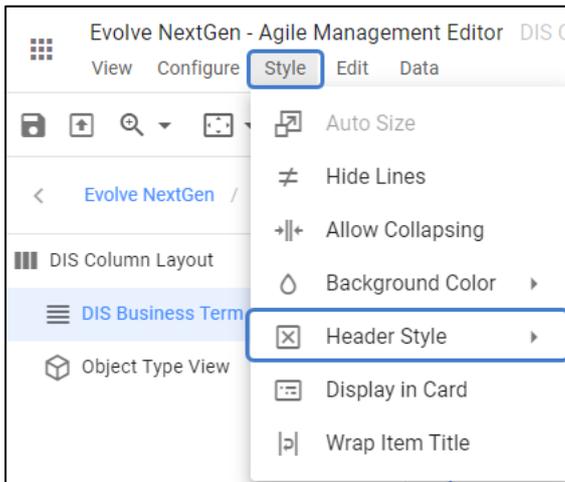

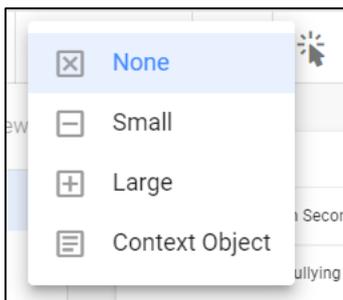
# Header Style

To add **Header Style** to the view,

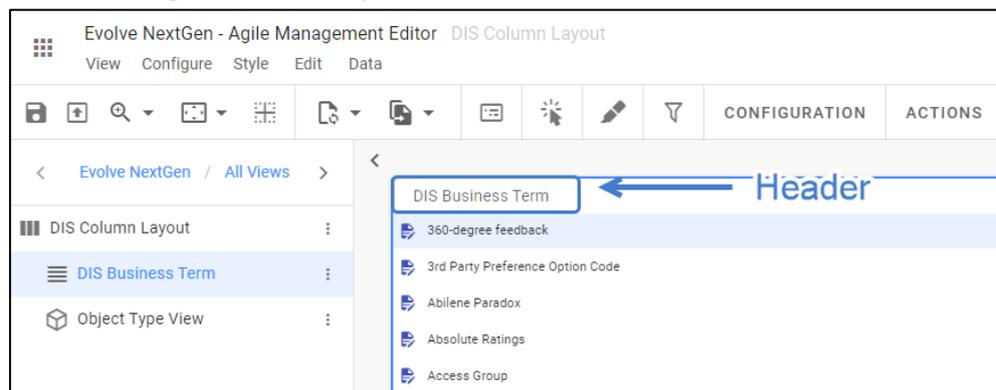
1. Go to **Style** tab on the toolbar, then select **Header Style**.



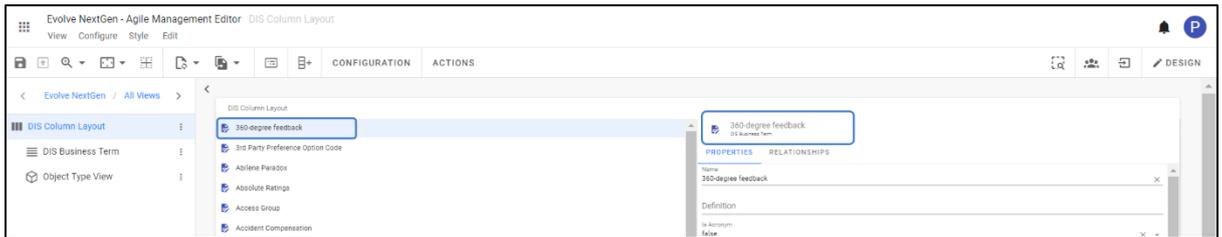

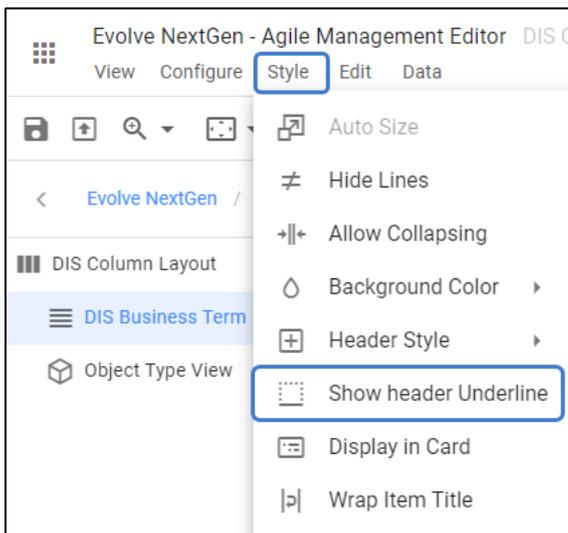


- **Context Object** is the style that renders the display name from the Element Source. **Context Object** style is typically used for the **Object Type View**.



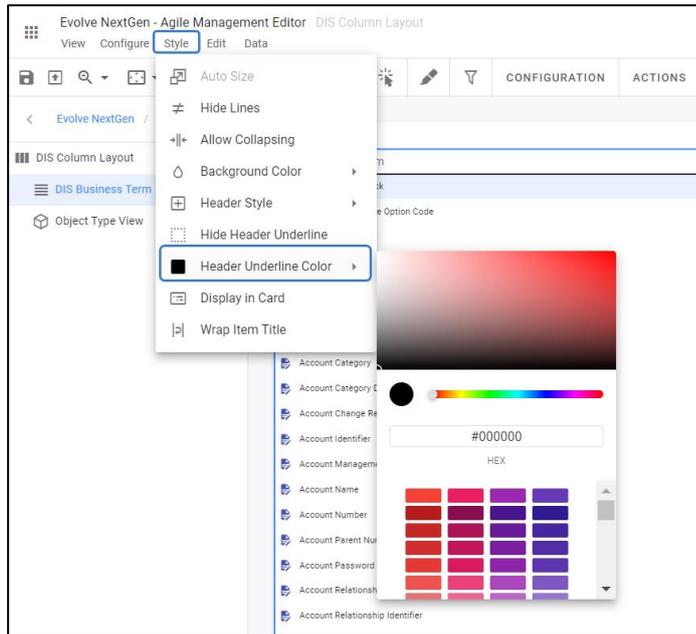

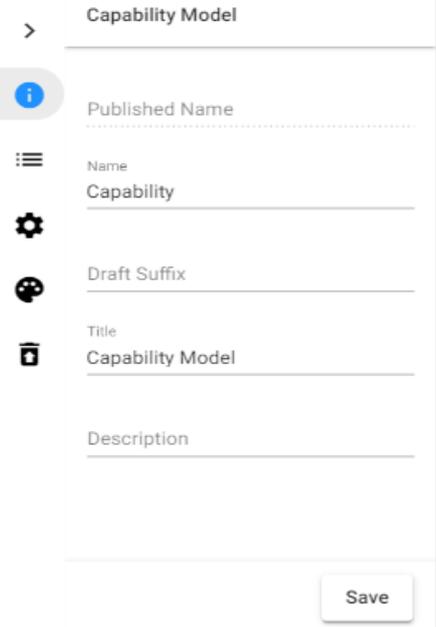
## Overview of Diagrammer

**Diagrammer** is used to both edit and create any Evolve Diagram online.



The different features within the Editor are detailed below:

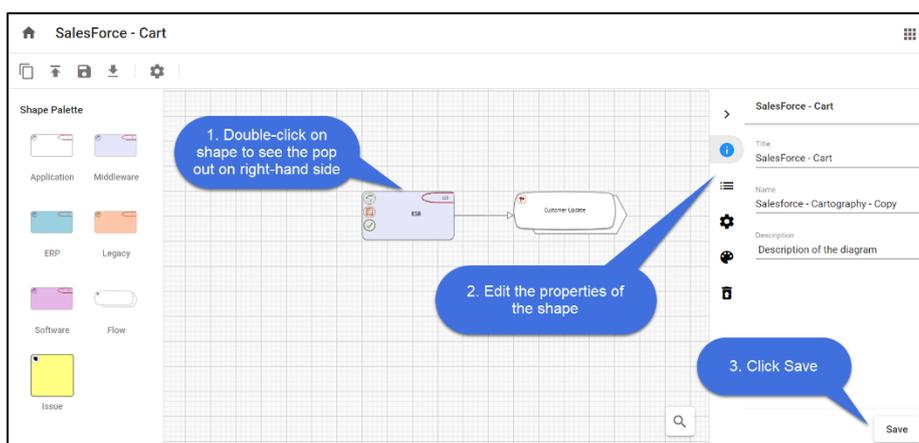

# Formatting Shapes in Diagrammer

## Adding Shapes, Connecting Lines to the Diagram, and Changing Properties

To add shapes to the diagram,

1. Drag and drop the required shape from the **Shape Palette**.
2. Double-click on the object shape to edit the **Title** and its **Properties**.
3. **Click Save**.



You can use a Connector to link two Shapes, indicating that there is a connection between the two shapes.

To add the connector between the shapes,

1. Select the first shape by clicking on it.
2. Click on one of the + symbols to add the connector and move your mouse pointer to the shape you would like to connect to.
3. Click on the shape to end the selection.
4. If there are multiple connection types between these kinds of objects, you will get a menu to choose the connection that is appropriate.

To Clear or Delete Shapes from the Diagram

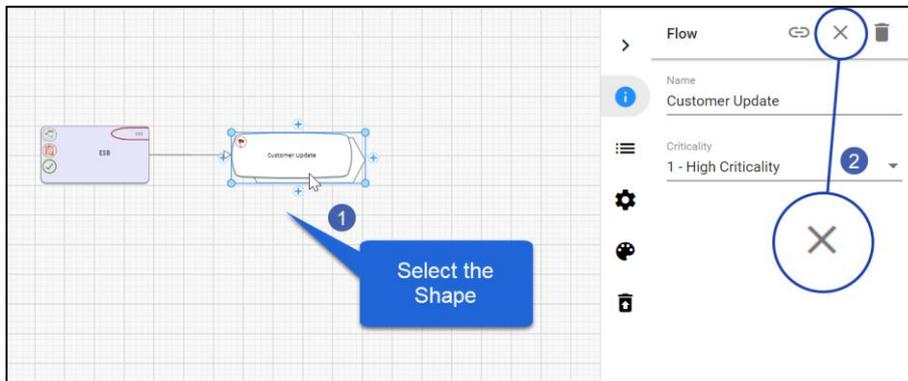
Object Shapes can be Cleared or Deleted from the diagram in two ways.

**To Clear a Shape:**

When you choose to **Clear** a shape, it removes the shape from the diagram, but it does not remove the object it represents from the model.

1. Select the shape you wish to **Clear**.

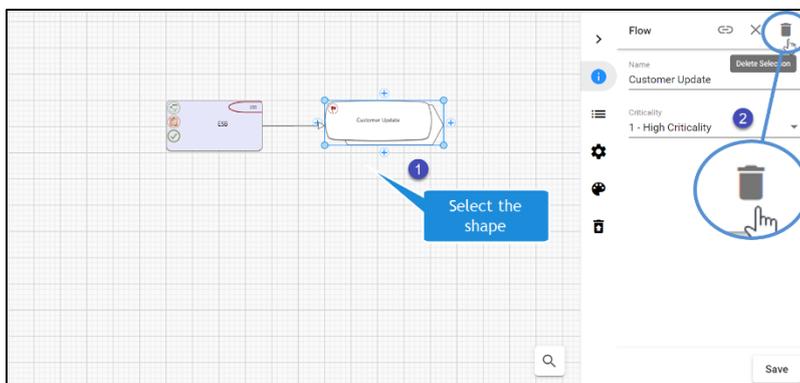
2. Click on  icon.



### To Delete a Shape:

When you choose to **Delete** a shape, it removes the shape from the diagram, and when published will remove the object representing from the model too.

1. Select the shape you wish to **Delete**.
2. Click on  icon.



**i** If a shape is deleted, any connector associated with the object shape also gets deleted.

**i** When object shapes are deleted using the **Delete** option, it adds the item to the Trash can icon called **Deleted Objects** on the right-hand pane.

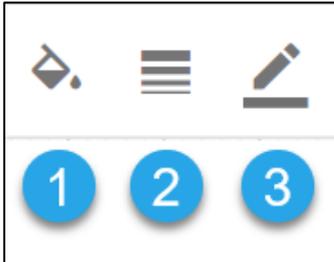

## Adding Background Colors and Borders to the Shapes

Every Shape from the Palette has a definite background color, border size, and border color.

You can format the shape by

1. **Background Color** of the shape.
2. **Border Size** to the shape.
3. **Border color** to the shape.



When object shapes are deleted using the **Delete** option, it adds the item to the Trash can icon. Some shapes may have **Region shapes** and **Region formatting** which overrides these styles such that the style options will not work.

Example: A shape may be set with color because of the “Category” of the object, i.e. the shape may be **Red** because it is a critical object (as defined in one of its properties).

## Aligning Shapes

Object shapes in the editor can be aligned using **Align Nodes** placed on the toolbar.



Object shapes can be aligned to the **Left**, **Right**, and **Center** horizontally, and also **Top**, **Bottom**, and **Center** vertically, which can also be evenly **Distributed Horizontally** or **Vertically**.

**Align Shapes**

Horizontal	Vertical	Distribute
→ ← Centre Align	⇅ Centre Align	↔ Distribute horizontally
← Left Align	↑ Top Align	⇅ Distribute vertically
→  Right Align	↓ Bottom Align	

**1** To Align shapes horizontally, multi-select the shapes and choose the alignment.
 **2** To Align shapes vertically, multi-select the shapes and choose the alignment.
 **3** Multi-select the shapes to distribute horizontally or vertically with even spaces between the shapes.

### Resizing Shapes to match others

In the **Diagrammer**, the object shape can be adjusted to the height and width of the other shape using **Resize Nodes**.



**Sizing**

- ⇅ Largest height
- ∨ Smallest height
- ⟷ Largest width
- ⟩⟹ Smallest width

The Size of one shape can be adjusted to the size of the other object shape with respect to the **Height** and **Width**.

---

## Move Shapes from Back and Front

In the diagram, if one shape is put on top of another, it may conceal the other.

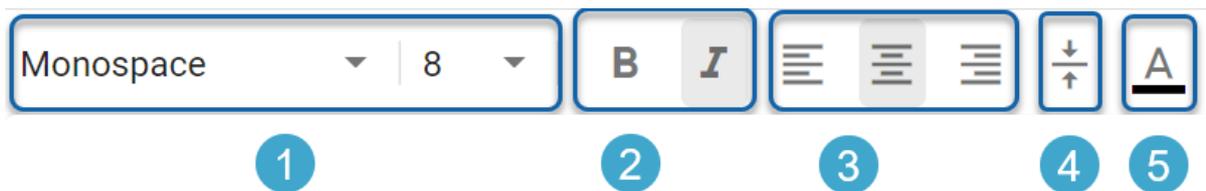
**Move To Back** and **Move To Front** buttons help to show/Hide the object shape.



## Text Formatting and Fonts

The Title of Object shapes can be formatted according to:

1. **Font** and its **Font Size**
2. Text in **Bold, and Italic**
3. Text alignment to **Left, Center, and Right.**
4. **Vertical Alignment.**
5. **Text Color.**



Some shapes may have **Region shapes** and **Region formatting** which overrides these styles such that the style options will not work.

Example: A shape may use a different property for the Title, that is defined in a region. This region's style cannot be overridden by Diagrammer

---

# General Operations in Diagrammer

Options that are generally available for any diagram in the canvas are:

1. Duplicate Draft
2. Publish Diagram
3. Download Diagram

## Duplicate Draft:

To duplicate the working draft of the diagram, click on **Duplicate Draft** on the toolbar.



By doing this, a copy of the draft will be created, and you will be taken immediately to the draft diagram.

The draft diagram will be associated with the originally published diagram, and on publishing will replace the same published diagram.



To create a separate published diagram, you should duplicate the published diagram instead

## Publish Diagram

To publish the diagram, click on **Publish Diagram** icon on the toolbar.



Before proceeding to **Publish** the diagram, make sure you don't have any incomplete items in To-Do list.

Once published, the draft diagram will be deleted, and the published diagram will be available in the application.

## Download Diagram

To download the diagram in the form of an image to your machine, click on **Download Diagram** on the toolbar.



## Diagram Settings

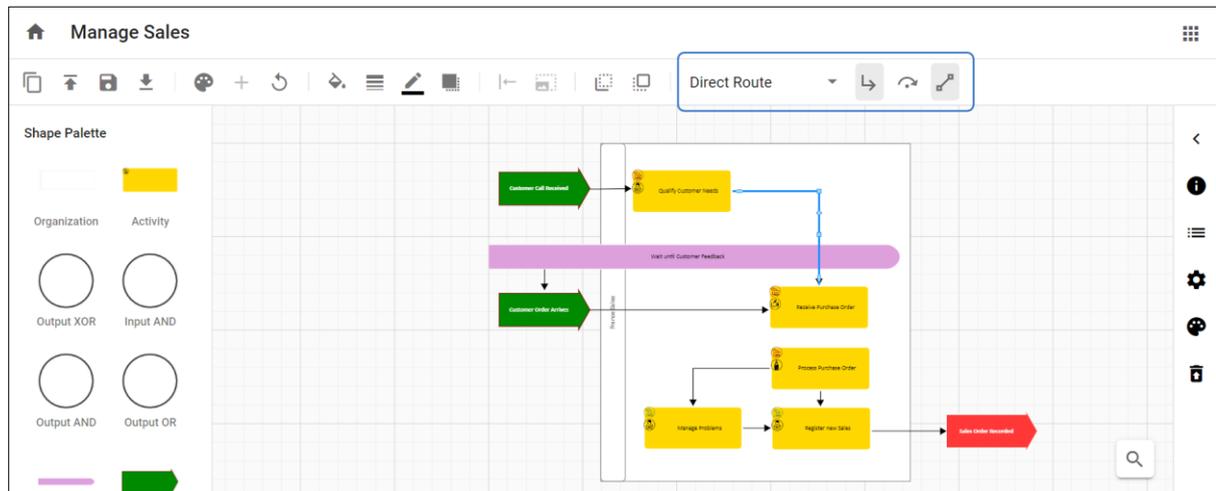
To apply the settings related to the diagram **Grid**, **Animation** and **Guiding lines** in the editor, click on **Diagram Settings** on the toolbar.



You will see a panel popped up on the right-side of the screen to work on settings.

# Working with Connector Lines

The lines which associate the two objects in the diagram are called **Connector Lines**.



Double-click on the line, then the options for connector lines are shown on the toolbar.



Lines can be applied in two ways:

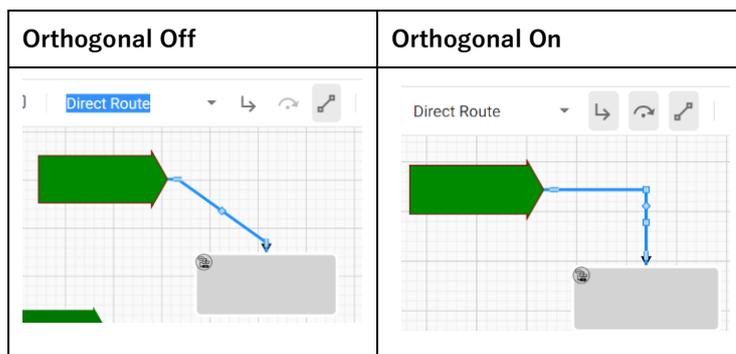
1. **Direct Route** – connects the objects using the shortest path.
2. **Avoid Route** – connects the objects avoiding the other objects in the diagram structure.

---

Lines are of three types are available to connect the objects:

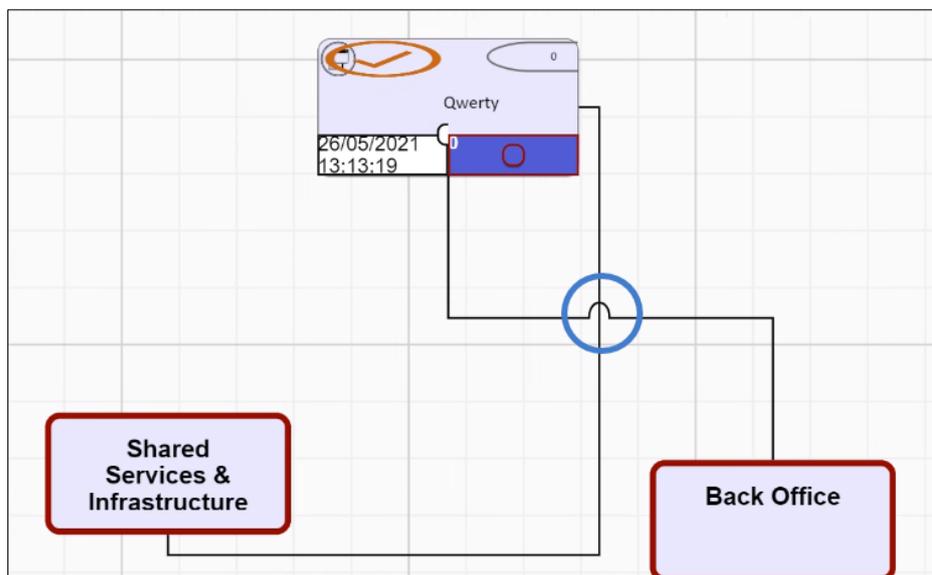
1. **Orthogonal Lines** – **Orthogonal Lines** are when the line appears with right angles in order to connect the two objects when it cannot be drawn horizontally or vertically.

*This line is available only under Direct Route and will be disabled for Avoid Route.*



2. **Jump Lines** – **Jump Lines** are when one connecting line passes over another, and it appears with an arc over it.

This button is used in conjunction with the orthogonal lines button. If an orthogonal line is off for a particular line, then the jump line button is disabled.



Jump is a property of an individual line, so if the lines cross and neither have the jump property then they look like straight lines passing through one another. Jump lines will be seen if both lines have jump property.

3. **Lock/Unlock Link Port** – Link Ports can be Locked or Unlocked. To lock them, either press the button or move the connection point (port) of the line, around the shape. When you select a location

---

to port the line to the shape, it will become locked. If you want the Diagrammer to automatically reposition the port, select the line, and press the unlock button, to release the lock.

Locking the link ports helps to keep the specific connection point when the shapes are moved around the canvas.

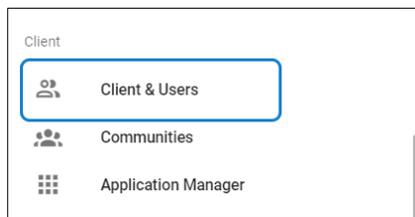
# Administration

## Client and User Settings

**Client & Users** helps to add new user, license management, and to register requests.

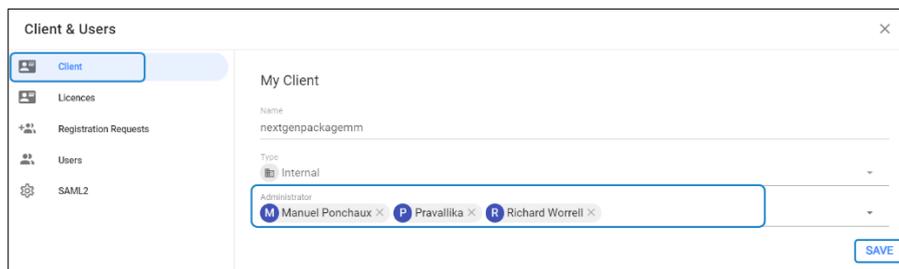
**i** You need to have administrator rights to perform any action related to users.

To set the settings, go to profile icon on the top right corner, select **Client & Users**.

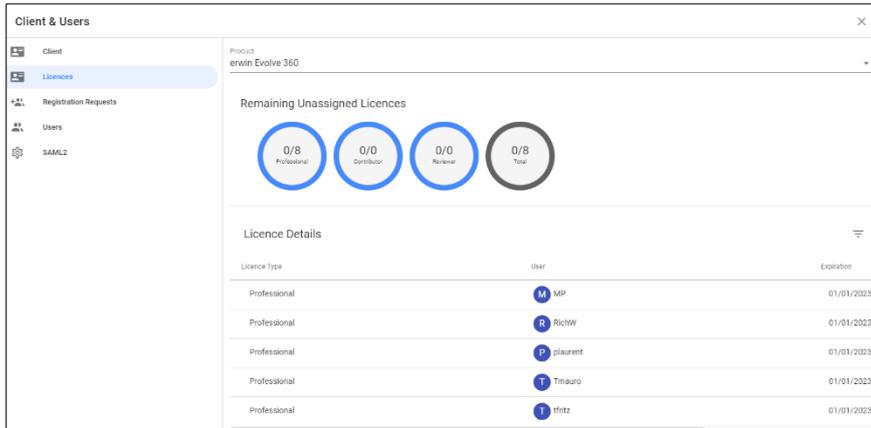


1. To set the existing user with **Administrator** rights,

Go to **Client > Administrator > Save**



2. Under License tab, you can view your available Licenses for the product. You can assign licenses to registered users by clicking on **User** in the table and to remove the license for the assigned user, click on cross against the user on selection.



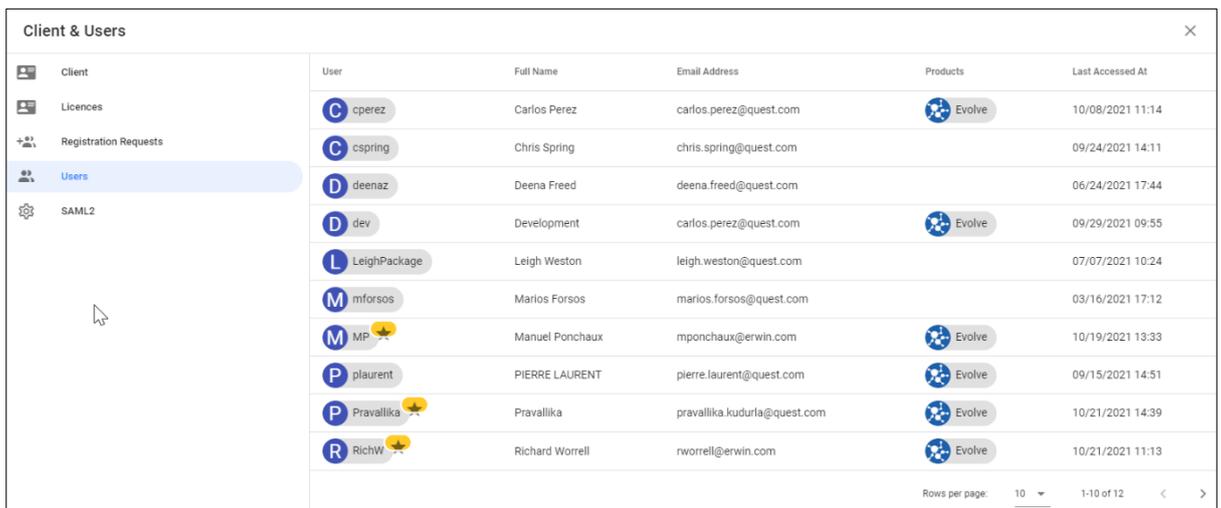
3. **Registration Requests** tab helps to register the new users.

Click on + symbol on top of the table, enter the **Email address** of the user and click on **Save**.



Soon after, user will receive a **Registration Request email** saying that an account has been created and asks to **Activate Account**.

4. **Users** display the whole list of registered users with the license information.

# Communities

**Communities** are a defined set of users identified as group of individuals or teams, that work together to achieve a common goal.

By default, an object will not have any communities and therefore visible to all users.

In **Evolve 360, Communities** are of two types. These community types control the access of communities to concepts within the platform.

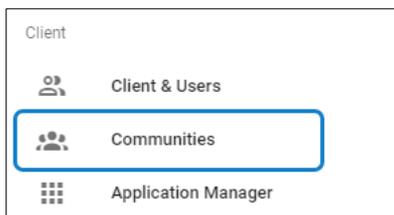
- **Public** – visible to every user
- **Private** – visible only to those within it and will be hidden from users who is not a member

## How to create a new Community?

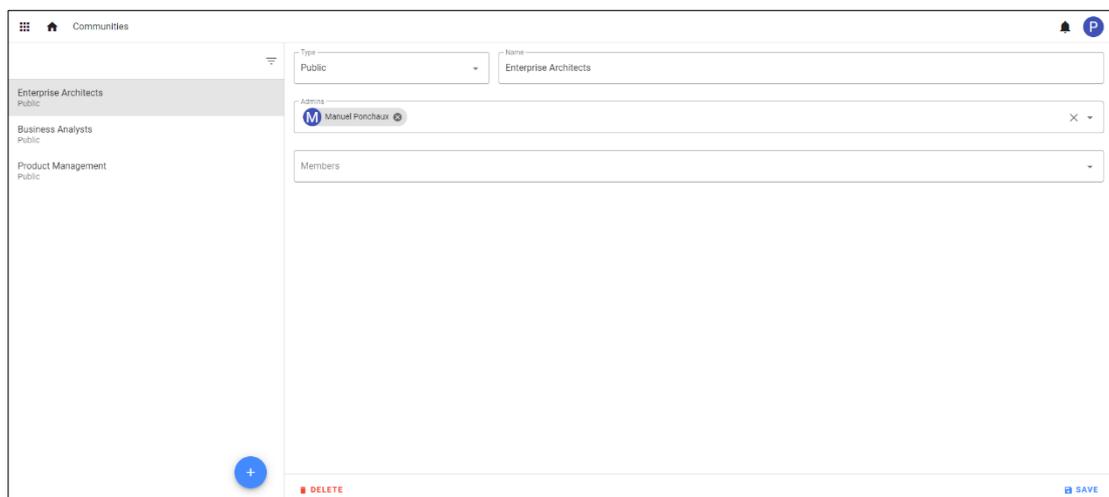
**i** | A user with administration rights will only have a privilege to create a community.

To create a new **Community**,

1. Go to profile and then select **Communities**.



2. A screen appears with the list of communities on the left-hand side and its details on the right-hand side upon selection of community.





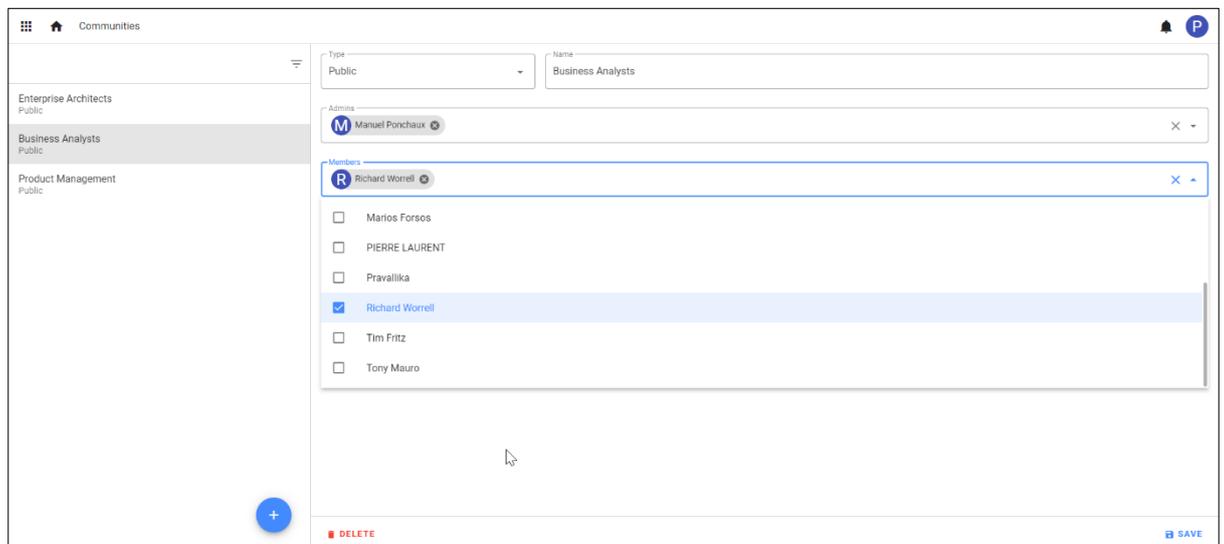
3. To create a new community, click on  button at the bottom of left-hand side screen.
4. Enter the details in the form on the right-hand side of the screen.
  - i. Set the Community to be either Public or Private.
  - ii. Enter the Name for your new community.
  - iii. Choose an Administrator from the list of users.
  - iv. Select the members you wish to be a part of community.

5. Click on **Save** to finish.

# How to Add/Remove users to an existing Community?

1. Go to profile and then **Communities**.
2. Select the community from the list appeared on the left-hand side of the screen, then its details will be shown on the right-hand of the screen.
3. Click on **Members**, check the box against the name of the user you wish to add or uncheck the box to remove the user.



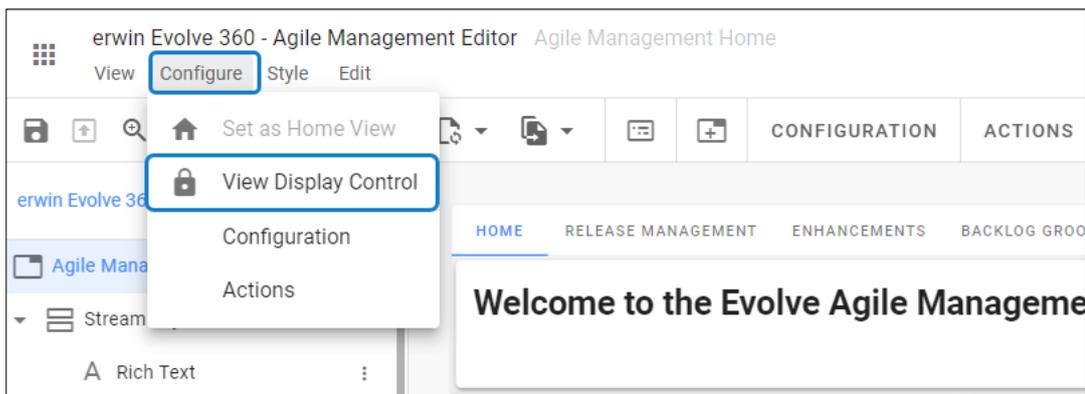

# How to restrict a view to single Community or set of Communities?

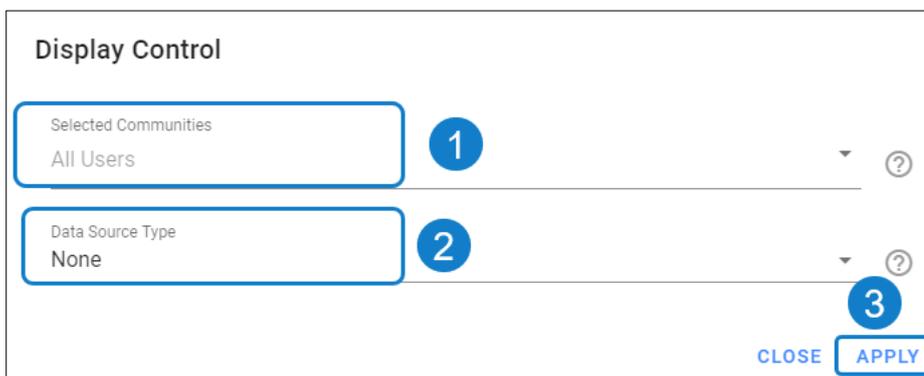
An administrator has the access to restrict a view to a certain community or set of communities.

To restrict a view,

1. Go to application editor of the view you wish to restrict.
2. Go Configure and select View Display Control.



3. A screen will be shown up with the details.
  - i. Select the **Communities** you wish to restrict the view to by clicking on their names.
  - ii. Select the **Data Source** to include with the context.
  - iii. Click on **Apply**.



**i** If no **Communities** are selected, it displays to all users, or it displays only to the selected **communities**.  
A data source of **None** mean that will always display. When a data source is selected it only displays when the context item is included in this data source.

# Import/ Export

**Import** and **Export** are the bulk operations deals with your application data.

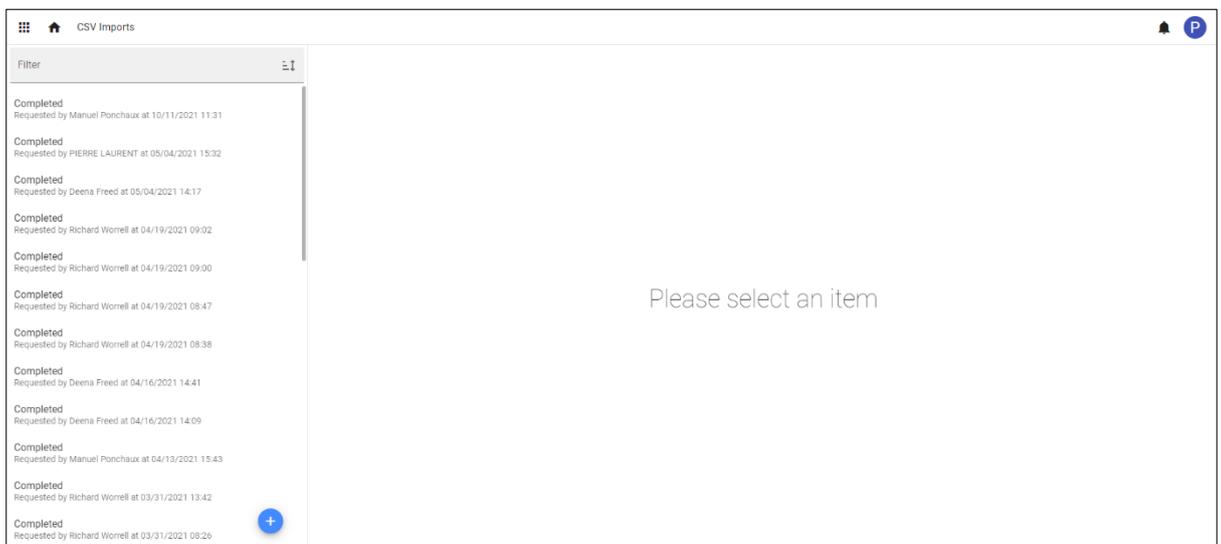
## Import

To Import the data,

1. Go to **Profile**, click on **CSV Import**.



2. A screen appears with the list of imports, and their status.



3. To create a new **Import**, click on  button from the bottom of left-hand side of the screen.
4. Enter the fields in the screen that is presented.
  - i. Select **Column** and **Value Delimiter**.
  - ii. Either drag your file into the selection box or **Click to Upload** the file.
5. Once the file uploaded, it is added to the import queue.

You are then able to track the progress of the import and can view logs after completion. You can also see a report of what errors have occurred.



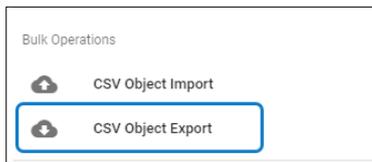
Import operation requires a file with the specific format. Make sure you have that format before importing the file.

To Export the data,

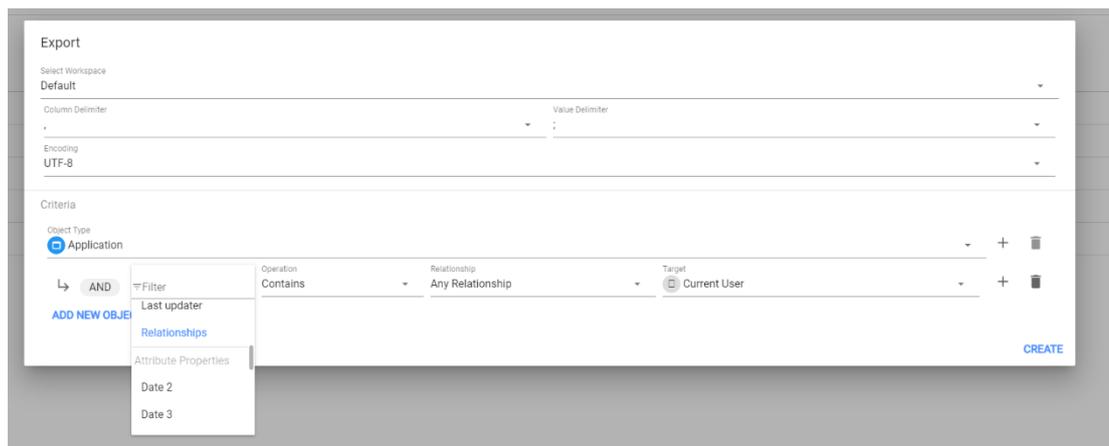
1. Go to Profile, click on **CSV Export**.

3. To create a new **Export**, click on **+** button from the bottom right corner of the screen.
4. Enter the fields in the screen that is presented.
  - iii. Select **Column** and **Value Delimiter**.
  - iv. Select your **Object Type**.
  - v. Click on **Create**.



5. You will receive an email after successful export.
