# Metalogix Sensitive Content Manager

Metalogix Sensitive Content Manager (SCM) provides a reliable, accurate and flexible solution for detecting sensitive information such as Personally Identifiable Information (PII), Protected Health Information (PHI) and Payment Card Industry (PCI) in English, German, Spanish, Italian, French and Portuguese, within enterprise content management systems.

This guide contains instructions for the administration of Sensitive Content Manager.

## Integration with Metalogix ControlPoint and Microsoft SharePoint

SCM can leverage the existing security, compliance and administration capabilities of Metalogix ControlPoint to enforce policies using the full range of Microsoft SharePoint's permissions management, auditing and user activity reporting. With on-demand scanning, administrators can flag specific libraries, sites, or site collections for content discovery, or use real-time content shield by analyzing files as they are created, modified, moved, or destroyed. The combination of SCM and Metalogix ControlPoint offers a powerful Data Loss Prevention (DLP) solution that uses customizable and intelligent scanning subsystems to identify, track, and secure documents. This ensures a more robust level of information governance inside increasingly complex enterprise environments.

## Integration with Metalogix Essentials

Essentials and SCM together allow a customer to selectively migrate file-share content based on the sensitive nature of the content after analysis with SCM.

## SCM Architecture

Metalogix SCM uses a microservices architecture that is comprised of several services that can be deployed on a single server or distributed across several servers. These services work together to analyze documents using regular expressions and machine learning. The SCM components are described below:

### SCM Databases

Each service has its own database which together form the SCM Databases and represent the central repository for the configuration, analysis results and operational metrics of the Metalogix SCM.

## Service Bus

Metalogix SCM uses RabbitMQ as the service bus. It provides the intelligent message routing, event queuing and sequencing needed by SCM to analyze the files.

## SCM Services (IIS)

- **Admin Portal** - The *SCMAdminPortal* service manages the SCM Administration Center.
- **Admin Services** - These are back-end services that feed information about other services to the SCM Administration Center.
  - *SCMAdminService* is used for license management, monitoring the system health and other administrative operations of SCM.
  - *SCMAdminService-Analytics*
  - *SCMAdminService-Notifications*
  - *SCMAdminService-Profiles*
  - *SCMAdminService-Scans*
  - *SCMAdminService-Subquestions*
- **File Upload Service** - When integrated with Metalogix ControlPoint, the *SCMFileUploadService* receives the requests to analyze one or more files. It stores these files and submits a request to the queue to analyze these files.
- **Profile Service** - A profile is a named collection of content search and analysis guidelines. Each profile is made up of sub-questions, weights and file thresholds. The *SCMProfileService* serves the profiles that are needed for content analysis.
- **Result Service** - When integrated with Metalogix ControlPoint, a REST API call requests the *SCMResultsService* to return the metrics and results of the files that were analyzed by the Analysis Service. Results are kept for a limited period.
- **Subquestion Service** - A sub-question is a search term used to identify a specific kind of sensitive content. The *SCMSubquestionService* serves the entire collection of sub-questions available for use within profiles.
- **Scan Service** - The process of analyzing files in a file-share and the generated report is called a *scan*. The *SCMScanService* allows you to submit, cancel or delete scans, and serves metadata about running scans and scan reports.
- **Analytics Service** - The *SCMAnalyticsService* collects and stores data about analysis throughput. Collected data supports the dashboard experience and is only kept for a limited period.
- **Notification Service** - The *SCMNotificationService* provides live-updates for scan progress, health and notifications within the SCM Administration Center.

## SCM Services (Windows)

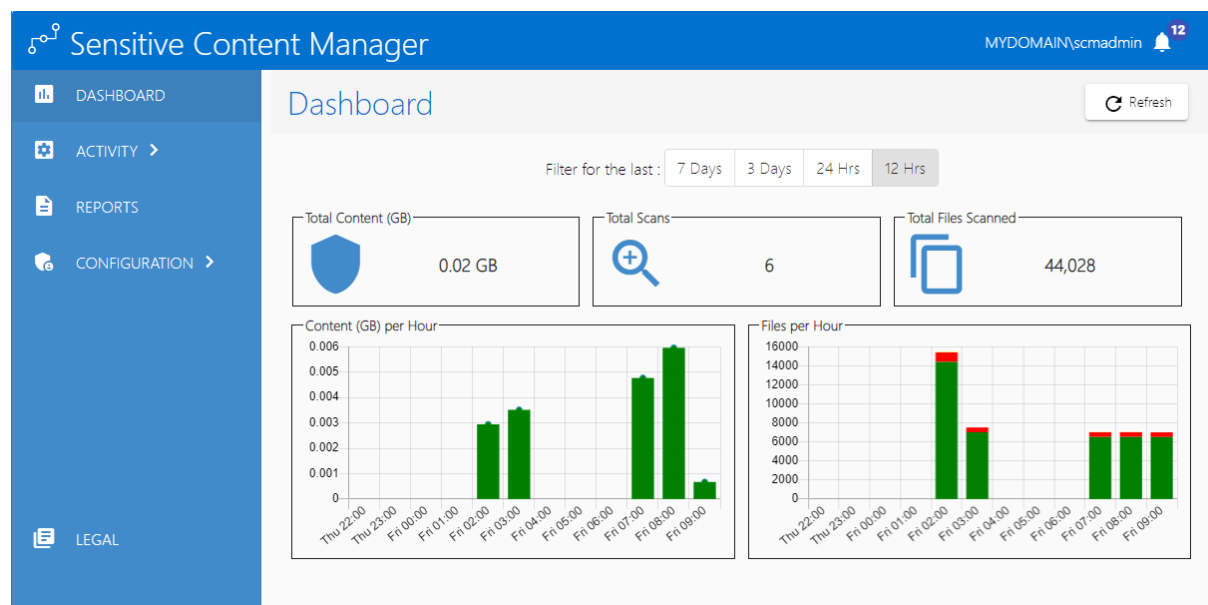
- **Document Routing Service** - When files are uploaded for analysis, they are stored in a specific *temporary folder* on the SCM Server. The *Metalogix SCM Document Routing Service* inspects each file from the folder to check whether these files are single files or complex files like compressed files or emails with attachments. Since only single files can be analyzed, this service submits complex files to the **Archive Extraction Service** to extract individual files for analysis. You can analyze the following file types: *Compressed files, Microsoft Office Files, Open Document Text, Portable Document Format, Rich Text Format, and Text Document*.
- **Archive Extraction Service** - When complex files are submitted for analysis, the *Metalogix SCM Extraction Service* extracts individual files from the file set.
- **Document Processing Service** - When single files are ready for analysis the *Metalogix SCM Document Processing Service* extracts the content from the files.
- **Analysis Service** - The *Metalogix SCM Analysis Service* analyzes the content in each file using regular expressions and machine learning technology. All files are permanently deleted from the *temporary folder* when the analysis is completed.
- **Crawler Service** - The *Metalogix SCM Crawler Service* inspects the contents of a file-share and the sub-folder hierarchy for supported files that are submitted for analysis.

## SCM Administration Center

The SCM Administration Center provides an overview of the scan results and lets administrators manage licenses, monitor the system health, and work with system logs to analyze the health of services with greater granularity.



## Steps to open the SCM Administration Center

1. Log in to the SCM Server.
2. Double-click the desktop shortcut to open the SCM Administration Center. You can also enter the URL directly in a browser. To get the URL for your own installation see [Steps to get the URL for the SCM Administration Center](#).
3. In the *Sign in* dialog that opens, enter the credentials of the SCM Administrator.

4. Click **Sign In**. The *Dashboard* page opens by default.
5. You can navigate to any administration feature accessible with your license.

# Dashboard

The Dashboard is the default page that opens when you log in to the SCM Administration Center. It provides a snapshot of the scan results over a pre-selected period and helps you to inspect the scans in greater detail.

## Refreshing the dashboard data

Since the Dashboard presents a snapshot of the scans, you must click Refresh to update the snapshot to view the performance of any scans that are in progress.

## Dashboard filters

The Dashboard provides four preset filters to present data about past and present scans. Click any preset filter to get the data for that period.

**7 Days** - presents scan data from the scans that started within the last seven days. This is the default selection.

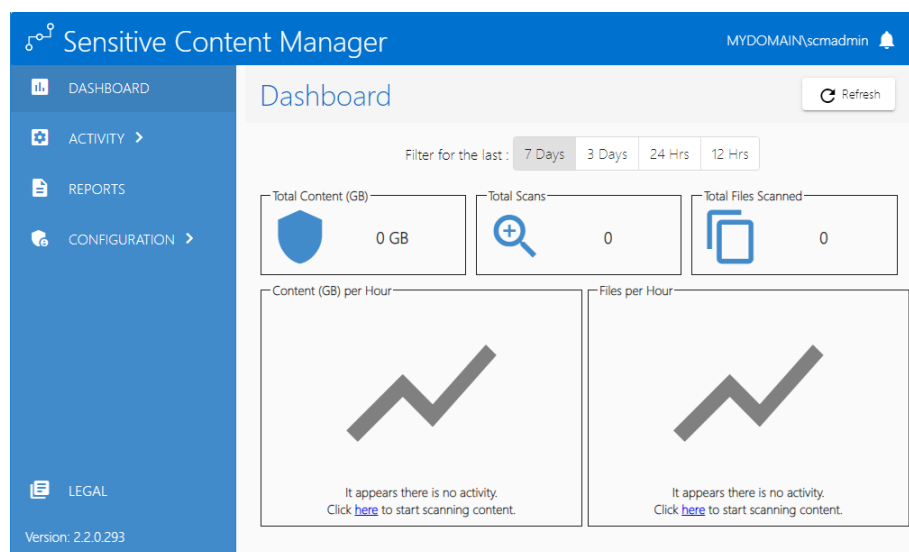
**3 Days** - presents scan data from the scans that started within the last three days.

**24 Hrs** - presents scan data from the scans that started within the last 24 hours.

**12Hrs** - presents scan data from the scans that started within the last 12 hours.



**NOTE:** If there are no scans that are in progress or completed within the period filter that you select, you will see empty panels in the Dashboard.



Click the hyperlink in the line **Click here to start scanning content** to submit a scan report and start a scan.



## Dashboard panels

There are five panels on the Dashboard as described below:

### Total Content (GB)

This panel displays the latest snapshot of the total size of data (in GB) processed within the period selected from the filter.

### Total Scans

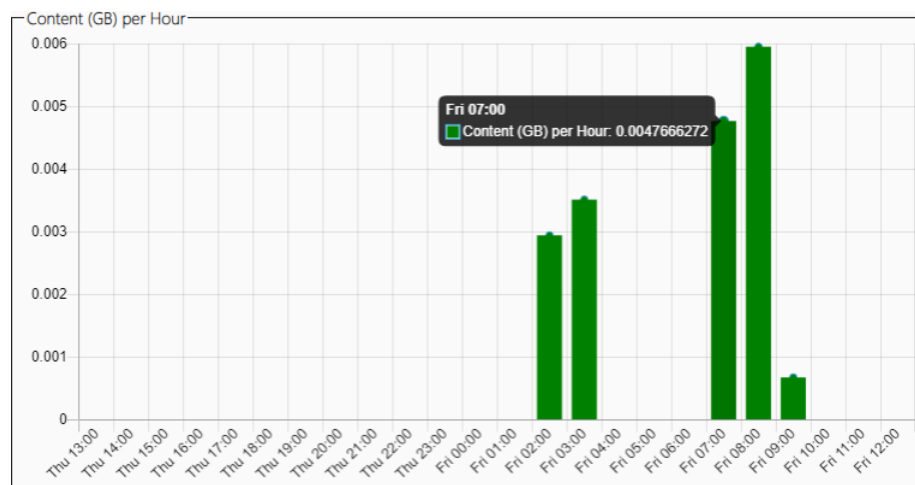
This panel displays the latest snapshot of the number of scans that started within the period selected from the filter. When the snapshot is taken, the scans could be in one of the following states: *In Progress*, *Canceled*, *Canceled*, or *Completed*.

### Total Files Scanned

This panel displays the latest snapshot of the total number of scanned files within the period selected from the filter.

### Content (GB) per Hour

This chart displays the latest snapshot of the total size of the data (in GB) processed per hour within the period selected from the filter. A line chart is displayed if the period filter is either **7 Days** or **3 Days**. A bar chart is displayed if the period filter selected is either **24 Hrs** or **12 Hrs**. When you hover your mouse over a line or bar, the **Content (GB) per hour** parameter is displayed.

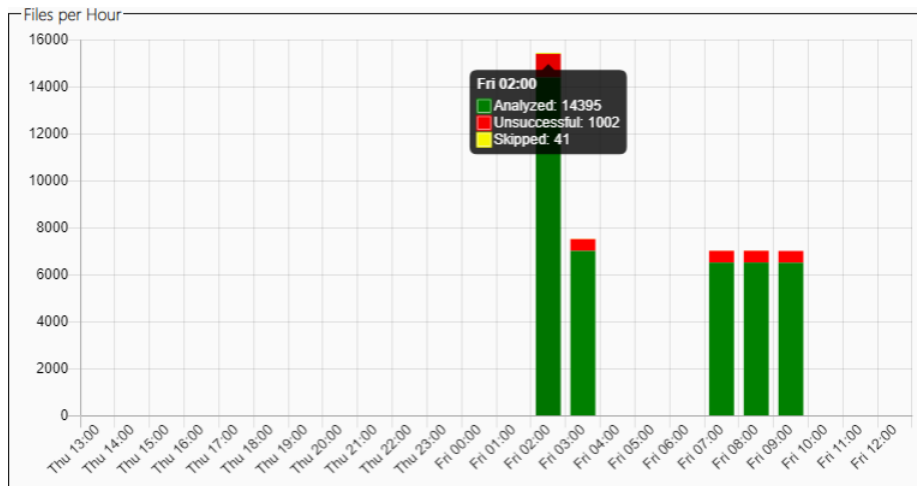


### Files per Hour

This chart displays the latest snapshot of the total number of files processed per hour within the period selected from the filter. A line chart is displayed if the period filter is either **7 Days** or **3 Days**. A stacked bar chart is displayed if the period filter is either **24 Hrs** or **12 Hrs**.

The line or bar chart has three data points. When you hover your mouse over a line or bar, the following data points are displayed:

- a. **Analyzed** - indicates the number of files that were successfully analyzed.
- b. **Unsuccessful** - indicates the number of files that could not be analyzed.
- c. **Skipped** - the number of files that could not be submitted and were not processed any further. There could be several reasons why files are skipped. For example, files may be skipped because the file type is not supported, there is a problem reading the contents of the file, there is low disk space on the server, or the file upload service was unavailable.

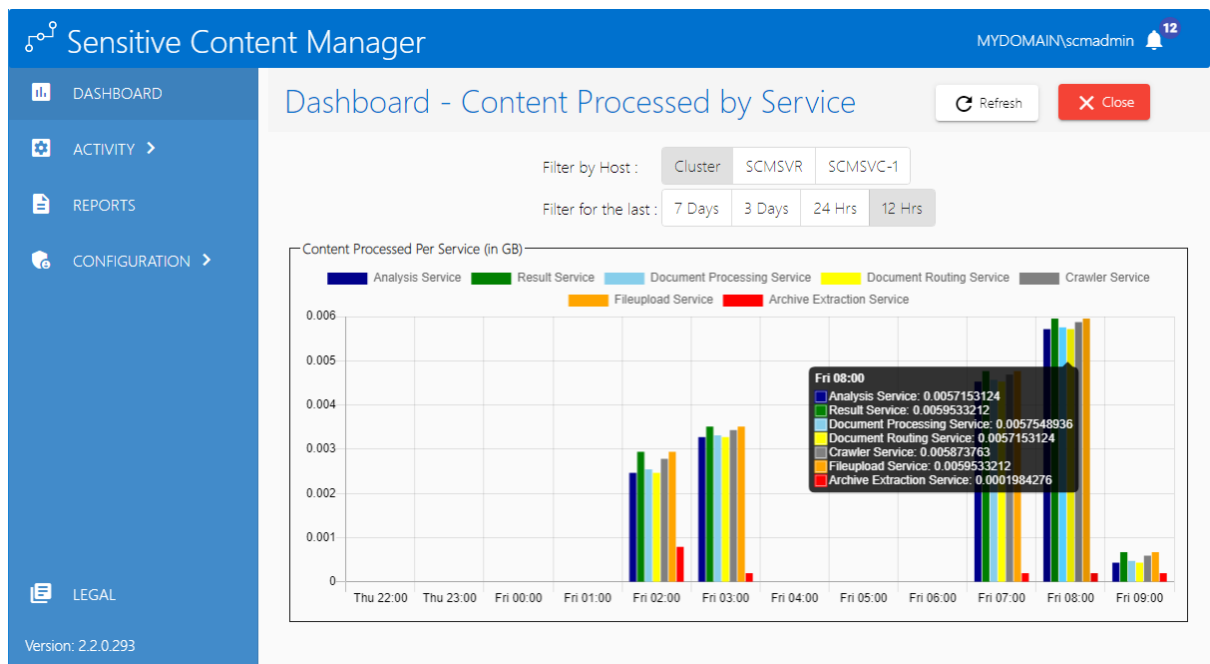


## Content Processed by Service

To access this chart, click the **Content (GB) per Hour** chart in the Dashboard.

This chart displays the latest snapshot of the total size of the data (in GB) processed by each service per hour within the period selected from the filter. A line chart is displayed if the period filter is either **7 Days** or **3 Days**. A grouped bar chart is displayed if the period filter is either **24 Hrs** or **12 Hrs**.

If you have a distributed deployment, an additional filter is available that lets you select the server node to inspect the performance of services installed on that node.



### Chart operations:

1. Hover your mouse over a line or bar to view the total content (in GB) processed by each service. You can inspect the performance for all the services or you can choose specific services that you want to inspect.
2. Click any service or its color code that you want to exclude from the chart. The service name that is excluded will be indicated with a *strikethrough*.

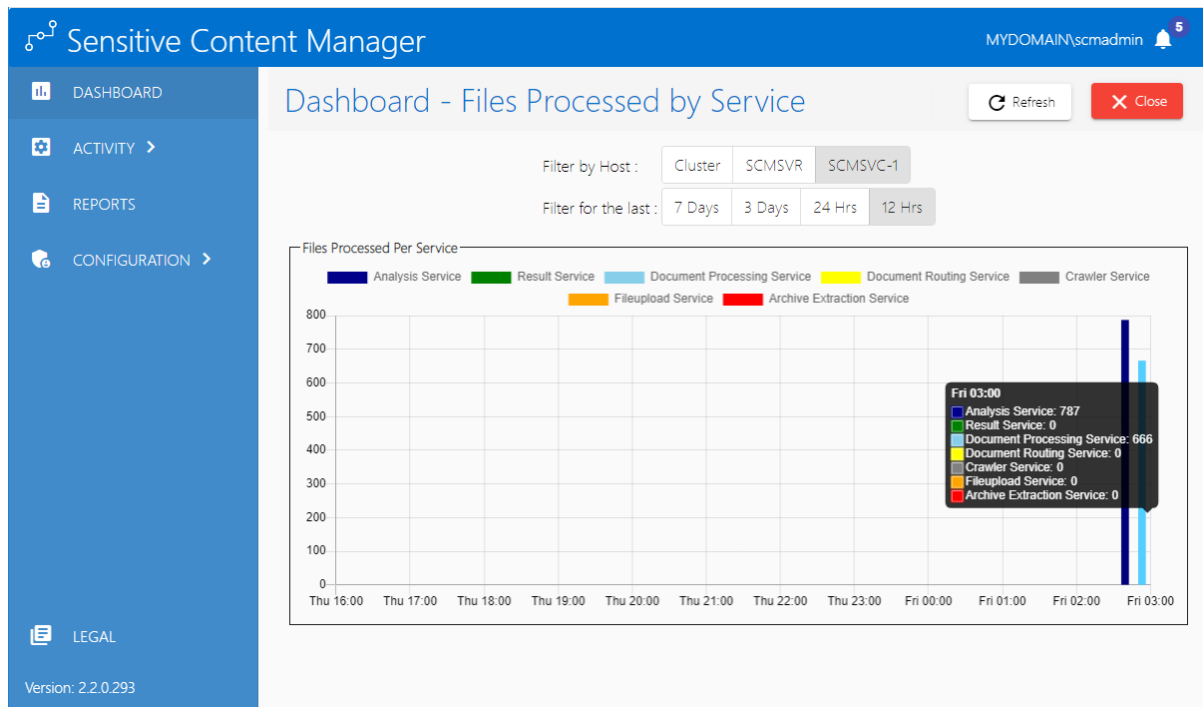
3. Click the service (or its color code) that was previously excluded and you want to include in the chart. The *strikethrough* disappears from service names that are included in the chart.
4. Click **Refresh** to get a fresh snapshot of the chart data.
5. Click **Close** to return to the Dashboard.

### Files Processed by Service

To access this chart, click the **Files per Hour** chart in the Dashboard.

This is a detailed chart that displays the latest snapshot of the total number of files processed by each service per hour within the period selected from the filter. A line chart is displayed if the period filter is either **7 Days** or **3 Days**. A grouped bar chart is displayed if the period filter is either **24 Hrs** or **12 Hrs**.

If you have a distributed deployment, the **Filter by Host** is an additional filter that is available that lets you select the server node to inspect the performance of the services installed on that node. The default is **Cluster** which includes services from the primary SCM server as well as the server nodes.



### Chart operations:

1. Hover your mouse over a line or bar to view the number of files processed by each service. You can inspect the performance for all the services or you can choose specific services that you want to inspect.
2. Click any service (or its color code) that you want to exclude from the chart. The service name that is excluded will be indicated with a *strikethrough*.

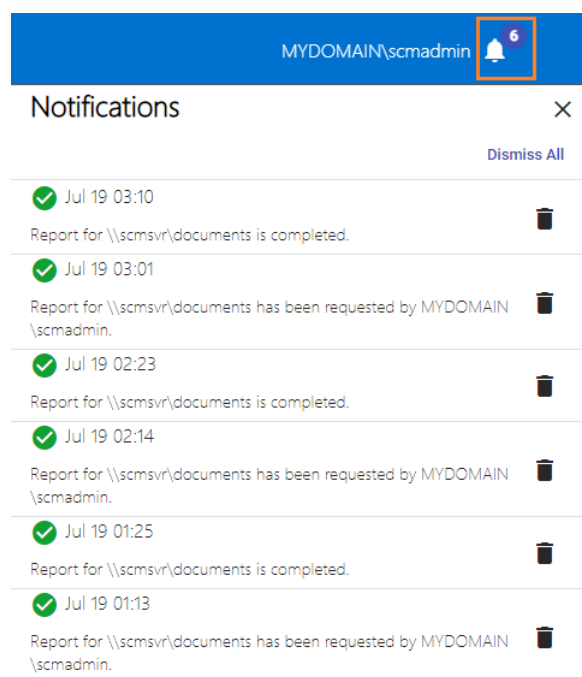

# Notifications

Notifications are messages about the progress of scan reports.

To view the notifications click the notification icon at the top right corner of the SCM Administration Center. The notification icon all indicates the number of messages in the notification panel.



The *Notifications* panel displays the date and time the message was posted and the message. The You can perform the following actions in the *Notifications* panel:

1. Click **X** to close the panel.
2. Click **Dismiss All** to clear all the messages from the panel.
3. Click  to delete a single message.

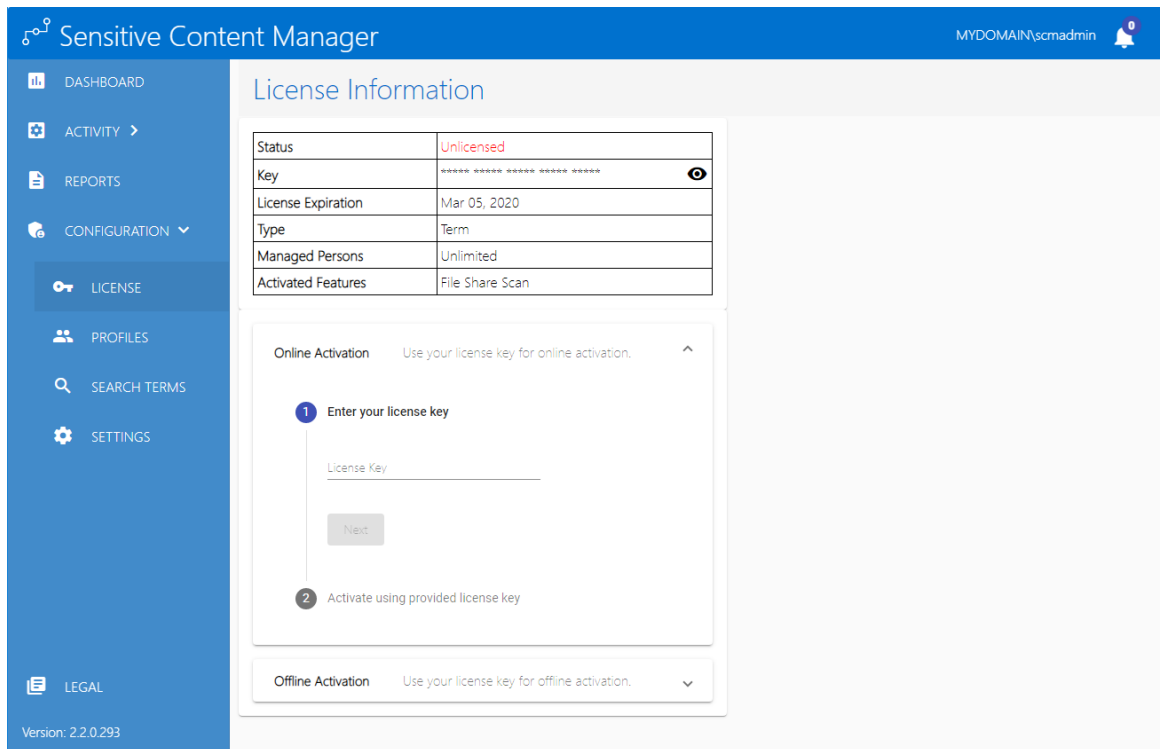

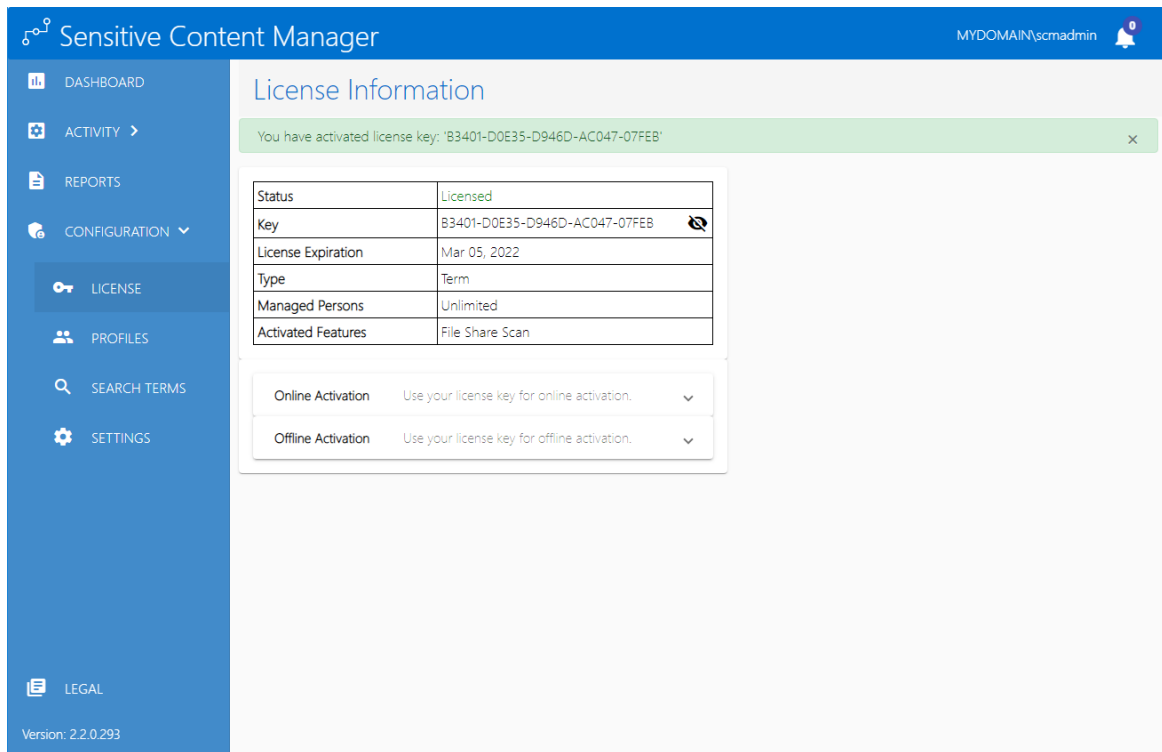
## About the trial License

- When you register and download a trial version of the Metalogix SCM, the trial license key is specified in the email that is sent to you.
- When you activate the trial license, the *License Information* page opens.
- The **Type** field indicates *Trial*.
- It is valid for 30 days (date of license issue + 29 days) and you can try all the features that are available.
- The Analysis service and the File Upload service will stop functioning after 30 days.

## Steps to activate your license

1. Log in to the SCM Administration Center and click **License** from the navigation panel. The *License Information* page opens.
2. Enter you license key in the **License Key** field.
3. Click **Next**. The **Activate using provided license key** step is activated.
4. Click **Activate Online**. If the **License Key** is valid, The **Activation Complete** step is activated.





5. Click **Finish**. Refresh the page to update the license status and access the licensed features.

## Steps to activate your license offline

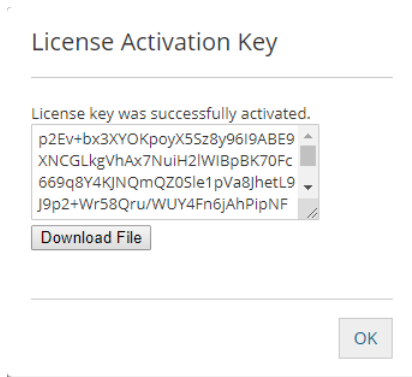

The *Services Health* page presents a snapshot of the overall health of the system. It is frequently updated with the latest status from the SCM repository. This section displays the following information about the SCM services.

- Status** - indicates the health of the service. The two possible values are: **Up** and **Down**. Click the status link to view details about the service. For the *Analysis Service* and the *Document Processing Service*, the details also include the set of documents that are currently being processed.
- Service Name** - name of the service.
- Server** - name of the server where the service is installed.
- Last Contacted** - most recent date and time when the service published health information.
- Version** - the version of the service that is installed on the server.

In a distributed environment, additional servers that are deployed to host one or more services will also be displayed along with the service and other health information.



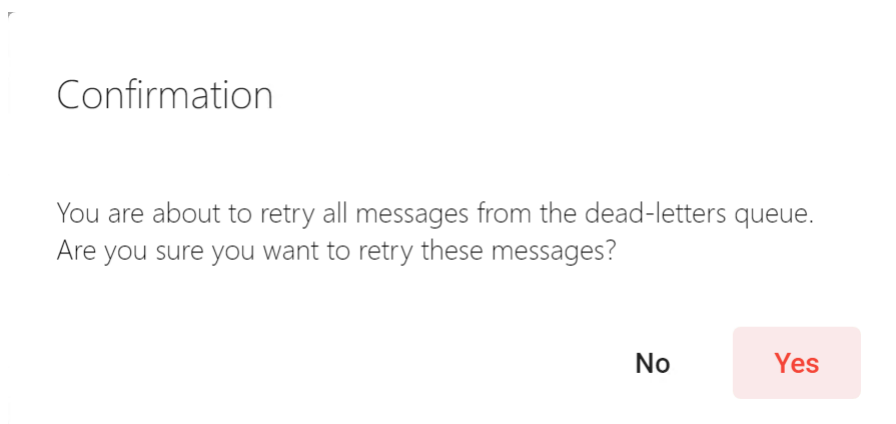

The **Logs** list presents the information about the system and services as described below. You can sort and filter each column in the **Logs** list. The filter recognizes a keyword and does not support logical operators or wildcard characters. The columns in the **Logs** list are described below:

- Date** - local date and time when the log entry was written.
- Component** - name of the SCM service.
- Server Host** - name of the server where the SCM service is hosted.

## Managing items per page

To customize the number of items displayed on the page, click the **Items per page** drop down below the list and choose the number of items you wish to display. If there are more report journal items than the list can display, you can use the navigation links below the list to browse through more search terms.




**NOTE:** A maximum of 10,000 journal items can be viewed across all pages. If the number of files in the scan exceed 10,000 you can download the full or filtered list as a CSV file and use Excel or a similar desktop tool to view the results.

## Filtering scan results

Enter a word in the **Filter** field above the list in either the *Report Journal - All*, *Report Journal - Warnings*, *Report Journal - Unsuccessful*, or *Report Journal - Skipped* page to filter the set of report journal items by the word entered.

## Downloading scan results

1. Click **Download** from the any **Report Journals** page The *Download Journals* dialog opens.

## Profiles

A profile is a named collection of content search and analysis specifications. Each profile is made up of search terms and regular expressions that can detect sensitive content in English, German, Spanish, Italian, French and Portuguese. SCM ships with 4 default profiles:

- General Data Protection Regulation (GDPR)
- Personally Identifiable Information (PII)
- Protected Health Information (PHI)
- Payment Card Information (PCI)

The file search and analysis criteria requirements for your organization may differ from the system profiles that are available. For example, you may want to create a custom profile to group a different subset of the predefined search terms, add custom search terms for sensitive data types, or analyze data that falls outside common definitions of PII, PHI or financial data. Custom profiles created with the SCM profile wizard can be made available to both SCM and ControlPoint users.

With the standard or custom profiles, SCM allows you to analyze the following file types -

- Compressed files (ZIP, 7z, TAR, RAR etc.)
- Comma Separated Values (CSV)
- Log Files
- Microsoft Excel
- Microsoft Excel 2007
- Microsoft Outlook Express Mail Message
- Microsoft Outlook Message
- Microsoft PowerPoint Presentation

- Microsoft PowerPoint Presentation 2007
- Microsoft PowerPoint Show
- Microsoft PowerPoint Show 2007
- Microsoft Word Document
- Microsoft Word Document 2007
- Open Document Text
- Portable Document Format (PDF)
- PowerShell
- Rich Text Format (RTF)
- Text Document

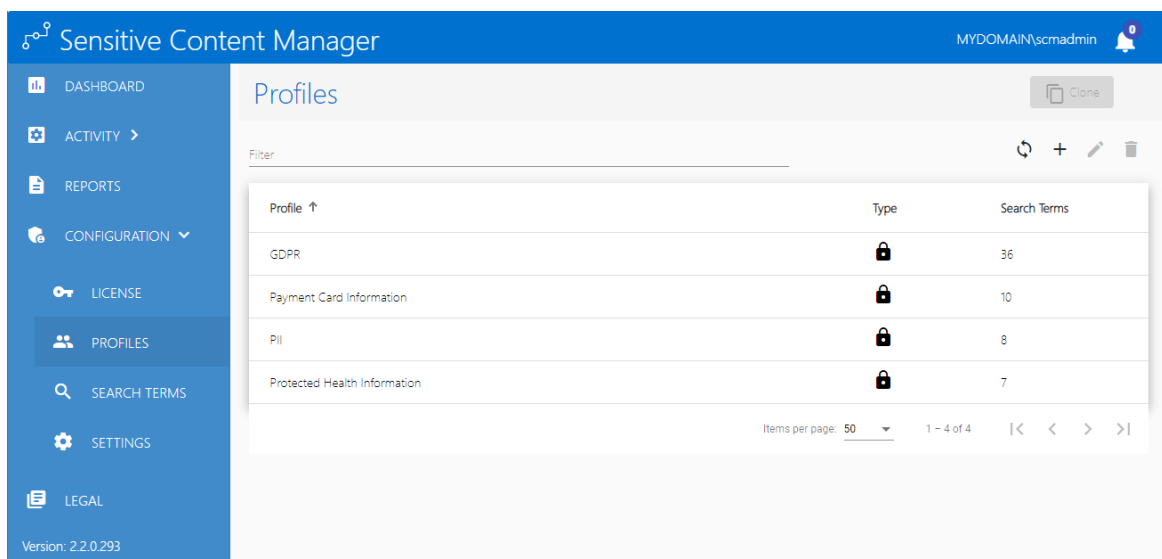

## Steps to view profiles

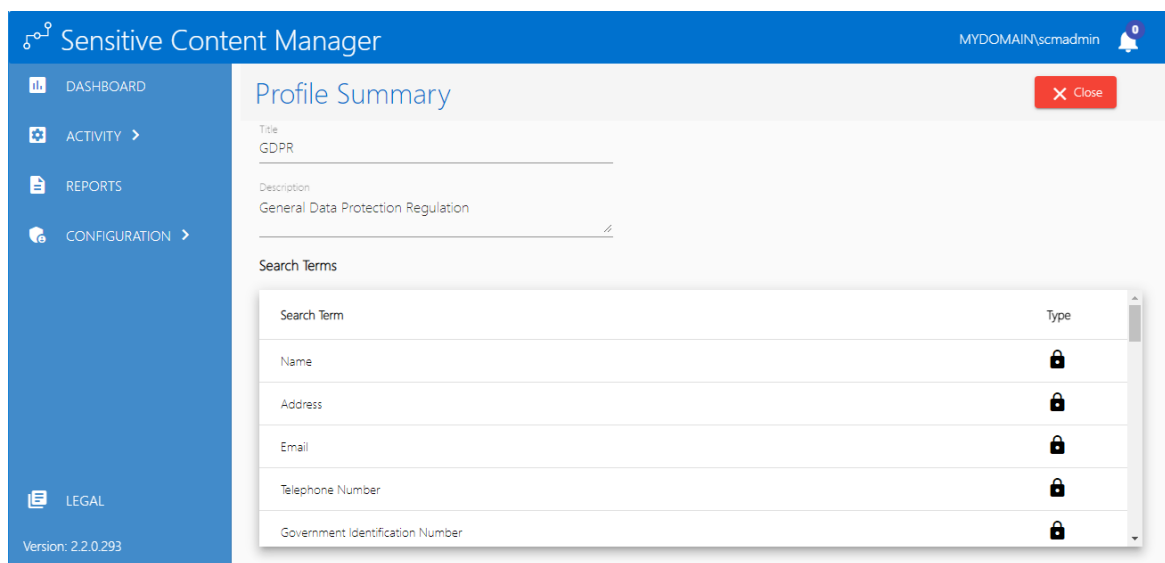
1. From the navigation panel, click **CONFIGURATION** and then click **PROFILES**. The *Profiles* page opens.



The columns in the list are as follows:


- a. **Profile** - a named set of search terms

- b. **Type** - indicates whether the profile is a system profile  or a custom profile . System profiles cannot be edited but can be cloned to create custom profiles.
  - c. **Search Term** - indicates the number of search terms in the profile.
- To customize the number of items displayed on the page, click the **Items per page** drop down below the list and choose the number of items you wish to display. If there are more profiles than the list can display, you can use the navigation links below the list to browse through more profiles.
  - Enter a keyword in the **Filter** field above the list to filter the set of profiles by the keyword entered.
  - Click **Refresh** to retrieve and display a fresh set of profiles from the SCM repository.
- Click a profile link to view the profile details. The *Profile - Summary* page opens.




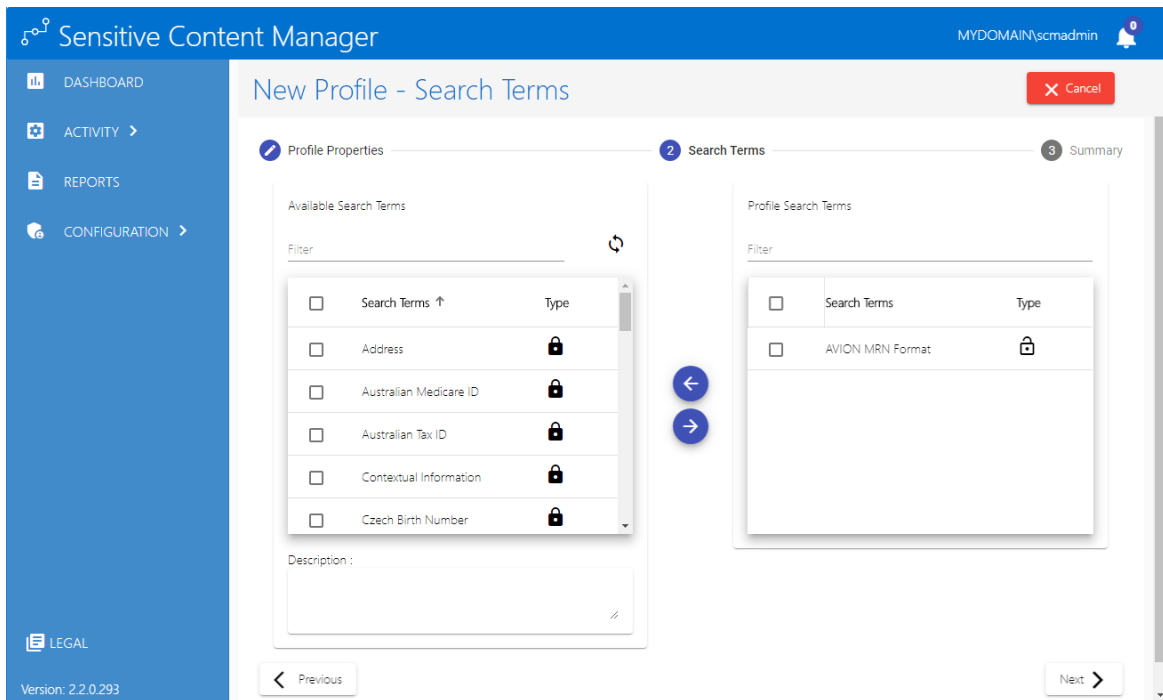
- Click **Close** to return to the *Profiles* page.

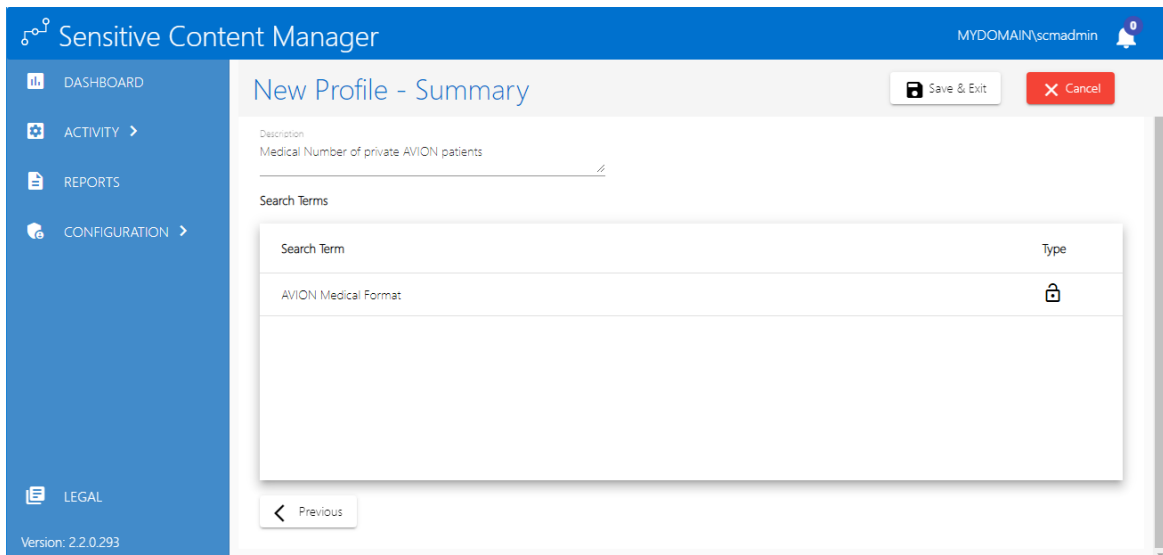

  4. From the *Available Search Terms* list, select one or more check boxes to choose the search terms for the profile. You can filter the list by entering a key word in the **Filter** field of the *Available Search Terms* list. 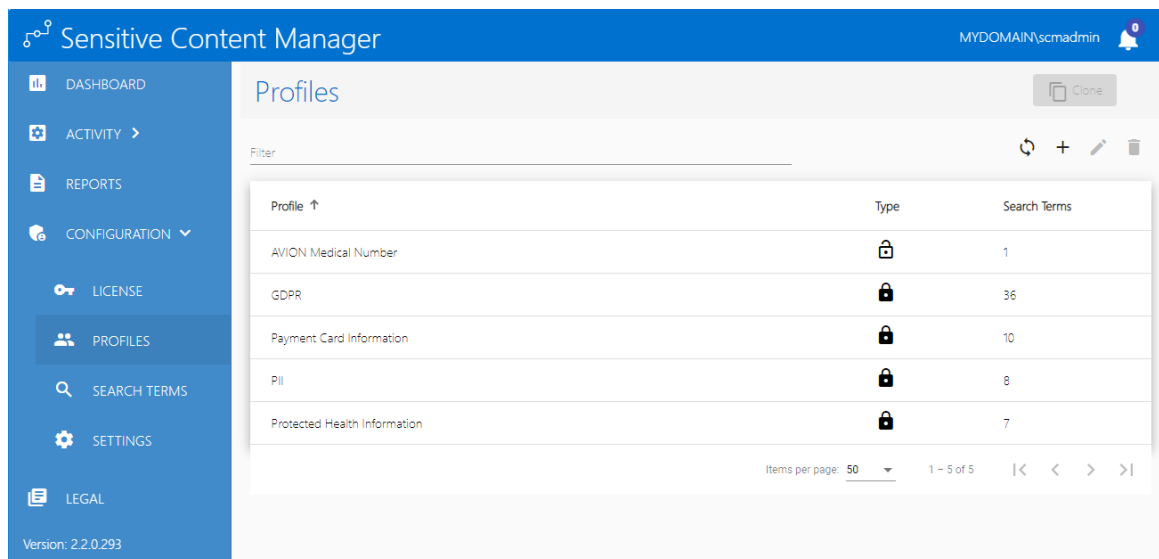

8. To remove a search term from the *Profile Search Terms* list, select one or more check boxes in the *Profile Search Terms* list. You can filter the list by entering a key word in the **Filter** field of the *Profile Search Terms* list. If the key word exists in the name or the description of the search term, you will see the result set in the list.
9. Click  to move the selected search terms back to the *Available Search Terms* list.

**CAUTION:** If a profile is modified while files are being scanned with the same profile, the scan will continue. All remaining files that are scanned will use the revised profile.




## Steps to delete an existing profile

1. From the navigation panel on the left, click **CONFIGURATION** and then click **PROFILES**. The *Profiles* page opens.
2. Select a custom profile that you want to delete. You cannot delete a system profile.
3. Click **Delete**  and then click **Yes** in the confirmation dialog to confirm the deletion.

**!** **CAUTION:** If a profile is modified while files are being scanned with the same profile, the scan will continue. All remaining files that are scanned after the profile is deleted, will produce a failed result and include no term matches.

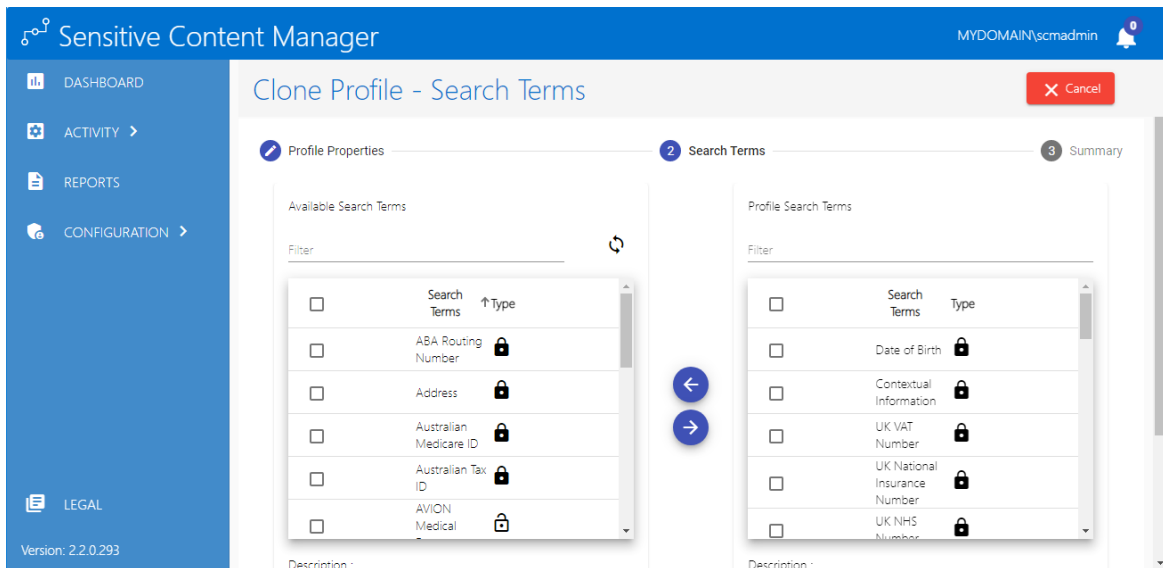
## Steps to customize a system profile



1. From the navigation panel on the left, click **CONFIGURATION** and then click **PROFILES**. The *Profiles* page opens.
2. Select a system profile.
3. Click **Clone** to open the new profile wizard. The *Clone Profile - Properties* page opens.

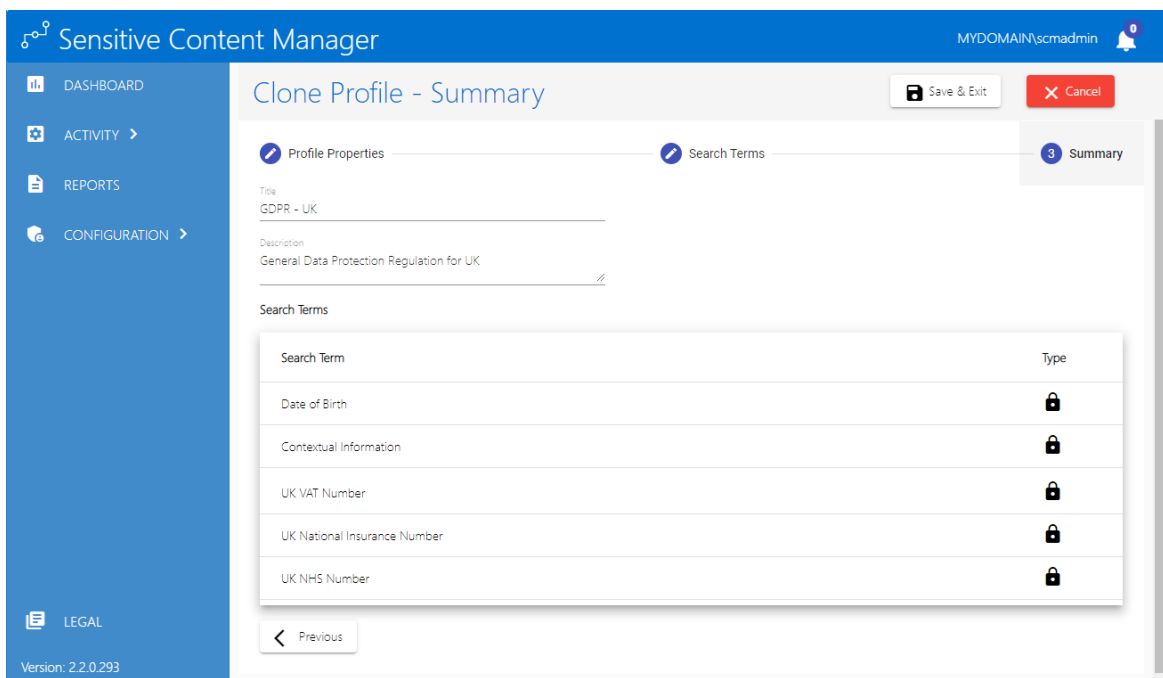


Change the property values as described below:

- a. **Profile Name** - enter a unique profile name. The profile name cannot exceed 100 characters.
  - b. **Profile Description** - change the description of the profile. The description text should not exceed 256 characters.
4. Click **Next**. The *Clone Profile - Search Terms* page opens in edit mode with the same search terms as in the original profile.



5. From the *Available Search Terms* list, select one or more check boxes to choose additional search terms for the custom profile. You can filter the list by entering a key word in the **Filter** field of the *Available Search Terms* list. If the key word exists in the name or the description of the search term, you will see the result set in the list.
6. Click  to move the selected search terms to the *Profile Search Terms* list.
7. To remove a search term from the *Profile Search Terms* list, select one or more check boxes in the *Profile Search Terms* list. You can filter the list by entering a key word in the **Filter** field of the *Profile Search Terms* list. If the key word exists in the name or the description of the search term, you will see the result set in the list.
8. Click  to move the selected search terms back to the *Available Search Terms* list.
9. When you complete the selection of search terms as displayed in the *Profile Search Terms* list, click **Next**. The *Clone Profile - Summary* page opens.

## Search Terms

A search term is a named entity for a regular expression that is used in a profile to scan files for matching patterns.



1. From the navigation panel on the left, click **CONFIGURATION** and then click **SEARCH TERMS**. The *Search Terms* page opens.

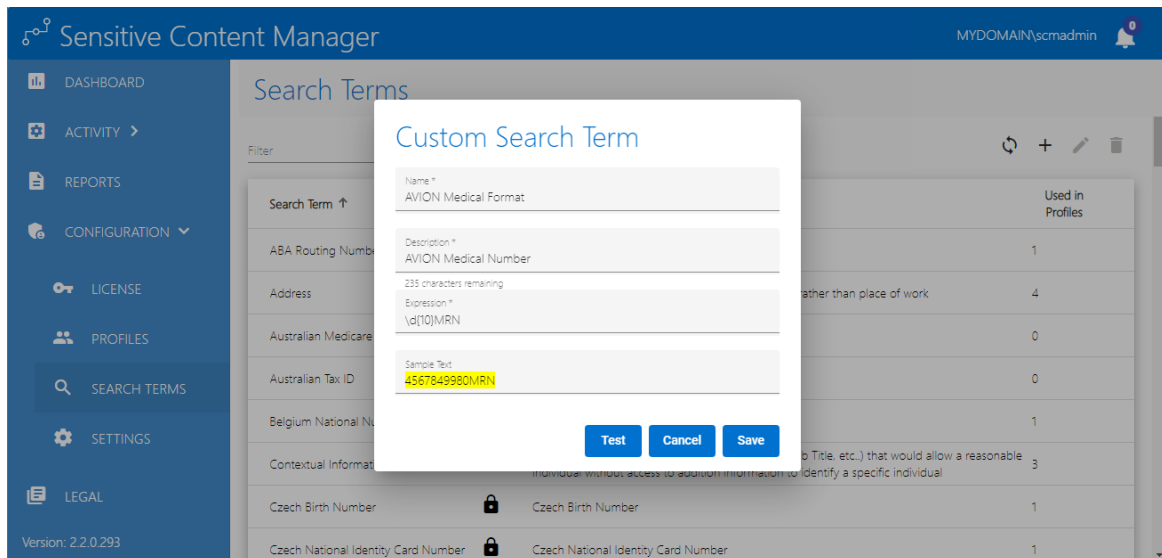

- b. **Type** - indicates whether the search term is a standard search term 🔒 or a custom search term 🔓. Standard search terms cannot be edited.
- c. **Description** - explanation of the search term.

- d. **Used in Profiles** - integer value that indicates the number of profiles that use the search term.
  - The list can be customized to display more or less items on the page. Click the **Items per page** drop down below the list and choose the number of items you wish to display. If there are more search terms than the list can display, you can use the navigation links below the list to browse through more search terms.
  - Enter a keyword in the **Filter** field above the list to filter the set of search terms by the keyword entered.
  - Click **Refresh** to retrieve and display a fresh set of search terms from the SCM repository.
2. Click a search term to view its details.

## Steps to create a new search term


1. From the navigation panel on the left, click **CONFIGURATION** and then click **SEARCH TERMS**. The *Search Terms* page opens.
2. Click **Create**  to open the *Custom Search Term* window.  
Specify the property values as described below:
  - a. **Name** - enter a unique search term name. The profile name cannot exceed 100 characters.
  - b. **Description** - enter a description of the search term. The description text should not exceed 256 characters.
  - c. **Expression** - enter a regular expression to match a text pattern in a file.
  - d. **Sample Text** - enter any text that contains the pattern you want to match.
3. Click **Test**. If a pattern match occurs in the **Sample Text** field, the matching pattern will be highlighted.

**i** | **NOTE:** If the test expression includes inline modifiers like `(?i)` for case insensitivity, you may get false negative results. For these expressions please consider testing them at <http://regexstorm.net/tester>




4. Click **Save** to save the new search term. Verify that it is listed in the *Search Terms* list. You can click **Cancel** to exit the window.

## Steps to edit an existing search term

1. From the navigation panel on the left, click **CONFIGURATION** and then click **SEARCH TERMS**. The *Search Terms* list page opens.
2. Select a custom search term that you want to edit. You cannot edit a standard search term.
3. Click **Edit**  to open the *Custom Search Term* window.
4. Review and revise the properties as needed.
5. If you revise the regular expression it is recommended that you enter some appropriate text in the **Sample Text** field and click **Test** to verify the regular expression.
6. Click **Save** to save the new search term. You can click **Cancel** to exit the window.

**CAUTION:** If a search term is modified while files are being scanned with a profile that contains the same search term, the scan will continue and all remaining files that are scanned will use the revised search term.

## Steps to delete an existing search term

1. From the navigation panel on the left, click **CONFIGURATION** and then click **SEARCH TERMS**. The *Search Terms* list page opens.
2. Select a custom search term that you want to delete. You cannot delete a standard search term.
3. Click **Delete**  and then click **Yes** in the confirmation dialog to confirm the deletion.

**CAUTION:** If a search term is deleted while files are being scanned with a profile that contains the same search term, the scan will continue but none of the remaining files will be checked for patterns that match the deleted search term.

# Settings

Log files that are generated by the application have different levels of severity. The *Settings* page lets you specify the logging level of system messages.

## Steps to set the logging level

1. From the navigation panel on the left, click **CONFIGURATION** and then click **SETTINGS**. The *Settings* page opens.
2. From the **Logging Level** drop down, select one of the following log levels listed below by descending severity:
  - **Verbose** - Logs that contain the most detailed messages. These messages may contain sensitive application data. These messages are deactivated by default and should never be activated in a production environment.
  - **Debug** - Logs that are used for interactive investigation during development. These logs should primarily contain information useful for debugging and have no long-term value.
  - **Information** - Logs that track the general flow of the application. These logs should have long-term value.
  - **Warning** - Logs that highlight an abnormal or unexpected event in the application flow, but do not otherwise cause the application processes to stop.
  - **Error** - Logs that highlight when the application processes stop due to a failure. These should indicate a failure in the current activity, not an application-wide failure.
  - **Fatal** - Logs that describe an unrecoverable application or system crash, or a catastrophic failure that requires immediate attention.



**NOTE:** The level you choose will also include all levels below it. For example, if you choose **Verbose**, all the other log levels will also be tracked. If you choose **Warning**, then the only the log levels **Warning**, **Error** and **Fatal** will be tracked.

When a log level is changed, you must allow between two to five minutes for the new log level to be distributed to all the services. If scans are in progress, the new log level will be applied only when the services are able to register the new log level.

# Support Tools

Support Tools are provided with the installation media.

## To access the support tools:

1. Download the installation ZIP file and extract all the files on the machine on which you are planning to install the SCM components.
2. Open the Support Tools folder.

## About the Support Tools

A summary of each tool is provided below. Each folder contains a *ReadMe.txt* file that provides detailed information about the tool.

### Archive-Logs

A PowerShell script to create a copy of all the log files for SCM into a single .zip file.

### Forensics

PowerShell scripts to visualize the timeline of verbose SCM log entries for better troubleshooting.

### Mx Connectivity Tests

PowerShell script and aspx page to troubleshoot the connectivity to SQL server.

### PemTool

Tool to generate the .pem files needed for RabbitMQ

### Phoenix

Command-line program that helps you to process RabbitMQ dead-letter messages. Helps you to capture content to SQL, resubmit, or move messages to a new Queue.

### Rabbit Migration

PowerShell script to migrate the RabbitMQ base folder from one location to another. You would typically move it from the %APPDATA% folder to a shared location like the %PROGRAMDATA% folder.

### Rabbit Snapshot

PowerShell script to import and export a RabbitMQ configuration from one machine to another.

### SCM diagnostics

Collects information about the environment and logs for troubleshooting like Event logs, IIS logs, list of installed programs, RabbitMQ configuration, SCM Logs and application .json files.

### **SCM Report Conversion**

PowerShell script to convert the exported scan report to an Essentials format for integration. In SCM 2.1.1 and later versions, report conversion is possible directly from the Administration Center.

### **SCM Scans**

PowerShell scripts to submit a file share scan and download the resulting CSV report. The script requires a *Profile Id*. To get the *Profile Id* of a standard or custom profile:

1. From the navigation panel in the Administration Center, click CONFIGURATION and then click PROFILES. The *Profiles* page opens.
2. Click a profile link. The *Profile - Summary* page opens.
3. Get the *Profile Id* from the URL. For example, for the Personally Identifiable Information (PII) profile, the *Profile Id* is 1 (<https://<domain:port>/#/profile/view/1>)

### **ScpTool**


An executable to test access to the Service Connection Point (SCP) data in Active Directory.

## Steps to get the URL for the SCM Administration Center

1. Log in to the SCM Server and open the **Command** console.
2. Run the command `ipconfig /all`

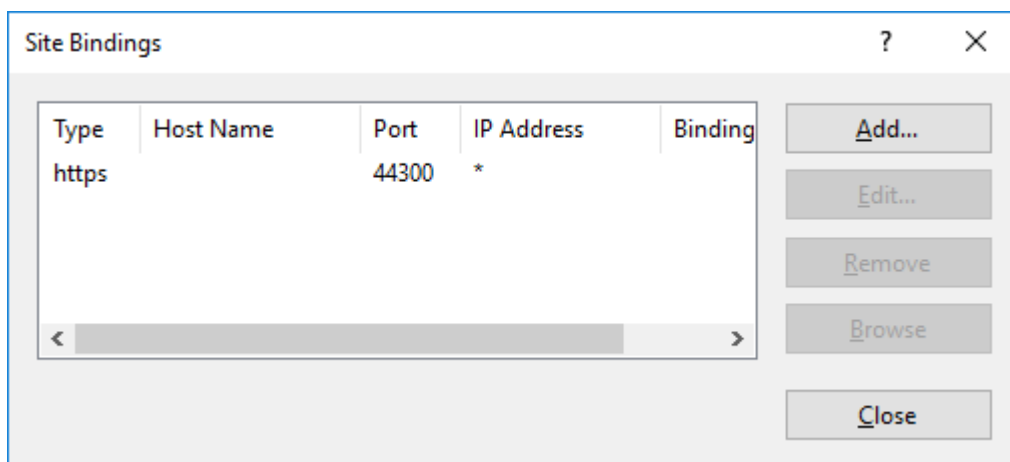

3. Get the FQDN of the server from the windows command prompt. This gives you **[Hostname]**. **[Primary Dns Suffix]**. For example, `SCMDemo.mydomain.com`
4. Open **IIS Manager** to get the protocol and port.
  - a. Expand the server node.
  - b. Expand the **Sites** node and select **SCMAdminPortal**
  - c. From the **Actions** pane click **Bindings**. This will give you [protocol] and [port]. For example, the protocol is **https** and the port binding is **44300**.



Gather all this information together to construct the URL **[protocol]:// [Hostname].[Primary Dns Suffix]:[Port]**. For example, `https://SCMDemo.mydomain.com:44300`
